Executive Order 12-01 for Regional Emergencies
Conditional and Temporary Relief from
Motor Carrier Rules and Regulations

WHEREAS, K.S.A. 48-925(b) provides that the Governor may issue orders and proclamations which shall have the force and effect of law under subsection (b) of K.S.A. 48-924; and

WHEREAS, Drought conditions exist which require the operation of motor carriers and drivers of commercial motor vehicles for the purposes of providing direct assistance for relief efforts in the State of Kansas; and

WHEREAS, Drought conditions also exist in the States of Texas and Oklahoma, who have issued regional emergency declarations to aid in their relief efforts; and

WHEREAS, This disaster has caused or threatens to cause an emergency as defined in 49 C.F.R. 390.5, as adopted by K.A.R. 82-4-3f and which has or threatens to interrupt the delivery of essential services or essential supplies or otherwise immediately threatens physical harm or injury to persons, the public welfare and/or substantial damage to property.

NOW, THEREFORE, pursuant to the authority vested in me as Governor of the State of Kansas, I hereby acknowledge a state of emergency exists in Kansas and declare it necessary to assist and expedite all disaster recovery efforts. I also acknowledge the regional emergencies declared by the States of Texas and Oklahoma. In order to accommodate these needs and to provide assistance to the citizens of Kansas, Oklahoma and Texas in this extreme situation, I hereby order the following:

1. This declaration only applies to motor carriers hauling hay to livestock in any drought stricken areas; and
2. In accordance with Title 49 C.F.R. § 390.23, the requirements contained in the Federal Motor Carrier Safety Regulations, Title 49 C.F.R. Parts 390-399 are hereby suspended for motor carriers providing relief to the State of Kansas through the duration of the motor carrier's assistance in the disaster relief effort not to exceed a period of thirty (30) days from the date of the initial declaration unless the order is rescinded or expanded by executive order or concurrent resolution of the legislature; and
3. All other applicable state and federal laws/regulations shall apply including but not limited to: Title 49 C.F.R. Part 382, Controlled Substances and Alcohol Use and Testing; the Kansas Motor Vehicle Driver's License Act, K.S.A. 8-234 *et seq.* and Title 49 C.F.R. Part 383 Commercial Driver's License Standards as adopted by the Kansas Uniform Commercial Drivers' License Act, K.S.A. 8-2,125 *et seq.*, the federal Minimum Levels of Financial Responsibility (insurance requirements) Title 49 C.F.R. Part 387 as adopted by K.A.R. 82-4-3n and state insurance requirements as provided in K.A.R. 82-4-23; and, adherence to the regulations governing the Transportation of Hazardous Materials as provided in Title 49 C.F.R. 397 and adopted by K.A.R. 82-4-3k and Parts: 107, 171-173, 177, 178 and 180 as adopted by K.A.R. 82-4-20; and
4. For motor carriers providing relief to Kansas, Oklahoma and Texas, the registration and fuel tax permits as enforced by the Kansas Department of Revenue are temporarily suspended; and
5. For motor carriers providing relief to Kansas, Oklahoma and Texas the licensing, certification and permitting rules and regulations as required by the Kansas Corporation Commission are temporarily suspended; and
6. Participating motor carriers who are providing relief to Kansas, Oklahoma and Texas are not required to obtain an over-dimensional permit from the Kansas Department of Transportation; and
7. Participating motor carriers are not permitted to travel during nighttime; and
8. Participating motor carriers are not allowed to drive during inclement weather conditions. *Oversize or overweight loads shall not be transported when visibility is less than one-half mile, or when conditions of moderate to heavy rain, sleet, snow, fog, or smoke exist, or when highway surfaces are slippery due to ice, packed snow, or rain.*
9. Participating motor carriers are limited to a load that does not exceed 12 feet in width and does not exceed a height of 14 feet, six inches.

This document shall be filed with the Secretary of State as Executive Order No. 12-01 and shall become effective immediately.

This sworn statement shall be in the form of an affidavit executed and sworn to by the bidder before a person who is authorized by the laws of the state to administer oaths. Notice of Hearing on Proposed
Administrative Regulations

A public hearing will be conducted at 9:30 a.m. Friday, April 27, in Room 106 of the Landon State Office Building, 900 S.W. Jackson, Topeka, to consider the adoption of proposed changes in existing rules and regulations of the Board of Accountancy.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments prior to the hearing to the executive director of the Board of Accountancy, Suite 556, Landon State Office Building, 900 S.W. Jackson, Topeka, 66612. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Judy Jenks at (785) 296-8148 or by e-mail at info@ksboa.ks.gov. Handicapped parking is located at the south end of the Landon Building, and the north entrance to the building is accessible to individuals with disabilities.

These regulations are proposed for adoption on a permanent basis. A summary of proposed regulations and their economic impact follows:

K.A.R. 74-1-4. Transfer of examination credit. Amendments to this regulation clarify the requirements for transfer of examination grades.

K.A.R. 74-2-7. Concentration in accounting. Amendments to this regulation broaden the type of alternative credits allowed and disallow credit for repeat courses.

K.A.R. 74-4-3a. Permit renewal. Amendments to this regulation specify the reasons for returning a renewal application.

K.A.R. 74-4-7. Continuing professional education requirements. Amendments to this regulation clarify that a person may not renew their permit until they have met the continuing professional education requirement and have proof in hand of the certificates of attendance/completion, in addition to requiring reinstatement applicants to obtain two hours of ethics for reinstatement of their permits.

K.A.R. 74-4-8. Continuing professional education programs; requirements. Amendments to this regulation rearrange existing language outlining the types of courses allowed for continuing professional education.

Synopsis: Under the *Executive Aircraft* test, the “transportation utility fee” (TUF) is a tax because it is a forced contribution on the owners of developed real property in the city of Mission levied for the purpose of raising revenue for the maintenance of governmental services offered to the general public, *i.e.*, maintenance of streets. The TUF is not an ad valorem tax because it is imposed by calculating the estimated number of vehicle trips originating from a property using a trip generation model rather than the value of real property. As such, TUF is an excise tax that the city of Mission is specifically, clearly, and uniformly prohibited from levying or imposing under K.S.A. 2011 Supp. 12-194. Cited herein: Kan. The Kansas Department of Health and Environment, Division of Health, Bureau of Public Health Informatics, will conduct a public hearing at 10 a.m. Monday, April 16, in Room 530, Curtis State Office Building, 1000 S.W. Jackson, Topeka, to consider the adoption of new regulations K.A.R. 28-56-1, 28-56-2, 28-56-3, 28-56-4, 28-56-5, 28-56-6, 28-56-7, 28-56-8, 28-56-9 and 28-56-10, pertaining to the reporting of abortions.

A summary of the proposed regulations and the estimated economic impact follows:

Summary of Regulations:

28-56-1. Definitions. Defines terms used in these regulations.

28-56-2. General requirements for abortion reports. Specifies the information to be reported on every abortion report submitted to the department; requires reports within 15 days of abortion; requires confidential code number; requires provider to have copy of reporting requirements; requires electronic reporting for certain reports.

28-56-3. Reporting requirements for abortions performed at clinical estimate of gestation of at least 22 weeks. Establishes additional reporting requirements for abortions performed at 22 weeks or greater gestation; requires specific responses to clinical issues; requires medical codes be submitted with the information.

28-56-4. Reporting requirements for partial birth abortions. Establishes additional reporting requirements for partial birth abortions; requires specific responses to clinical issues; requires medical codes be submitted with the information.

28-56-5. Requirements for reporting failed abortions. Requires filing of a failed abortion report if abortion attempt results in a live birth; requires submission of live birth certificate as well.

28-56-6. Reporting requirements for abortions performed on minors in the case of a medical emergency. Requires physicians to report additional information about abortions performed on minors in case of medical emergencies.

28-56-7. Physician's report of number of certifications received. Requires physicians to file a monthly report on number of informed consent certifications received prior to performing an abortion; specifies information to be provided.

28-56-8. Late term affidavits. Requires physicians performing and referring late-term abortions to sign separate affidavits attesting the physicians are not legally or financially affiliated.

28-56-9. Correction in an abortion report. Establishes procedures and timeframe for correcting abortion reports and reports on the number of informed consent certifications received by physicians.

28-56-10. Medical information retained on each abortion performed. Establishes the medical information that

must be retained on each abortion performed by a provider.

Economic Impact:

Cost to individuals: These proposed regulations are consistent with current abortion records reporting requirements and should not impose any additional or unusual cost on regulated providers or clients. There are no fees assessed to the regulated community. Some additional time may be spent by providers to comply with new record-keeping and reporting requirements. However, although difficult to estimate, that time is likely to be modest.

Cost to the agency: Revisions to forms and abortion reporting software and staff time for training providers will be required. Costs are estimated to be \$34,000 with the bulk of the money expended for the vendor maintaining the vital statistics information system to modify the abortion reporting system. It is presumed these costs will be absorbed in the current budget. Processing reports submitted to the agency will be accomplished by existing staff.

Costs to other governmental agencies or units: There are no known costs to other agencies.

The time period between publication of this notice and the scheduled hearing serves as the required public comment period of at least 60 days for the purpose of receiving written public comments on the proposed new regulations. Article 4.—ACCIDENT AND HEALTH INSURANCE

40-4-42c. Standard external review procedures. (a) At the time a request for external review is accepted pursuant to K.A.R. 40-4-42b, an external review organization that has been approved pursuant to K.S.A. 40-22a15, and amendments thereto, shall be assigned by the commissioner to conduct the external review.

(b) In reaching a decision, the assigned external review organization shall not be bound by any decisions or conclusions reached during the insurer's utilization review process as set forth in K.S.A. 40-22a13 through 40-22a16, and amendments thereto, or the insurer's internal grievance process.

(c) The notice provided in K.A.R. 40-4-42b shall notify both the insurer or its designee utilization review organization and the insured or the insured's authorized representative that any of these persons may, within seven business days after the receipt of the notice, provide the assigned external review organization with additional documents and information that the person wants the assigned external review organization to consider in making its decision. Within one business day of receipt of any additional documents or information from the insured or the insured's authorized representative, the assigned external review organization shall forward a copy of these documents or this information to the insurer or its designee utilization review organization.

(d) Failure by the insurer to provide the documents and information within the time specified in K.S.A. 40-22a14(g), and amendments thereto, shall not delay the conduct of the external review.

(e) The assigned external review organization shall review all of the information and documents received pursuant to subsection (c) and any other information submitted in writing by the insured or the insured's authorized representative pursuant to K.A.R. 40-4-42b.

(f)(1) Upon receipt of the information required to be forwarded pursuant to subsection (e), the insurer may reconsider its adverse decision that is the subject of the external review.

(2) Reconsideration by the insurer of its adverse decision as provided in paragraph (f)(1) shall not delay or terminate the external review.

(3) The external review may be terminated only if the insurer reconsiders its adverse decision and decides to provide coverage or payment for the health care service that is the subject of the adverse decision.

(4)(A) Immediately upon making the decision to reverse its adverse decision as provided in paragraph (f)(3), the insurer shall notify, in writing, the insured or the insured's authorized representative, the assigned external review organization, and the commissioner of the insurer's decision.

(B) The assigned external review organization shall terminate the external review upon receipt of the notice from the insurer sent pursuant to paragraph (f)(4)(A).

(g) In addition to the documents and information provided pursuant to subsection (c), the assigned external review organization, to the extent that the documents or information is available, shall consider the following in reaching a decision:

(1) The insured's pertinent medical records;

(2) the attending health care professional's recommendation;

(3) consulting reports from appropriate health care professionals and other documents submitted by the insurer, the insured, the insured's authorized representative, or the insured's treating provider;

(4) the terms of coverage under the insured's insurance plan with the insurer, to ensure that the external review organization's decision is not contrary to the terms of coverage under the insured's insurance plan with the insurer;

(5) the most appropriate practice guidelines, including generally accepted practice guidelines, evidence-based practice guidelines, or any other practice guidelines developed by the federal government and national or professional medical societies, boards, and associations; and

(6) any applicable clinical review criteria developed and used by the insurer or its designee utilization review organization.

(h) Within 30 business days after the date of receipt of the request for external review, the assigned external review organization shall provide written notice of its decision to uphold or reverse the adverse decision to the following:

(1) The insured or the insured's authorized representative;

(2) the insurer; and

(3) the commissioner.

(i) The external review organization shall include the following in the notice sent pursuant to subsection (h):

(1) A general description of the reason for the request for external review;

(2) the date the external review organization received the assignment from the commissioner to conduct the external review;

(3) the date the external review was conducted;

(4) the date of the external review organization's decision;

(5) the principal reason or reasons for the external review organization's decision;

(6) the rationale for the external review organization's decision; and

(7) references, as needed, to the evidence or documentation, including the practice guidelines that the external review organization considered in reaching its decision.
