**Notice of Hearing on Proposed  
Administrative Regulations**

A public hearing will be conducted by the Department of Revenue at 9 a.m. Tuesday, April 9, in the secretary's conference room, Room 230, Docking State Office Building, 915 S.W. Harrison, Topeka, to consider the adoption of alcoholic beverage control regulations. Copies of these proposed regulations may be found at [www.ksrevenue.org](http://www.ksrevenue.org).

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written comments from the public on the proposed regulations. All interested parties may submit written public comments on the proposed regulations prior to the hearing to Kathleen Smith, Tax Specialist, Office of Policy and Research, Room 230, Docking State Office Building, 915 S.W. Harrison, Topeka, 66612, or through email at [kathleen.smith@kdor.ks.gov](mailto:kathleen.smith@kdor.ks.gov).

All interested parties will be given a reasonable opportunity to present their views, either orally or in writing or both, concerning the adoption of the proposed regulations. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working days in advance of the hearing by contacting Kathleen Smith at 785-296-3081 or TTY 785-296-6461. Disabled parking is located in State Parking Lot No. 2, south of the Docking Building facing Harrison Street. The east entrance to the Docking Building is accessible.

These regulations are proposed for adoption on a permanent basis. A summary of the proposed regulations and the economic impact follows:

**Article 13.—RETAIL LIQUOR DEALER**

**Adoption of 14-13-16. Tasting events; requirements; prohibitions.** This new regulation implements the provisions of Section 3 of 2012 Substitute for HB 2689, allowing retail licensees to serve free samples of alcoholic liquor on the licensed premises and at adjacent premises monitored and regulated by the Division of ABC. The regulation establishes procedures for conduct of the event, record keeping and storage of liquor.

Economic Impact: The Department of Revenue does not anticipate any impact on the department or other government agencies. Licensees may see an increase in sales of alcoholic liquor through the sampling program.

**Adoption of 14-13-17. Tasting events; supplier participation; requirements; prohibitions.** This new regulation implements the provisions of Section 3 of 2012 Substitute for HB 2689, allowing suppliers to participate in tasting events conducted by a retail liquor store licensee on the licensed premises and at adjacent premises monitored and regulated by the Division of ABC. The regulation es-

tablishes procedures for a supplier's conduct of the event, record keeping and storage of liquor.

Economic Impact: The Department of Revenue does not anticipate any impact on the department or other government agencies. Licensees may see an increase in sales of alcoholic liquor through the sampling program.

**Adoption of 14-13-18. Change of ownership; notice to director.** This new regulation requires a retailer to notify ABC of its intent to transfer ownership in its business at least 20 days prior to the transfer, then notify ABC again not later than 10 days after the transfer takes place. The notices must include all information necessary to determine the continued eligibility of the licensee.

Economic Impact: The Department of Revenue does not anticipate any impact on the department or other government agencies.

Sealed bids for **Turkey Creek Bicycle and Pedestrian Trail (PR-1067), KDOT Project No. 46 N-0553-01**, will be received by the city of Overland Park, Kansas, at the office of the city clerk, City Hall, 8500 Santa Fe Drive, Overland Park, 66212, until 2 p.m. local time March 5, 2013. At that time all sealed bids will be transferred to the City Council Chamber, City Hall, where they will be publicly opened and read aloud. Any bid received after the designated closing time will be returned unopened.

All bids shall be submitted in sealed envelopes addressed to the city clerk of Overland Park, Kansas, and marked "BID FOR: Turkey Creek Bicycle and Pedestrian Trail (PR-1067)." Copies of plans, specifications, bid documents and other contract documents are on file at the office of Olsson Associates, 7301 W. 133rd St., Suite 200, Overland Park, 66213. Neither the city nor the consultant shall be responsible for the accuracy, completeness or sufficiency of any bid documents obtained from any source other than the source indicated above. Obtaining copies of plans, specifications, bid documents and other contract documents from any other source(s) may result in obtaining incomplete and inaccurate information. Obtaining these documents from any source other than directly from the source listed herein also may result in failure to receive any addenda, corrections or other revisions to these documents that may be issued.

Contractors should read and be fully familiar with all contract documents before submitting a bid. In submitting a bid, the bidder warrants that it has read the contract documents and is fully familiar therewith and that it has visited the site of the work to fully inform itself as to all existing conditions and limitations, and shall include in its bid a sum to cover the cost of all items of the work.

Should a bidder find "defects" as defined in paragraph GC-3 of the General Conditions, it shall follow the procedures outlined in paragraph GC-3 to bring same to the attention of the city. Changes necessitated thereby shall be in the form of addenda issued by the consultant.

All bidders shall verify that they have considered all written addenda. Neither the city nor the consultant shall be responsible for oral instructions.

Any written addenda issued during the time of bidding shall be covered and included in the bid. There will be no clarifications or exceptions allowed on the bid. Bids are for a total bid package, total contract price.

Bids shall be made upon the form provided in ink or typewritten. Numbers shall be stated both in writing and in figures, the signature shall be longhand, and the com-

plete form shall be without alteration or erasure. On alternate items for which a bid is not submitted, a written indication of "no bid" on the bid form is required.

No oral, telegraphic, facsimile or telephonic bids or alterations will be considered.

The following items must be included in the sealed envelope with the bid:

- a. Bid
- b. 5% bid security — bid bond, cashier's check or certified check (see below)
- c. Signed documents (KDOT certifications)
  - DBE Contract Goal
  - Certification — Noncollusion & History of Debarment
  - Declaration — Limitations on Use of Federal Funds for Lobbying
  - Tax Clearance Certificate

Each bidder shall file with its bid a bid bond, a cashier's check or a certified check drawn on any acceptable bank, made payable to the city of Overland Park, Kansas, in an amount of not less than 5 percent of the total bid, which shall be retained by the city of Overland Park until a contract for the project has been executed. Bid bonds will be returned to the unsuccessful bidders, with the exception of the second qualifying bidder, at such time as their bids are rejected. The bid deposit of the successful bidder and the second qualifying bidder will be returned when satisfactory bonds in an amount equal to 100 percent of the contract amount, required insurance certificates and other required documents shall have been furnished and the contract documents have been executed.

In the event the successful bidder is unable to execute the contract, for whatever reason, the city may exercise its legal prerogatives, including, but not limited to, enforcement of its rights as to the bid security.

The city reserves the right to accept or reject any and all bids and to waive any technicalities or irregularities therein. Bids may be modified or withdrawn by written request of the bidder received in the office of the city clerk prior to the time and date for bid opening; provided, however, that no bidder may withdraw its bid for a period of 30 days from the date set for the opening thereof. All bidders agree that rejection shall create no liability on the part of the city because of such rejection. It is understood by all bidders that an unsuccessful bidder has no cause of action against the city for bid preparation costs. The filing of any bid in response to this invitation shall constitute an agreement of the bidder to these conditions.

After expiration of said 30 days from the date of publication of this notice, no one shall have any right to commence an action contesting the validity of such revenue bonds or the provisions of such proceedings of the board, all such revenue bonds shall be conclusively presumed to be legal and no court shall thereafter have the authority to inquire into such matters.

The Kansas Department of Health and Environment received an application from the city of Salina to modify the city's municipal solid waste (MSW) landfill (Permit No. 144) at 4292 S. Burma Road, southwest of Salina in Saline County, Kansas.

The total facility permitted site area remains unchanged at approximately 656.5 acres, which is all contained within Section 7, Township 15 South, Range 3 West, in Saline County. City officials have proposed adding 9.6 acres of landfill disposal area to the existing 280.1 acres of MSW disposal area, for a total of 289.7 acres of disposal. City officials also have proposed increasing the final elevation of the landfill from an elevation of 1,408 feet to approximately 1,545 feet above sea level. These modifications would add approximately 8.4 million cubic yards of capacity or approximately 73 years of disposal at current disposal rates. Existing solid waste management activities at this facility include temporary storage of MSW in drop-off containers, white goods and scrap metal storage, tree and brush burn pit, and post-closure care of closed MSW landfill areas.

The city of Salina has certified that the application described herein is consistent with its solid waste management plan and compatible with surrounding land use.

KDHE is providing public notice of its intent to issue a permit to the city of Salina to allow the facility modifications described herein. However, a final decision to issue the permit has not been made, and KDHE will consider information gathered during the public comment period before making a final decision. The U.S. Environmental Protection Agency has a 45-day review period, which will start concurrently with the 30-day public comment period, within which to object to the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the

EPA to review the permit. The 60-day public petition period will directly follow the EPA's 45-day review period. Interested parties may contact KDHE to determine if the EPA's 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. #### Notice of Hearing on Proposed Administrative Regulations

The Kansas Department of Health and Environment, Division of Environment, Bureau of Waste Management (BWM), will conduct a public hearing at 1:30 p.m. Tuesday, April 2, in the Azure Conference Room, fourth floor, Curtis State Office Building, 1000 S.W. Jackson, Topeka, to consider the adoption of proposed new hazardous waste management regulation K.A.R. 28-31-260b and the adoption of amended hazardous waste management regulation K.A.R. 28-31-268. A summary of the proposed regulations, environmental benefit and estimated economic impact follows.

#### Summary of Regulations:

**K.A.R. 28-31-260b. General provisions and definitions; adoption of technical documents.** This regulation adopts technical documents that are cited in the federal hazardous waste regulations which the state has adopted by reference. Adoption of these technical documents is needed to maintain and update Kansas' authorization to administer the hazardous waste management program in lieu of the EPA.

**K.A.R. 28-31-268. Land disposal restrictions; adoption and modification of federal regulations.** The proposed amendment corrects an error in K.A.R. 28-31-268, which adopts 40 CFR Part 268, Land Disposal Restrictions, by reference. 40 CFR Part 268 sets standards for treatment of hazardous waste that is destined for disposal in a municipal solid waste landfill or a hazardous waste landfill.

Under federal regulations, land disposal restrictions (LDRs) apply to generators of more than 100 kg of hazardous waste each month, i.e., small quantity generators and large quantity generators. Kansas' most recent adoption of this regulation changed the generation limit to 25 kg per month, thus requiring that Kansas small quantity generators (KSQGs) also comply with all of the LDR reg-

ulations. The intent was that KSQGs only needed to comply with two sections of the LDRs.

It is important that this error be corrected before Kansas' authorization to administer the hazardous waste program is updated. If the EPA authorizes the regulation without the correction, the EPA could require KSQGs to comply with all of the LDR requirements in 40 CFR 268.

**Environmental Benefit:** The adoption by reference of technical documents in K.A.R. 28-31-260b and the corrections to K.A.R. 28-31-268 do not provide any environmental benefit.

**Economic Impact:** The adoption by reference of technical documents in K.A.R. 28-31-260b imposes no additional costs on the regulated community. The amendment to K.A.R. 28-31-268 reduces the potential regulatory burden and cost of compliance with this regulation for more than 600 KSQG facilities in Kansas. There will be no increase in costs to governmental agencies or the general public.

The time period between the publication of this notice and April 2 serves as the required public comment period of at least 60 days for the purpose of receiving written public comments on the proposed regulatory action. All interested parties may submit written comments prior to 5 p.m. April 2 to Christine Mennicke, Kansas Department of Health and Environment, Bureau of Waste Management, 1000 S.W. Jackson, Suite 320, Topeka, 66612, by fax to 785-296-8909 or by email to [cmennicke@kdheks.gov](mailto:cmennicke@kdheks.gov).

During the hearing, all interested parties will be given a reasonable opportunity to present their views orally on the proposed regulations as well as an opportunity to submit their written comments. In order to give all parties an opportunity to present their views, it may be necessary to require each participant to limit any oral presentation to an appropriate timeframe.

(f) The winner of the first ticket drawn shall win the poker table and chip set. The winner of the second ticket drawn shall win the \$25 gift certificate from Kisby's Pit Stop. The winner of the third ticket drawn shall receive promotional items of the Kansas lottery's choice.

(g) The drawing shall be held at Kisby's Pit Stop on or about August 10, 2012, at approximately 1:05 p.m. (Authorized by and implementing K.S.A. 2011 Supp. 74-8710; effective, T-111-10-18-12, July 18, 2012.)

**111-2-290. Method of entry.** (a) Entry into the Kisby's Pit Stop 25th anniversary promotion shall be accomplished as follows:

(1) During the term of this promotion, customers shall receive an entry voucher with any single purchase of \$5 or more worth of Super Kansas Cash on a single ticket to use as an entry to complete and put into the drop box provided.

(2) The purchaser must complete the information on the entry voucher in a legible manner. Only one name shall appear on each entry voucher.

(3) The completed entry voucher must be placed into the designated drawing receptacle provided at Kisby's Pit Stop no later than 1:00 p.m. on August 10, 2012.
