Notice to Contractors

Electronic copies of the letting proposals and plans are available on the KDOT website at <http://www.ksdot.org/burconsmain/contracts/proposal.asp>. The website will allow the contractor to request approval from KDOT to bid as a prime contractor and be included on the "Bid Holders List," or to be included on the "Non-Bid Holders List" as a subcontractor/supplier. KDOT's approval is required to bid as a prime contractor. To bid as a prime contractor, KDOT needs to be notified of the intent to bid no later than the close of business on the Monday preceding the scheduled letting date. Failure to obtain prior approval to bid as a prime contractor on any projects listed below will be reason to reject your bid. The secretary of transportation reserves the right to reject bids that do not comply with all requirements for preparing a bidding proposal as specified in the 2007 edition of the Kansas Department of Transportation *Standard Specifications for State Road and Bridge Construction*.

KDOT will only accept electronic internet proposals using the Bid Express website at <http://www.bidx.com> until 1 p.m. local time April 20, 2016. The proposed action consists of reissuing an existing pretreatment permit for an existing facility. This facility manufactures, tests and overhauls aircraft instruments, helicopter parts, oil coolers and pumps. This facility performs chemical conversion coating operations on aluminum parts and discharges the contaminated rinse water from this operation. A foundry used to cast lead/kirksite is also performed on-site but does not use water and is considered a dry operation. The proposed permit contains limits for total toxic organics, cadmium, chromium, copper, lead, nickel, silver, zinc, total cyanide, and pH, as well as monitoring of flow.

The bonds will consist of fully registered bonds in the denomination of \$5,000 or any integral multiple thereof. The bonds will initially be registered in the name of Cede & Co., as nominee of the Depository Trust Company, New York, New York, to which payments of principal of and interest on the bonds will be made. Individual purchases of bonds will be made in book-entry form only. Purchasers will not receive certificates representing their interest in bonds purchased. The bonds will be subject to mandatory and optional redemption prior to maturity as provided in the Official Notice of Bond Sale and Preliminary Official Statement.

The bonds will bear interest from the date thereof at rates to be determined when the bonds are sold as hereinafter provided, which interest will be payable semiannually on February 1 and August 1 in each year, beginning on February 1, 2017.

Paying Agent and Bond Registrar

The Kansas State Treasurer, Topeka, Kansas, is designated as the Paying Agent and Bond Registrar.

Good Faith Deposit

HOUSE BILL No. 2438

AN ACT concerning fire districts; adding territory of adjoining cities; amending K.S.A. 19-3605 and 19-3623 and repealing the existing sections.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 19-3605 is hereby amended to read as follows: 19-3605. If the governing body of any city of the first, second or third classes, lying which lies within or adjoins the boundaries of any proposed or organized fire district shall deem it advisable to that all or a part of the city be included within the territory of any fire district, such city or cities may be included within such district at the time of its organization or any time subsequent thereto as follows: The governing body thereof of the city shall, not less than twenty (20) 20 days prior to some a regular meeting day, publish a notice (as in the case of publishing ordinances) in the official city newspaper of its intention to petition the board of county commissioners that all or a part of said the city be made a part of or be included within any proposed or organized fire district in the county and of a hearing on said the proposal at such the meeting. At such the meeting, or any adjournment thereof, the said governing body may adopt a resolution directed to the board of county commissioners praying requesting that all or part of the city be included within or added to the fire district, and said the petition may be heard by the board of county commissioners at any meeting thereof. After such the hearing, the board of county commissioners may make its order as in the case of the organization of a new district or the alteration and modification of the boundaries of an existing district.

Sec. 2. K.S.A. 19-3623 is hereby amended to read as follows: 19-3623. New-lands territory may be included in any fire district created under the provisions of K.S.A. 19-3613 to through 19-3622, both sections inclusive, or acts amendatory thereof and amendments thereto, in like manner as provided by K.S.A. 19-3604 or 19-3605, and amendments thereto, for the inclusion of new-lands territory in a fire district organized under the provisions of K.S.A. 19-3601 to through 19-3612, both sections inclusive, or acts amendatory thereof and amendments thereto.

Sec. 3. K.S.A. 19-3605 and 19-3623 are hereby repealed.

Sec. 4. This act shall take effect and be in force from and after its publication in the Kansas register.
