Subject to the terms and requirements of the Official Notice of Bond Sale, dated February 6, 2017, of the City of Louisburg, Kansas (the city), bids to purchase the city's General Obligation Bonds, Series 2017-A, (the bonds) will be received at the office of the city clerk at City Hall, 215 S. Broadway, Louisburg, KS 66053, by telefacsimile at 913-837-5374, or electronically as described in the Official Notice of Bond Sale, until 11:00 a.m. (CST) Monday, March 6, 2017. The bids will be considered by the governing body at its meeting at 6:30 p.m. (CST) on the sale date.

No oral or auction bids for the bonds will be considered, and no bids for less than 100 percent of the total principal amount of the bonds and accrued interest to the date of delivery will be considered.

Good Faith Deposit

Bidders must submit a good faith deposit in the manner described in the Official Notice of Bond Sale, in an amount equal to 2 percent of the principal amount of the bonds.

Details of the Bonds

The bonds will be dated March 28, 2017, and will be issued as registered bonds in denominations of \$5,000, or any integral multiple thereof. Interest on the bonds is payable semiannually on March 1 and September 1 of each year, beginning September 1, 2017. Principal of the bonds becomes due on September 1 in the years and amounts as shown below:

Payment of Principal and Interest

The Kansas State Treasurer will serve as the bond registrar and paying agent for the bonds.

Book-Entry Bonds

The bonds will be issued and registered under a book-entry-only system administered by The Depository Trust Company, New York, New York (DTC).

Delivery of the Bonds

The city will prepare the bonds at its expense and will deliver the registered bonds to DTC on or about March 28, 2017. Any bond printing costs will be paid by the city from the proceeds of the bonds or other city funds.

Legal Opinion

The bonds will be sold subject to the legal opinion of Triplett, Woolf & Garretson, LLC, Wichita, Kansas, bond counsel, whose fees will be paid by the city.

Financial Matters

The city's current assessed valuation for purposes of calculating statutory debt limitations is \$44,754,307. As of March 28, 2017, the city's total outstanding general obligation debt (including the bonds), is \$6,595,000*.

The proposed action consists of reissuing an existing Kansas/NPDES Water Pollution Control permit for an existing facility. This facility is engaged in a hog slaughtering operation which processes the carcasses into various prepared meat products. The wastewater generated from slaughtering, deboning, grinding, packaging, and clean-up operations is pre-treated with a rotary drum screen and a grease basin. The pre-treated wastewater commingles with the flow from the grit chamber serving the holding pens washing, the wastewater from the engine room and rest rooms, and stormwater run-off prior to flowing into the wastewater treatment system, consisting of an anaerobic lagoon, a synthetic-lined lagoon which is divided into an aeration basin and an uncovered, aerated biosolids storage basin; a final clarifier; a tank for CO2 feed for pH adjustment and four aerobic lagoons. With completion of an oil and meal recovery facility, paunch and screenings are now rendered on-site. The recovery facility utilizes final effluent from Pond 6 as cooling and scrubber water. The proposed permit contains limits for biochemical oxygen demand, total suspended solids, oil and grease, fecal coliform, ammonia, total nitrogen, total phosphorus, whole effluent toxicity, pH, and flow, as well as monitoring for chlorides, nitrate, nitrite, and total Kjeldahl nitrogen. The permittee is also required to submit an annual land application report.

Notice of Hearing on Proposed Administrative Regulations

The Kansas State Board of Education will conduct a public hearing at 1:30 p.m., or as soon thereafter as possible, on Tuesday, May 9, 2017, in the Board Room of the Landon State Office Building, 900 SW Jackson Ave., Suite 102, Topeka, Kansas, to consider the adoption of proposed rules and regulations of the Kansas State Board of Education on a permanent basis.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rule and regulation. All interested parties may submit written comments prior to the hearing to the secretary of the Kansas State Board of Education at the below addresses or by email to pPhill@ksde.org. The address for the Kansas State Board of Education is Landon State Office

Building, 900 SW Jackson Ave., Suite 102, Topeka, KS 66612. All interested parties will be given a reasonable opportunity to present their views orally regarding the adoption of the proposed regulations during the public hearing. In order to provide all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes. The hearing shall be conducted in compliance with the public hearing procedures of the Kansas State Board of Education.

Any individual with a disability may request an accommodation in order to participate in the public hearing, and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation to participate in the hearing should be made at least five working days in advance of the hearing by contacting Wendy Fritz at 785-296-5363 (or TDD 785-296-8172) or by email to wfritz@ksde.org. The north entrance to the Landon State Office Building is accessible. Handicapped parking is located at the south end of the Landon State Office Building, across the street from the north entrance to the building, and on Ninth Street, just around the corner from the north entrance to the building.

A summary of the proposed regulations and their economic impact follows.

K.A.R. 91-1-70a

This regulation adopts by reference the National Council on the Accreditation of Teacher Education (NCATE) standards and procedures for accrediting of teacher education units in Kansas. The two national accrediting entities, NCATE and Teacher Education Accreditation Council (TEAC) combined to form one new entity called the Council for the Accreditation of Educator Preparation (CAEP). The regulation amendments accommodate this change from NCATE to CAEP standards. Adoption of this amendment will have minimal if no economic impact on teacher preparation institutions, school districts, or individuals.

K.A.R. 91-1-208

An amendment requires license application forms to include a completed Child Abuse and Neglect Central Registry release. According to Kansas law a substantiated finding of abuse and/or neglect prohibits any person listed on the Child Abuse and Neglect Registry from working, residing, or volunteering in a child care home or facility regulated by Kansas Dept. of Health and Environment. This amendment will allow KSDE to search the Child Abuse and Neglect Registry to find out if the Kansas State Department for Children and Families (DCF) has substantiated any such claim against a licensee. Adoption of this amendment will have no economic impact on teacher preparation institutions, school districts, or individuals. License applications will include a release statement.

K.A.R. 91-1-221

Revoked due to lack of need and usage.

K.A.R. 91-1-235

An amendment formalizes a program completion requirement that has been in practice since 2008 to require a pre-service candidate work sample to be completed during the initial teacher preparation program. Adoption of this amendment will have minimal if no economic impact on teacher preparation institutions, school districts, or individuals as this is a current practice during pre-service.

Permanent Administrative Regulations

Article 3.—SWINE BRUCELLOSIS AND CERVIDS

9-3-9. Certificate of veterinary inspection; importation and intrastate movement requirements and permits. (a) Each cervid imported into Kansas shall be identified with official identification and shall be accompanied by a certificate of veterinary inspection.

(b) Each individual importing a cervid into Kansas shall obtain an import permit from the Kansas department of agriculture, division of animal health before the

cervid enters Kansas. The cervid shall not be allowed entry into Kansas without this permit.

(c) Each animal of the genera *Odocoileus*, *Cervus*, and *Alces*, including whitetail deer, mule deer, black-tailed deer and associated subspecies, North American elk (wapiti), red deer, sika deer, moose, and any hybrids of these species, regardless of age, not moving directly to a licensed slaughter establishment within Kansas shall originate and move directly from a herd with at least five years of herd status in the APHIS herd certification program or an equivalent program administered by the office of the state veterinarian in the state of origin.

Muntjacs, Père David’s deer, reindeer or caribou, fallow deer, and axis deer shall be exempt from the monitoring requirements for CWD in K.A.R. 9-3-15 and 9-3-16. Other cervid species may be exempted by the commissioner if the species are determined by APHIS to be nonsusceptible to CWD.

(d) Each adult domesticated cervid, except whitetail deer and mule deer, that is entering Kansas from another state, is not moving directly to a licensed slaughter establishment within Kansas, and has not originated and moved directly from an APHIS-certified brucellosis-free herd shall be required to test negative for brucellosis, using an approved test, within 45 days before entry into Kansas. Any imported cervid required to have tested negative for brucellosis under this subsection may be quarantined for a test or retest for brucellosis by order of the commissioner. Each test or retest shall be at the owner’s expense.

(e) All cervids originating from an area identified by APHIS as a designated surveillance area shall be prohibited entry into Kansas.

(f) Each domesticated cervid, except nursing young under four months of age and accompanied by their dam, that is entering Kansas, is not from a herd accredited by APHIS to be TB-free, and is not moving directly to a licensed slaughter establishment in Kansas shall be required to test negative for TB, using an approved test administered twice at least 90 days apart. The first test shall be administered no more than 180 days before entry into Kansas, and the second test administered no more than 90 days before entry.

(g) Any imported cervid may be quarantined for a retest for TB by order of the commissioner.

(h) Each domesticated cervid, alive or dead, transported within the state of Kansas shall be accompanied by a completed transportation notice signed by the shipper on a form provided by the Kansas department of agriculture, division of animal health. One copy of the notice shall be mailed to the commissioner, one copy shall accompany the shipment, and one copy shall be retained by the shipper. The shipper shall possess a current domesticated cervid permit. 9-3-10. Brucellosis. (a) Any adult domesticated cervid known or suspected to have been exposed to brucellosis may be quarantined for a test or retest for brucellosis by order of the commissioner.

(b) The owner of any domesticated cervid herd infected with brucellosis shall take either of the following steps:

(1) Quarantine and depopulate the herd; or
 (2) quarantine the herd until a herd plan to eradicate brucellosis from the infected herd has been completed. (Authorized by K.S.A. 2016 Supp. 47-610; implementing K.S.A. 2016 Supp. 47-610 and K.S.A. 47-614; effective Sept. 19, 2014; amended March 10, 2017.)
