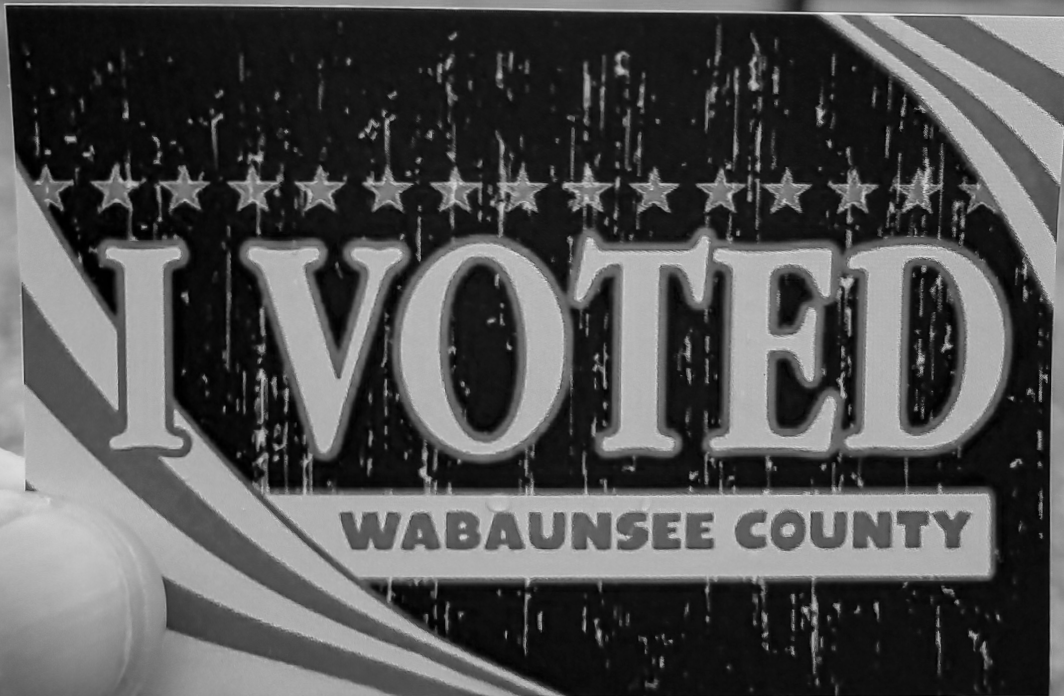

Request for Comments

The State of Kansas will submit by December 31, 2020, an updated annual report for administration of the block grant to states for Temporary Assistance for Needy Families (TANF). TANF provides assistance to low-income families with children, and provides parents with job preparation, work, and supportive services to enable them to leave the program and become self-reliant.

Federal law requires that a specified percentage of recipients of TANF be engaged in work or work activities. In determining if a state meets its minimum participation requirement, a state is allowed a credit for reducing the size of its TANF caseload.

Public notice is hereby given that the Kansas Department of Transportation (KDOT), in cooperation with the Federal Highway Administration (FHWA), will prepare an Environmental Assessment (EA) for a proposal to modernize and expand the U.S. 69 Corridor located in Johnson County, Kansas. The City of Overland Park and the Kansas Turnpike Authority are serving as partners on the study.

The overall environmental study limits begin just south of W. 179th Street and extend to just north of 103rd Street. The overall length is approximately ten miles. Major roads at interchanges are included within the environmental study area, including W. 103rd Street, College Boulevard, W. 119th Street, Blue Valley Parkway, W. 135th Street, W. 151st Street, W. 167th Street, and W. 179th Street. Additionally, I-435 at the interchange with U.S. 69 is included.

Within the EA, FHWA and KDOT will evaluate a “No Action” alternative as well as modernization and expansion alternatives, including a toll alternative as the proposed action. The toll alternative will evaluate the potential benefits of express toll lanes for north and southbound traffic to improve safety and improve congestion in the corridor. Roadway and interchange configurations will be evaluated throughout the corridor.

The FHWA and KDOT plan to prepare an EA for the project. The EA will analyze the potential social, economic, and environmental impacts resulting from the proposed project. The following issues will be specifically analyzed as part of the EA: impacts to the aquatic ecosystem; impacts to cultural resources; impacts to threatened and endangered species; impacts to floodplains; impacts to transportation; impacts to parks/recreation; environmental justice; and socioeconomics. This includes direct, indirect, and cumulative impacts. Other federal approvals or permits that may be required; a Section 404 Permit from the U.S. Army Corps of Engineers (USACE), a floodplain development permit from the City of Overland Park as well as water resource, and floodplain permits from the Kansas Division of Water Resources.

A scoping and coordination process will be initiated that involves appropriate federal, state, and local agencies, as well as stakeholders and the public. This will continue throughout the study to engage the local and regional community to obtain public input and to keep the public informed. Coordination meetings will be held as needed with affected/concerned local, state, tribal, and federal governmental entities. Public meetings will be held to gather input and share findings on the EA. The EA will be made available for public and agency review and comment prior to the final public meeting.

To ensure that the full range of issues related to the proposed action are addressed and all significant issues defined, comments and suggestions are invited from all interested parties. Qualifications-Based Selection Process

A qualification-based selection process conforming to FAA Advisory Circular 150/5100-14E *Architectural, Engineering, and Planning Consultant Services for Airport Grant Projects* will be utilized to select a consultant. No cost or pricing information shall be submitted with the LOI and will not be considered in the selection process to shortlist or rank proposals. Based on the qualifications submitted in the LOI and other information available to KDOT, on or about December 2, 2020 KDOT will shortlist three to five firms and notify all firms submitting LOIs of the names of the shortlisted firms by return email. The firm's accounting systems must have the following capabilities before the firm may be awarded a contract.

- Valid, reliable, and current costs must be available within the system to support actual costs and pricing data.
- Capability to provide a means of measuring the reasonableness of incurred costs.
- Capability to identify and accumulate allowable costs by contract or project records which will reconcile with the general ledger.
- Ability to provide supporting documentation of actual expenditures for each billing, based on costs.

Article 4. – MOTOR CARRIERS OF PERSONS AND PROPERTY

82-4-30a. Applications for interstate registration.

(a)(1) For the purposes of this regulation, “base state” shall have one of the following meanings:

(A) The meaning assigned to “base-state” in 49 U.S.C. 14504a(a)(2), as adopted in paragraph (a)(2) of this regulation; or

(B) if an entity does not have a principal place of business, office, or operating facility in any participating state, the participating state chosen by the entity that is nearest to the location of the entity’s principal place of business or any participating state within the entity’s FMCSA region.

(2) 49 U.S.C. 14504a, as in effect on January 14, 2019, is hereby adopted by reference, except for the following portions:

(A) In 49 U.S.C. 14504a(a), the following:

(i) The phrase “and section 14506 (except as provided in paragraph (5))”;

(continued)

- (ii) 49 U.S.C. 14504a(a)(3);
- (iii) 49 U.S.C. 14504a(a)(5)(B); and
- (iv) 49 U.S.C. 14504a(a)(6) through (7);
- (B) 49 U.S.C. 14504a(c) through (e);
- (C) In 49 U.S.C. 14504a(f), 49 U.S.C. 14504a(f)(1)(B) through (E); and
- (D) 49 U.S.C. 14504a(g) through (j).

(3) Each interstate motor carrier designating Kansas as the carrier’s base state and operating in interstate commerce over the highways of this state under authority issued by the relevant federal agency shall file the uniform application for registration issued by the relevant federal agency. The carrier shall file this application for registration with the transportation division of the state corporation commission.

(b) Each interstate motor carrier designating Kansas as the carrier’s base state shall pay a fee to the state corporation commission through the national registration system. This fee shall be in accordance with the fee schedule in 49 C.F.R. 367.60, as in effect on October 1, 2019 and as amended by 85 fed. reg. 8198 (2020), which is hereby adopted by reference.

(c) An interstate regulated motor carrier shall not operate in interstate commerce over the highways of this state unless the carrier is registered in the carrier’s base state as defined in paragraph (a)(1). Article 1.—DISEASES

28-1-40. Definitions. In addition to the terms defined in L. 2020 Special Session, ch. 1, sec. 16 and amendments thereto, each of the following terms, as used in K.A.R. 28-1-40 through 28-1-43, shall have the meaning specified in this regulation:

- (a) “Department” means Kansas department of health and environment.
- (b) “Personal information” means contact data collected as specified in K.A.R. 28-1-42 and “personal information” collected pursuant to K.S.A. 50-7a01, and amendments thereto.
- (c) “Protected health information” has the meaning specified in K.S.A. 65-6822, and amendments thereto.
- (d) “Third party” means any of the following, other than any of the entities specified in K.S.A. 65-118 and amendments thereto:
 - (1) An individual, other than a contact tracer;

- (2) an organization;
- (3) a business; or
- (4) an entity similar to any of the entities specified in paragraphs (d)(1) through (3). (Authorized by and implementing L. 2020 Special Session, ch. 1, sec. 16; effective, T-36-8-28-20, Aug. 28, 2020; effective Nov. 20, 2020.)

28-1-41. Contact tracers. (a) Each individual acting as a contact tracer under the authority of the secretary or a local health officer shall meet the following qualifications and training requirements:

- (1) Be at least 18 years of age;
- (2) possess a high school diploma or GED certificate; and
- (3) complete a contact tracing training program approved by the secretary.

(b) Each individual acting as a contact tracer under the authority of the secretary or a local health officer shall execute the following oath or affirmation:

“I, ___[name]___, acknowledge that I have completed the training to become a contact tracer. I am familiar with the provisions contained in and duties required by L. 2020 Special Session, ch. 1, sec. 16, attached hereto and incorporated by reference, including the duty of confidentiality stated therein. I do solemnly swear (or affirm) that I will comply with those Kansas COVID-19 contact tracing provisions while acting as a contact tracer. So help me God.

Signature: _____ Date: _____”

(c) Any individual having conscientious scruples against taking an oath ending with a reference to a deity may affirm with like effect without the need to make a reference to the deity.

(d) The oath or affirmation specified in subsection (b) may be executed before the secretary, the secretary’s designee, a local health officer, or the local health officer’s designee. (Authorized by and implementing L. 2020 Special Session, ch. 1, sec. 16; effective, T-28-7-30-20, July 30, 2020; effective Nov. 20, 2020.)

28-1-42. Contact data; communication with contacts. (a) Each individual acting as a contact tracer under the authority of the secretary or a local health officer shall be limited to collecting the following personal information for any contact:

- (1) Identity;
- (2) address;
- (3) telephone number;
- (4) electronic-mail address;
- (5) geographical or similar location information at certain points in time; and
- (6) the name of each individual who could be an additional contact.

(b) Each individual acting as a contact tracer under the authority of the secretary or a local health officer shall be limited to collecting the following health data for any contact:

- (1) Age;
 - (2) physical biometrics;
 - (3) temperature; and
 - (4) symptoms.
- (c) Whenever a contact tracer communicates with a contact, the contact tracer shall advise the contact that

the contact is under no compulsion or prohibition from participating in the contact tracing.

(1) The contact tracer shall use the following text, or a substantially similar text, when advising the contact:

“Participation in COVID-19 contact tracing is voluntary. You may not be compelled or prohibited from participation with contact tracing for COVID-19. If in good faith you do provide information requested by a contact tracer, you shall be immune from civil, criminal, and administrative liability for disclosing the information. If you do not provide information, you are not subject to civil, criminal, or administrative penalties. Do you understand what I have said? May I ask you questions concerning a COVID-19 contact tracing?”

(2) The contact tracer shall document in the contact data whether the text was provided and what were the contact’s responses to the questions. (Authorized by and implementing L. 2020 Special Session, ch. 1, sec. 16; effective, T-28-7-30-20, July 30, 2020; effective Nov. 20, 2020.)

28-1-43. Surrender or destruction of contact data. (a) Each individual acting as a contact tracer for the secretary or a local health officer who possesses contact data pursuant to L. 2020 Special Session, ch. 1, sec. 16, and amendments thereto, shall surrender all contact data to

the secretary or the local health officer when the contact data is no longer needed to monitor the contact’s health and the contact has been released from quarantine.

(b) Each individual who possesses contact data permitted to be collected as specified in K.A.R. 28-1-42 shall destroy any contact data that contains protected health information, individual movement or mobility data, or personal information whenever the secretary determines that the contact data that contains protected health information, individual movement or mobility data, or personal information is no longer necessary for the purpose of containing the spread of COVID-19. (Authorized by and implementing L. 2020 Special Session, ch. 1, sec. 16; effective, T-28-7-30-20, July 30, 2020; effective Nov. 20, 2020.)

28-1-44. Sunset provision. K.A.R. 28-1-40 through 28-1-43 shall have no force and effect after May 1, 2021 or upon the expiration of L. 2020 Special Session, ch. 1, sec. 16 and amendments thereto, whichever is later. (Authorized by and implementing L. 2020 Special Session, ch. 1, sec. 16; effective, T-28-7-30-20, July 30, 2020; effective Nov. 20, 2020.)
