#### Notice of Available Funding for Adult Education

Pursuant to assurances set forth in the Kansas Four-Year State Plan for Adult Education, notification of available state and federal funding for adult education and family literacy programs is announced. These funds are authorized by the Adult Education and Family Literacy Act (Title II of the Workforce Investment Act [WIA] of 1998). Title II of WIA, the Adult Education and Family Literacy Act (AEFLA), provides federal financial assistance to states to assist, improve and/or expand existing local programs that serve adults and out-of-school youth age 16 and older, who meet one of the following conditions:

- do not have a secondary credential;
- do not have basic reading, writing or math skills; or
- do not have proficiency in the English language necessary to function in the multiple roles of citizen, employee and family member.

The State Board of Regents, the state agency responsible for implementation of the AEFLA in Kansas, will award multi-year grants through a competitive process to eligible entities whose adult education programs provide intensive, quality instructional and support services to adults. These services include activities that lead to the following outcomes:

- demonstrated improvements in literacy skill levels in reading, writing and speaking the English language, numeracy, problem solving, English language acquisition and other literacy skills;
- placement in, retention in, or completion of postsecondary education, training, unsubsidized employment or career advancement; and
- receipt of a secondary school diploma or its recognized equivalent.

Priority is given to local programs that have a history of providing services that are based on a solid foundation of research, address the diverse needs of adult learners and result in measurable learner outcomes. This sworn statement shall be in the form of an affidavit executed and sworn to by the bidder before a person who is authorized by the laws of the state to administer oaths. ## Opinion No. 2010-01

Written January 20, 2010, to Chris Biggs, Securities Commissioner of Kansas, Topeka.

This opinion is in response to your letter of December 23, 2009, in which you request an opinion from the Kansas Governmental Ethics Commission concerning the Campaign Finance Act, K.S.A. 25-4142 *et seq.* We note at the outset that the Commission's jurisdiction concerning your questions is limited to the application of K.S.A. 25-4142 *et seq.*, and whether some other statutory system, common law theory or agency rule or regulation applies to your inquiry is not covered by this opinion.

**Factual Statement:**

We understand you request this opinion in your capacity as the Kansas Securities Commissioner. You are contemplating running for a statewide office. You are asking for clarification of K.S.A. 25-4169a, and its impact on your run for statewide office.

**Questions:**

1. Does the statute on its face prohibit an unclassified employee of the State of Kansas from running for statewide office when maintaining employment with the State of Kansas?
2. Are such restrictions on political activity strictly construed in favor of allowing such activity?
3. What is meant by the word "time" in the statute, particularly as it relates to an unclassified employee who is running for a statewide elective office?

**Opinion:**

K.S.A. 2008 Supp. 25-4169a states in pertinent part:

(a) No officer or employee of the state of Kansas . . . shall use or authorize the use of public funds or public vehicles, machinery, equipment or supplies of any such governmental agency or the time of any officer or employee of any such governmental agency, for which the officer or employee is compensated by such governmental agency, to expressly advocate the nomination, election or defeat of a clearly identified candidate to state office or local office. The provisions of this section prohibiting the use of time of any officer or employee for such purposes shall not apply to an incumbent officer campaigning for nomination or reelection to a succeeding term to such office or to members of the personal staff of any elected officer.

K.S.A. 2008 Supp. 25-4169a does not on its face prohibit an unclassified employee of the State of Kansas from running for statewide office while maintaining employment with the State of Kansas. There is no statute under the Commission's jurisdiction which addresses this issue.

As to your second question, the interpretation regarding the restrictions on political activity is not within the Commission's purview.

After further discussion with you, the third question is an inquiry as to what the definition of time is as it relates to your work day. K.S.A. 2008 Supp. 25-4169a does not permit you to use your state compensated time to campaign for office as you are not an incumbent officer or the personal staff of any elected officer. The Campaign Fi-

nance Act does not define the word "time" for any state employee. Therefore, the Commission opines that the determination of time worked as an unclassified employee is made between you and your employer.

The project is being financed by the lender for Travis Nutsch and Kara Kichler and is located at the East Half and the Northwest Quarter of the Southeast Quarter of Section 31, Township 24 South, Range 12 East, Greenwood County, Kansas, approximately 5 miles south of Hamilton and 1 mile east on Y Road.

The bond, when issued, will be a limited obligation of the KDFA and will not constitute a general obligation or indebtedness of the state of Kansas or any political subdivision thereof, including the KDFA, nor will it be an indebtedness for which the faith and credit and taxing powers of the state of Kansas are pledged. The bond will be payable solely from amounts received from the respective borrower, the obligation of which will be sufficient to pay the principal of, interest and redemption premium, if any, on the bond when it becomes due.

## State of Kansas

### Office of the Governor

#### Executive Order 08-10

NOW, THEREFORE, pursuant to the authority vested in me as Governor of the State of Kansas, I hereby:

1. Declare a Drought Warning or Drought Watch for the counties identified below; and
2. Authorize and direct all agencies under the jurisdiction of the Governor to implement the appropriate Watch or Warning level drought response actions assigned to them in the Operations Plan of the Governor's Drought Response Team.

Drought Warning counties by Climate/Crop Reporting District:

Southwest: Grant, Morton, Stanton and Stevens.

Drought Watch counties by Climate/Crop Reporting District:

West Central: Greeley and Wichita.

Southwest: Hamilton, Haskell, Kearny, Meade and Seward.

County drought stages declared in this Executive Order shall remain in effect until October 31, 2008 or until revised or rescinded by a subsequent Executive Order.

**Executive Order 08-12**

WHEREAS, the State of Kansas is committed to ensuring that all of its citizens have the opportunity to lead full lives of independence, productivity, and self-determination, without regard to their disabilities; and

WHEREAS, in order to do so, it is important that the state's electronic and information technology systems are accessible to persons with disabilities, so that all Kansans can fully participate in and enjoy the benefits of state services, programs, employment, and opportunities; and

WHEREAS, Information Technology Policy 1210 established in 2000 accessibility requirements for all web-based services, applications, and information available on state internet/intranet/extranet servers, including services that are developed internally, developed via contract, provided by third parties on behalf of state organizations, or purchased products; and

WHEREAS, the removal of all barriers to equal opportunity for all Kansans requires the leadership and the concentrated and continued attention of the state administration to build upon this important foundation; and

WHEREAS, Kansas state government is a complex combination of organizations and functions providing a wide variety of services to citizens and other customers; and

WHEREAS, Article 1, § 4 of the Constitution of the State of Kansas vests in the Governor the power to require information from the officers of the executive department upon any subject related to their duties.

NOW, THEREFORE, pursuant to the authority vested in me as Governor of the State of Kansas, I hereby establish the Kansas Partnership for Accessible Technology ("Partnership") with the following purposes and charges:

1. The Partnership shall address web and information technology accessibility issues and provide policy, standards, guidelines, or procedural recommendations to the Information Technology Executive Council.
2. The Partnership shall coordinate, review, and provide recommendations on programs for enterprise wide assessment and monitoring of accessibility compliance.
3. The Partnership shall review annually and modify as required the State of Kansas Web Accessibility Requirements (Information Technology Policy 1210), and related documents (e.g., the State of Kansas Web Content Accessibility Guidelines), in response to any pertinent advances in technology and/or changes in federal accessibility standards.
4. The Partnership shall develop and provide information, training, support, and resources on web and information technology accessibility to agency web and information technology implementers and other stakeholders.
5. The Partnership shall aim to establish a leadership role for Kansas in the national effort to improve access to and use of information and services by individuals with disabilities.
6. The Partnership shall be a standing advisory committee to the Information Technology Executive Council, and other committees, boards and commissions as appropriate, and shall provide a copy of its annual report to the Council, as well as to the Governor and Legislature.
7. The Partnership membership shall consist of up to thirty (30) members as follows:
  - a. The Director of Statewide Web/IT Accessibility;
  - b. The State ADA Coordinator;
  - c. The Executive Director of the Kansas Commission on Disability Concerns;
  - d. The Director of the Department of Administration Division of Purchases;
  - e. The Chief Information Technology Architect;
  - f. The Executive Branch Chief Information Technology Officer, or designee;
  - g. The Legislative Branch Chief Information Technology Officer, or designee;

- h. The Judicial Branch Chief Information Technology Officer, or designee;
- i. The Executive Director of the Information Network of Kansas;
- j. The State Archivist, or designee;
- k. The State Geographic Information Systems Director;
- l. A representative from the Kansas Department of Social and Rehabilitation Services;
- m. A representative from the Kansas Department on Aging;
- n. A representative from the Division of Information Systems and Communications;
- o. A representative from the Kansas State Department of Education;
- p. A representative from the Regents Information Technology Council of the Kansas Board of Regents;
- q. A representative from Kan-ed;
- r. A representative from the Kansas Health Policy Authority;
- s. A representative from the Kansas Division of Emergency Management;
- t. A representative from Kansas Relay Services, Inc.;
- u. Up to ten (10) appointments by the Governor from among the following categories. These members shall serve at the pleasure of the Governor.
  - i. County government;
  - ii. Local government;
  - iii. The Kansas State School for the Blind;
  - iv. The Kansas School for the Deaf;
  - v. Disability advocates from the private sector;
  - vi. At-large.
- 8. The Governor shall select a Chairperson and Vice-Chairperson from among the members who shall serve for one year and thereafter be elected by the Partnership. The Partnership may elect other officers among its members and may establish any committees deemed necessary to discharge its duties.
- 9. Members of the Partnership, including officers and employees who are appointed to the Partnership, may receive subsistence allowances, mileage and expenses as permitted by law.
- 10. For administrative purposes, the Partnership shall be housed in the Division of Information Systems and Communications. The Partnership shall receive staff support from the Director of Statewide Web/IT Accessibility.
- 11. The Partnership shall work jointly with officials from other state agencies, organizations and county, municipal and tribal governments, as well as with businesses and organizations in the private sector whose products, services, or activities affect the accessibility of state services, programs, or systems.

This document shall be filed with the Secretary of State as Executive Order No. 08-12 and shall become effective immediately.

#### Executive Order 08-13

WHEREAS, pursuant to Executive Order 08-06, the Kansas Energy Council ("Council") was established to collect and compile information pertaining to the state's energy resources, estimate energy consumption and production, promote the state's renewable energy resources, evaluate transmission infrastructure reliability, and provide timely information to aid in the development of sound energy policy; and

WHEREAS, upon its establishment, the Council was the only existing entity coordinating energy resources, analyzing renewable energy and energy efficiency potential, and reviewing energy policies to help ensure Kansans have low cost, reliable and sustainable energy into the future; and

WHEREAS, several targeted groups have since been assembled to review energy-related matters, including the Legislative Joint Committee on Energy and Environmental Policy, the Kansas Energy and Environmental Policy Advisory Group, the Kansas Electric Transmission Authority, the Midwest Governor's Association, and the Wind Working Group; and

WHEREAS, the Council successfully collected information related to the state's energy consumption and production, and provided recommendations and information to the legislature, executive branch and Kansas Corporation Commission regarding energy policy; and

WHEREAS, the Energy Programs Division, the Kansas Corporation Commission and other groups formed after creation of the Kansas Energy Council are able to assume the responsibilities of the Council.

NOW, THEREFORE, pursuant to the authority vested in me as Governor of the State of Kansas, I hereby rescind the force and effect of Executive Order No. 08-06 promulgated by the Governor of the State of Kansas and abolish the Kansas Energy Council created by such Executive Order.

This document shall be filed with the Secretary of State as Executive Order No. 08-13 and shall become effective immediately.

A public hearing will be conducted at 10 a.m. Monday, March 29, in the basement auditorium of the Docking State Office Building, 915 S.W. Harrison, Topeka, to consider the adoption of the following proposed regulations as permanent regulations of the Kansas Home Inspectors Registration Board.

This 60-day notice of the public hearing constitutes a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments to the Kansas Home Inspectors Registration Board, 610 Rivera, Mulvane, 67110. Written comments must be received at or prior to the hearing. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

A summary of the proposed regulations and their economic impact follows:

**Article 1.—REGISTRATION, RENEWAL, AND  
EXAMINATION**

**K.A.R. 130-1-2. Renewal.** This proposed regulation establishes the information that a registrant must provide to the board to renew a registration.

**K.A.R. 130-1-3. Examination.** This proposed regulation establishes the standards that an examination and procuring entity must meet in order to be approved by the board as meeting the statutory requirements for registration. The proposed regulation establishes the minimum score to be achieved for successful completion.

**K.A.R. 130-1-4. Registration expiration; renewal.** The board proposes to amend the existing regulation regarding the date registrations expire.

**Article 3.—EDUCATION PROGRAMS**

**K.A.R. 130-3-1. Approval of educational providers.** This proposed regulation establishes the standards and core curriculum that an educational program must meet in order to be approved by the board for registration.

**Article 5.—CONTINUING EDUCATION**

**K.A.R. 130-5-2. Approval of continuing education providers.** This proposed regulation establishes standards for providers of continuing education programs. The proposal reflects modifications following a previous public hearing.

The proposed regulations have an economic impact on individuals who desire to perform home inspections in Kansas and on educational programs that do not meet the standards for approval. The impact on those who are qualified for registration is limited to the fees charged for the initial and annual renewal of a registration. The impact on educational programs to meet the standards for approval cannot reasonably be calculated.

Regulations****Article 6.—DISCLOSURE AND  
CONFIDENTIAL PROCEDURES**

**19-6-1. Nondisclosure and public record.** (a) (1) Except as otherwise provided by relevant law and as provided in K.A.R. 19-5-5, the following shall be confidential:

(A) All records, complaints, and documents of the commission and all reports filed with, submitted to, or made by the commission; and

(B) all records and transcripts of investigations, inquiries, and hearings of the commission under K.S.A. 46-215 et seq. and K.S.A. 25-4142 et seq. and amendments thereto.

(2) The items specified in this subsection shall not be open to inspection by any individual other than a member of the commission, an employee of the commission, or a state officer or employee designated to assist the commission.

(b) Nothing contained in this regulation shall prohibit any disclosure that is reasonable and necessary to investigate any matter. The following shall be public records and open to public inspection:

(1) Each complaint and any amendments after a determination that probable cause exists;

(2) each answer and any amendments with the consent of the respondent;

(3) any matter presented at a public meeting or public hearing; and

(4) each report of the commission stating a final finding of fact.

(c) Any person subject to an investigation and any respondent may release any report or order issued pursuant to K.A.R. 19-3-1 or K.A.R. 19-5-9 and may comment on the report or order. The confidentiality requirements of relevant law shall be met by all members of the commission and its staff. **Article 5.—CONTINUING EDUCATION**

**Article 6.—TEMPORARY CERTIFICATION**

**109-6-1. Requirements for temporary certification for applicant with non-Kansas credentials.** (a) An applicant for temporary certification who is certified or licensed as an attendant in another jurisdiction but whose coursework is not substantially equivalent to that required in Kansas may be granted one-year temporary certification by meeting the following requirements:

(1) Providing verification of current attendant certification or licensure issued by that jurisdiction that is comparable to the certification level sought in Kansas; and

(2) providing either the name, address, and telephone number of or a signed statement from the physician, physician assistant, professional nurse, or attendant who is certified at the same or higher level as that of the applicant and who will directly supervise the applicant during the year of temporary certification.

(b) Within one year from the date on which the temporary certificate is issued, if the applicant provides verification of successful completion of the required coursework, attendant's certification shall be granted. If the applicant does not provide this verification within one year from the date on which the temporary certificate is issued, the temporary certificate shall expire and the application for an attendant's certificate shall be denied. **109-6-2. Renewal of attendant, training officer, and instructor-coordinator certificates.** (a) Each attendant certificate shall expire on December 31 of the second complete calendar year following the date of issuance.

(b) An attendant, an instructor-coordinator who is also an attendant, and a training officer who is also an attendant may renew that person's certificate for each biennial period in accordance with this regulation and with K.A.R. 109-5-1.

(c) Each application for certification renewal shall be submitted on a form provided by the executive director or through the online renewal process. Copies, facsimiles,

and other reproductions of the certification renewal form shall not be accepted.

(d) Each application for renewal shall be deemed sufficient when the following conditions are met:

(1) The applicant provides in full the information requested on the form, and no additional information is required by the board to complete the processing of the application.

(2) The applicant submits a renewal fee in the applicable amount specified in K.A.R. 109-7-1.

(e) The date of receipt of a document shall mean the date stamped on the document when the document is received in the board office. **Article 10.—CURRICULA**

**109-10-7. Distance learning.** (a) Any EMS educational program accredited by the committee on accreditation of emergency medical services-paramedic or offered by an accredited postsecondary institution may be granted approval to provide an initial course of instruction or continuing education programs in a distance learning format.

(b) Any instructor-coordinator, training officer I, or training officer II not affiliated with a program accredited by the committee on accreditation of emergency medical services-paramedic or with an accredited postsecondary institution may be granted approval to offer an initial course of instruction or continuing education programs in a distance learning format if the course or program meets the requirements of this regulation.

(c) Each instructor-coordinator, training officer I, or training officer II not affiliated with a program specified in subsection (a) shall submit a request for initial course approval or an application for single-program provider to the executive director or the executive director's designee. The request or application shall include the following, in addition to meeting the requirements of K.A.R. 109-5-3, 109-5-6, 109-10-2, 109-10-6, 109-11-1, 109-11-3, 109-11-4, 109-11-5, 109-11-6, 109-11-7, or 109-11-10:

(1) The procedures to be used for conducting progress counseling sessions for all students, including at those sites where distance learning is provided;

(2) the process by which students can access the instructor for an initial course of instruction or continuing education program;

(3) the procedures to be used for ensuring timely delivery of and feedback on written materials at all sites;

(4) the procedures to be followed for ensuring that students are participating in the course;

(5) the procedures to be used to ensure the competency of those completing didactic and psychomotor skills training;

(6) identification of the learning management system to be used during the course; and

(7) identification of each program's quality assurance plan that at a minimum shall include the following:

*(continued)*

(A) An advisory committee that includes the program coordinator, program medical adviser, and representatives of the following:

- (i) Current students;
- (ii) former students;
- (iii) graduates;
- (iv) employees;
- (v) faculty;
- (vi) all communities of interest; and
- (vii) local ambulance service;

(B) an advisory committee meeting schedule; and

(C) a copy of the evaluation tools to be completed by the students, employees, staff, faculty, medical adviser, and program coordinator.

(d) Any approved class may be monitored by the executive director or the executive director's designee. (Authorized by K.S.A. 2008 Supp. 65-6111; implementing K.S.A. 2008 Supp. 65-6111 and 65-6129 and K.S.A. 65-6129b; effective Feb. 12, 2010.)
