Request for Comments

The Kansas Department for Aging and Disability Service will be hosting a series of public comment sessions regarding programmatic amendments resulting from federal changes, such as the Department of Labor Home Care Ruling, which will impact consumers receiving certain services on the HCBS Traumatic Brain Injury (TBI), Intellectual and Developmental Disability (IDD), Frail Elderly (FE), Physical Disability (PD) and Technology Assisted (TA) programs.

Additionally, KDADS will be presenting an amendment reflecting the Financial Management Services (FMS) model change initially presented in 2014 public sessions for the IDD, TA and TBI programs. Information regarding the proposed model change previously presented can be found at the KDADS website provided below.

The public comment period for related program amendments will be open from November 1-30, 2015. Public information sessions will be announced and posted on the KDADS website as information regarding dates and times become available.

Electronic copies of the letting proposals and plans are available on the KDOT website at <http://www.ksdot.org/burconsmain/contracts/proposal.asp>. The website will allow the contractor to request approval from KDOT to bid as a prime contractor and be included on the "Bid Holders List," or to be included on the "Non-Bid Holders List" as a subcontractor/supplier. KDOT's approval is required to bid as a prime contractor. To bid as a prime contractor, KDOT needs to be notified of the intent to bid no later than the close of business on the Monday preceding the scheduled letting date. Failure to obtain prior approval to bid as a prime contractor on any projects listed below will be reason to reject the bid. The secretary of transportation reserves the right to reject bids that do not comply with all requirements for preparing a bidding proposal as specified in the 2007 edition of the Kansas Department of Transportation's *Standard Specifications for State Road and Bridge Construction*.

The proposed action consists of reissuing an existing pretreatment permit for an existing facility. This facility manufactures steel roll over protection systems. Steel parts are cut, welded and processed in a three-stage phosphating system, before being painted. Spent wastes from the three-stage phosphating system are then pumped to an on-site, 6,000-gallon holding tank, which is considered Outfall 001. Once the pH of the waste is checked and adjusted, the wastes are then hauled to the city of Newton, via a 1,000-gallon portable tank. The proposed permit contains limits for total toxic organics, cadmium, chromium, copper, lead, nickel, silver, zinc, total cyanide and pH, as well as monitoring of flow.

Persons wishing to comment on the draft documents and/or permit applications must submit their comments in writing to the Kansas Department of Health and Environment if they wish to have the comments considered in the decision-making process. Comments should be submitted to the attention of the Livestock Waste Management Section for agricultural-related draft documents or applications, or to the Technical Services Section for all other permits, at the Kansas Department of Health and

After review of any comments received during the public notice period, the secretary of health and environment will issue a determination regarding final agency action on each draft document/application. If response to any draft document/application indicates significant public interest, a public hearing may be held in conformance with K.A.R. 28-16-61 (28-46-21 for UIC).

All draft documents/applications and the supporting information including any comments received are on file and may be inspected at the offices of the Kansas Department of Health and Environment, Bureau of Water. Article 1.—APPLICATION AND EXAMINATION

86-1-5. Fees. (a) Each applicant shall pay a fee in an amount equal to the actual cost of the examination and the administration of the examination to the testing service designated by the commission.

(b) Each applicant shall submit the following fees for licensure to the commission:

(1) For submission of an application for an original salesperson's or broker's license, a fee of \$15;

(2) for an original salesperson's license, a prorated fee based on a two-year amount of \$125;

(3) for an original broker's license, a prorated fee based on a two-year amount of \$175;

(4) for renewal of a salesperson's license, a two-year fee of \$125;

(5) for renewal of a broker's license, a two-year fee of \$175;

(6) for reinstatement of a license that has been deactivated or that has been canceled pursuant to K.S.A. 58-3047(c), and amendments thereto, or due to termination of a salesperson or associate broker, a fee of \$15;

(7) for reinstatement of each license canceled pursuant to K.S.A. 58-3047(d) or (f), and amendments thereto, a fee of \$7.50;

(8) for a duplicate license, a fee of \$10;

(9) for certification of licensure to another jurisdiction, a fee of \$10;

(10) for each branch office, a fee of \$25;

(11) for each primary office of a company created or established by a supervising broker, a fee of \$25;

(12) for certification of a licensee's education history under K.S.A. 58-3046a, and amendments thereto, a fee of \$10;

(13) for certification of licensure of a professional corporation, a fee of \$10; and

(14) for each additional primary or branch office at which a salesperson or an associate broker, supervising broker, or branch broker is associated or employed, if the person is associated or employed by more than one primary or branch office, a fee of \$10, which shall be paid by the salesperson or broker.

(c)(1) Each applicant for an original salesperson's or broker's license shall pay a fee of \$60 for the cost of submission of the applicant's fingerprints to the Kansas bureau of investigation for the purpose of obtaining a criminal history check conducted by the Kansas bureau of investigation and the federal bureau of investigation and for the commission's reasonable costs of administering the criminal history check program.

(2) Each licensee shall pay a fee of \$60, upon request of the commission, for the cost of submission of the licensee's fingerprints to the Kansas bureau of investigation for the purpose of obtaining a criminal history check conducted by the Kansas bureau of investigation and the federal bureau of investigation and for the commission's reasonable costs of administering the criminal history check program in connection with any investigation.

(d)(1)(A) For each original salesperson's license, the applicant shall pay a prorated fee that is calculated by multiplying \$5.00 by the number of months that remain in the applicant's two-year license cycle.

(B) For each original broker's license, the applicant shall pay a prorated fee that is calculated by multiplying \$7.00 by the number of months that remain in the applicant's two-year license cycle.

(2) The number of months that remain in the applicant's two-year license cycle shall be determined beginning with the month following the date on which the applicant's application is received by the commission through the applicable expiration month, as specified in K.A.R. 86-1-3.

(e) Each entity seeking course approval pursuant to K.S.A. 58-3046a, and amendments thereto, shall submit the following applicable fee or fees to the commission:

(1) For approval of a course of instruction submitted by a course provider pursuant to K.S.A. 58-3046a, and amendments thereto, a fee of \$50; and

(2) for renewal of an approved course of instruction pursuant to K.S.A. 58-3046a, and amendments thereto, a fee of \$15.

(f) Each licensee seeking approval of a course of instruction pursuant to K.S.A. 58-3046a(k), and amendments thereto, shall pay a fee of \$10 to the commission.

Article 2.—LOTTERY RETAILERS

111-2-318. Cosentino’s Price Chopper grocery give-a-way. (a) The term of this promotion shall be from 12:00 a.m. October 1, 2015, through 11:59 p.m. on October 31, 2015.

(b) During the term of this promotion with participating chain numbers 1436 and 1732 Cosentino’s Price Chopper stores in Kansas, for every Hot Lotto single ticket purchase of \$3 or more, the player shall receive an entry for the “Grocery Give-A-Way” promotion drawing. Lottery terminals shall automatically dispense an entry form for each \$3 or more Hot Lotto single ticket purchase at participating Cosentino’s Price Chopper Kansas lottery retailers during the term of this promotion. The qualifying Hot Lotto purchase may be for a single draw or for multiple draws.

(c) During the term of this promotion, drop boxes for the deposit of entries shall be provided by the lottery and placed at all participating Cosentino’s Price Chopper locations. All drop boxes shall be collected by store managers and brought to the Cosentino’s corporate office on the date of the drawing.

(d) After the term of this promotion has ended on October 31, 2015, one winning entry and two alternate entries shall be drawn by the Kansas lottery pursuant to standard lottery drawing procedures for each of the participating Price Chopper grocery store locations. If the winning entry does not qualify under the terms of this promotion or the winner is not able to be contacted, the prize shall be awarded to an alternate winner accordingly.

(e) The winner from each store location will win \$100 in groceries. The Kansas lottery will give each store a \$75 instant ticket credit. (j) The odds of winning a prize in this game are approximately one in 4.80. (Authorized by K.S.A. 2014 Supp. 74-8710; implementing K.S.A. 2014 Supp. 74-8710, and K.S.A. 74-8720, as amended by L. 2015, ch. 62 §23; effective, T-111-10-8-15, Sept. 9, 2015.)

Article 5.—MULTI-STATE ONLINE GAMES AND DRAWINGS

111-5-23. Definitions. The following definitions shall apply to the “Powerball” game:

(a) “Advertised grand prize” shall mean the estimated annuitized grand prize amount as determined by the MUSL central office by use of the MUSL annuity factor and communicated through the selling lotteries prior to the grand prize drawing. The “advertised grand prize” is not a guaranteed prize amount and the actual grand prize amount may vary from the advertised amount, except in circumstances where there is a guaranteed grand prize amount as described in these rules.

(b) “Computer pick” means the random selection of indicia by the computer, which appear on a ticket and are played by a player in the game.

(c) “Drawing” refers collectively to the formal draw event for randomly selecting the winning indicia which determine the number of winners for each prize level of the Powerball game and the Power Play multiplier. Winning indicia include the winning numbers for the Powerball game, and the Power Play multiplier.

(d) “Game board” or “boards” means that area of the play slip which contains sets of numbered circles to be marked by the player.

(e) “Game ticket” or “ticket” means an acceptable evidence of play, which is a ticket produced in a manner that meets the specifications defined in these rules and is a physical representation of the play or plays sold to the player.

(f) “Grand prize” refers to the top prize in the Powerball game.

(g) “Licensee lottery” shall mean a state lottery or lottery of a governmental unit, political subdivision, or en-

tity thereof that is not a party lottery but has agreed to comply with all applicable MUSL and product group requirements and has been authorized by the MUSL and by the Powerball product group to sell the Powerball game.

(h) "MUSL" means the Multi-State Lottery Association, a government-benefit association wholly owned and operated by the party lotteries.

(i) "MUSL annuity factor" shall mean the annuity factor as determined by the MUSL central office through a method approved by the MUSL finance and audit committee and which is used as described in these rules.

(j) "MUSL board" means the governing body of the MUSL which is comprised of the chief executive officer of each party lottery.

(k) "Online lottery game" means a lottery game connected by telephone lines, satellite or other similar communication methodology, owned or controlled by the lottery, to a central computer in which each player selects numbers out of a larger predetermined set or sets of numbers.

(l) "Party Lottery" or "Member Lottery" means a state lottery or lottery of a political subdivision or entity which has joined the MUSL and, in the context of these Powerball product group rules, that is authorized to sell the Powerball Game. Unless otherwise indicated, "party lottery" or "member lottery" does not include "licensee lotteries."

(m) "Play" or "bet" means the six numbers, the first five from a field of sixty-nine (69) numbers and the last one from a field of twenty-six (26) numbers, that appear on a ticket as a single lettered selection and are to be played by a player in the Powerball game.

(n) "Play slip" or "bet slip" means a card used in marking a player's game plays and containing one or more boards.

(o) "Power play" or "multiplier option" means the "Powerball" game option whereby a player may elect to pay an additional \$1 per play at the time of ticket purchase which will have the effect of multiplying any prize won on the play, except the grand prize.

(p) "Product group" means the group of lotteries which has joined together to offer a product pursuant to the terms of the multi-state lottery agreement and the product group's own rules.

(q) "Retailer" or "agent" means a person or entity authorized by the Kansas lottery to sell lottery plays.

(r) "Selling lottery" means a lottery authorized by the product group to sell Powerball plays, including party lotteries and licensee lotteries.

(s) "Set Prize," also referred to as "low-tier" prize, means all other prizes except the grand prize and, except in rare instances, outlined in these rules, will be equal to the prize amount established by the MUSL Board for the prize level.

(t) "Terminal" means a device authorized by a party lottery to function in an online, interactive mode with the gaming computer system for the purpose of issuing lottery tickets and entering, receiving and processing lottery transactions, including purchases, validating tickets and transmitting reports.

(u) "Validation" or "validate" means the process of determining whether a ticket presented for a prize is a winning ticket.

(v) "Winning numbers" means the indicia randomly selected during a drawing event which shall be used to determine winning plays for the Powerball game contained on a game ticket.

111-5-24. Game description; retail sale of tickets.

(a) "Powerball" is a five (5) out of sixty-nine (69) plus one (1) out of twenty-six (26) numbers lottery game, drawn every Wednesday and Saturday as part of the Powerball drawing event, which pays the grand prize, at the election of the player made in accordance with the rules or by a default election made in accordance with these rules, either on an annuitized pari-mutuel basis, or as a single lump sum payment of the total funding held in the grand prize pool for the winning drawing on a pari-mutuel basis. Except as provided in these rules, all other prizes are paid on a single payment basis. Powerball winning numbers applicable to determine Powerball prizes will be determined in the Powerball drawing event. The drawing procedures shall include procedures for randomly selecting the Powerball game winning numbers and the Power Play multiplier.

To play "Powerball" a player shall select (or computer pick) five different numbers from one (1) through sixty-nine (69) and one additional number from one (1) through twenty-six (26) for input into a terminal. The additional number may be the same as one of the first five numbers selected by the player.

(b) A "Powerball" play shall sell for two dollars.

(c) Plays shall not be sold to any person under the age of 18 years. Each retailer may require a person purchasing plays to produce proof of age.

(d) Each play shall be purchased from a terminal operated by a retailer. The player may select a set of five numbers and one additional number by:

(1) communicating the six numbers to the retailer;

(2) marking six numbered circles in any one game board on a play slip and submitting the play slip to the retailer; or

(3) requesting a "computer pick" or "quick pick" from the retailer. A player may choose the multiplier option by marking the appropriate box on the play slip or by communicating to the retailer the desire to play the multiplier option. If the multiplier option is chosen, it shall apply to all boards played on that play slip. For each board upon which the multiplier option is chosen, the player shall pay one additional dollar.

The retailer shall then issue a ticket from the terminal containing the selected set or sets of numbers, each of

which constitutes a game play, and if applicable, whether or not the multiplier option has been chosen for all plays on that play slip.

(e) A validated ticket shall be the only proof of a game play or plays. The only method of claiming a prize or prizes shall be the submission of the winning ticket to and receipt of the ticket by the lottery or its authorized agent. A play slip shall have no pecuniary or prize value and shall not be used as evidence of a play purchase or of numbers selected.

(f) A play may not be voided or cancelled by returning the ticket to the selling retailer, including tickets that are printed in error. The Kansas lottery has an approved method (defined in K.A.R. 111-2-4) of compensating retailers for plays that are not transferred to a player for reasons acceptable to the Kansas lottery. No play that is eligible for a prize can be returned to the Kansas lottery for credit. Plays accepted by retailers as returned plays and that cannot be re-sold shall be deemed owned by the bearer thereof unless the ticket has been signed.

(g) Ticket sales will end at approximately 8:59 p.m. central time (CT) on Wednesdays and Saturdays and will resume at approximately 9:05 p.m. central time (CT).

(h) Drawings will be conducted twice weekly, on Wednesdays and Saturdays at approximately 9:58 p.m. central time (CT), after the game is closed at approximately 8:59 p.m. central time (CT) and the draw official has verified that the game is closed, under conditions and procedures promulgated by the executive director of the lottery.

(i) Each player shall be responsible for verifying the accuracy of the game play or plays and other data printed on the ticket. The placing of plays is done at the player's own risk through the online retailer who is deemed to be acting on behalf of the player in entering the play or plays.

111-5-25. Prize pool; prize pool account, and prize reserve account. (a) The prize pool for all prize categories shall consist of 50.0% of each drawing period's sales, inclusive of tax, after the prize pool accounts and prize reserve accounts are funded to the amounts set by the product group. Any amount remaining in the prize pool at the end of this game shall be returned to all lotteries participating in the prize pool after the end of all claim periods of all selling lotteries, carried forward to a replacement game, or expended in a manner as directed by the members of the product group.

(b) Up to five percent (5%) of sales shall be deducted from a party lottery's grand prize pool contribution and placed in trust in one or more Powerball prize pool ac-

counts and prize reserve accounts held by the product group at any time that the prize pool accounts and the party lottery's share of the prize reserve account(s) is below the amounts designated by the product group.

The product group has established the following prize reserve accounts for the Powerball game: The prize reserve account, which is used to guarantee the payment of valid, but unanticipated, grand prize claims that may result from a system error or other reason, and the set prize reserve account, which is used to fund deficiencies in low-tier payments (subject to limitations of these rules).

The product group has established the following prize pool accounts for the Powerball game: the grand prize pool, which is used to fund the immediate grand prize; the Powerball set prize pool, which is used to fund the Powerball set prize payments; and the Powerball set-aside account, which is used to guarantee payment of the minimum or starting grand prize. The Power Play prize pool and Power Play pool account are described in these rules. The set prize pool holds the temporary balances that may result from having fewer than expected winners in the Powerball set prize (aka low-tier prize) categories and the source of the prize pool is the party lottery's weekly prize contributions less actual Powerball set prize liability. The source of the set-aside account funding shall be the prize reserve deduction until such time as the set-aside account is fully funded.

When the Powerball prize pool accounts and the party lottery's share of the Powerball prize reserve accounts exceed the designated amounts, the excess shall become part of the grand prize pool. The product group, with approval of the MUSL finance and audit committee, may establish a maximum balance for the Powerball prize pool accounts and prize reserve account(s).

The product group may determine to expend all or a portion of the funds in the Powerball prize pool accounts (except the grand prize pool account) and the prize reserve account(s) for the purpose of indemnifying the party lotteries and licensee lotteries in the payment of prizes to be made by the selling lotteries, subject to the approval of the MUSL board, and for the payment of prizes or special prizes in the game, subject to the approval of the MUSL finance and audit committee. The prize reserve shares of a party lottery may be adjusted with refunds to the party lottery from the prize reserve account(s) as may be needed to maintain the approved maximum balance and shares of the party lotteries.

A party lottery may contribute to its share of prize reserve accounts over time, but in the event of a draw down from the reserve account, a party lottery is responsible for its full percentage share of the account, whether or not it has been paid in full.

Any amount remaining in the Powerball prize reserve accounts or the prize pool account(s) at the end of this game shall be returned to all lotteries participating in the accounts after the end of all claim periods of all selling lotteries, carried forward to a replacement prize reserve account or prize pool account or expended in a manner as directed by the members of the product group in accordance with state law.

111-5-26. Expected prize payout pari-mutuel prizes. (a) The grand prize payout shall be determined on a pari-mutuel basis. Except as provided in these rules, all other prizes awarded shall be paid as set cash prizes with the following expected approximate prize payout percentages:

(b) The prize money allocated to the grand prize category shall be divided equally by the number of plays winning the grand prize.

(c) The Powerball set prize pool (for single payment prizes of \$1,000,000 or less) shall be carried forward to subsequent drawings if all or a portion of it is not needed to pay the Powerball set prizes awarded in the current drawing. If the total of the Powerball set prizes (as multiplied by the respective Power Play multiplier, if applicable) awarded in a drawing exceeds the percentage of the prize pool allocated to the Powerball set prizes, then the amount needed to fund the Powerball set prizes, including Power Play prizes, awarded shall be drawn from the following sources, in the following order: (1) the amount allocated to the Powerball set prizes and carried forward from previous drawings, if any; (2) an amount from the set prize reserve account, if available, not to exceed forty million dollars (\$40,000,000) per drawing, and (3) other amounts as agreed to by the product group in their sole discretion. If, after these sources are depleted, there are not sufficient funds to pay the set prizes awarded, including Power Play prizes, then the highest set prize shall become a pari-mutuel prize. If the amount of the highest set prize, when paid on a pari-mutuel basis, drops to or below the next highest set prize and there are still not sufficient funds to pay the remaining set prizes awarded, then the next highest set prize, including Power

Play prizes, shall become a pari-mutuel prize. This procedure shall continue down through all set prize levels, if necessary, until all set prize levels become pari-mutuel prize levels. In that instance, the money available from the funding sources listed in these rules shall be divided among the winning plays in proportion to their respective price percentages. Powerball set prizes and the Power Play prizes will be reduced by the same percentage. By agreement with the licensee lotteries, the licensee lotteries shall independently calculate their set pari-mutuel prize amounts. The party lotteries and the licensee lotteries shall then agree to set the pari-mutuel prize amounts for all lotteries selling the game at the lesser of the independently-calculated prize amounts.

111-5-28. Prize payments; annuitized and cash prizes. (a) Grand prizes shall be paid, at the election of the player made no later than 60 days after the player becomes entitled to a prize with either a per winner annuity or cash payment. If the payment election is not made at the time of purchase and is not made by the player within 60 days after the player becomes entitled

to the prize, then the prize shall be paid as an annuity prize. An election for an annuity payment made by a player before ticket purchase or by system default or design may be changed to a cash payment at the election of the player until the expiration of 60 days after the player becomes entitled to the prize. The election to take the cash payment may be made at the time of the prize claim or within 60 days after the player becomes entitled to the prize. An election made after the winner becomes entitled to the prize is final and cannot be revoked, withdrawn or otherwise changed. Shares of the grand prize shall be determined by dividing the cash available in the grand prize pool equally among all winning plays of the grand prize. Winner(s) who elected a cash payment shall be paid their share(s) in a single cash payment. The annuitized option prize shall be determined by multiplying a winner's share of the grand prize pool by the MUSL annuity factor. The MUSL annuity factor is determined through a process as approved by the MUSL finance and audit committee. Neither MUSL nor the party lotteries shall be responsible or liable for changes in the advertised or estimated annuity prize amount and the actual amount purchased after the prize payment method is actually known to MUSL. In certain instances announced by the product group, the grand prize shall be a guaranteed amount and shall be determined pursuant to subsection (f) of K.A.R. 111-5-28. If individual shares of the cash held to fund an annuity are less than \$250,000, the product group, in its sole discretion, may elect to pay the winners their share of the cash held in the grand prize pool of the annuity. All annuitized prizes shall be paid annually in 30 equal payments with the initial payment being made in cash, to be followed by 29 payments funded by the annuity. All annuitized prizes shall be paid annually in thirty (30) graduated payments (increasing each year) by a rate as determined by the product group. Prize payments may be rounded down to the nearest one-thousand dollars (\$1,000). Annual payments after the initial payment shall be made by the lottery on the anniversary date, or if such date falls on a non-business day, then on the first business day following the anniversary date of the selection of the grand prize winning numbers. Funds for the initial payment of an annuitized prize shall be made available by MUSL for payment by a party lottery by the fifteenth calendar day following the drawing or the next banking day if the fifteenth day is a non-business day. If necessary, when the due date for the payment of a prize occurs before the receipt of funds in the prize pool trust sufficient to pay the prize, the transfer of funds for the payment of the full lump sum cash option amount may be delayed pending receipt of funds from the selling lotteries. A state may elect to make the initial payment from its own funds after validation, with notice to MUSL. If a party lottery purchases or hold the prize payment annuity for a prize won in that jurisdiction, that party lottery's game rules, and any prize payment agreement with the prize winner, shall indicate that the prize winner has no recourse on the MUSL or any other party lottery for payment of that prize.

(b) In the event of the death of a lottery winner during the annuity payment period, the MUSL finance and audit committee, in its sole discretion excepting a discretionary

review by the product group, upon the petition of the estate of the lottery winner (the "estate") to the lottery and subject to federal, state, or applicable laws, may accelerate the payment of all of the remaining lottery proceeds to the estate. If such a determination is made, then securities and/or cash held to fund the deceased lottery winner's annuitized prize may be distributed to the estate. The identification of the securities to fund the annuitized prize shall be at the sole discretion of the product group.

(c) All prizes (whether described as "cash" payment prizes or otherwise) shall be paid through the selling lottery which sold the winning play(s) and at the discretion of the selling lottery that sold the winning play(s) may be paid by cash, check, warrant, or electronic transfer. A selling lottery may begin paying low-tier cash prizes after receiving authorization to pay from the MUSL central office. If a selling lottery, due to jurisdictional law requirements, separately determines its low-tier prize amounts, it shall be solely responsible for its low-tier prize liability, and may begin paying low-tier prizes after a drawing when it determines appropriate to do so.

(d) Annuitized payments of the grand prize or a share of the grand prize may be rounded to facilitate the purchase of an appropriate funding mechanism. Breakage on an annuitized grand prize win shall be added to the first cash payment to the winner or winners. Prizes other than the grand prize, which, under these rules, may become single-payment, pari-mutuel prizes, may be rounded down so that prizes can be paid in multiples of whole dollars. Breakage resulting from rounding these prizes shall be carried forward to the prize pool for the next drawing.

(e) If the grand prize is not won in a drawing, the prize money allocated for the grand prize shall roll over and be added to the grand prize pool for the following drawing.

(f) The product group may offer guaranteed minimum grand prize amounts or minimum increases in the grand prize amount between drawings or make other changes in the allocation of prize money where the product group finds that it would be in the best interest of the game. If a minimum grand prize amount or a minimum increase in the grand prize amount between drawings is offered by the product group, then the grand prize shares shall be determined as follows. If there are multiple grand prize winners during a single drawing, each selecting the annuitized option prize, then a winner's share of the guaranteed annuitized grand prize shall be determined by dividing the guaranteed annuitized grand prize by the number of winning plays. If there are multiple grand prize winners during a single drawing and at least one of the grand prize winners has elected the annuitized option prize, then the best bid submitted by MUSL's pre-approved qualified brokers shall determine the cash pool needed to fund the guaranteed annuitized grand prize. If no winner of the grand prize during a single drawing has elected the annuitized option prize, then the amount of cash in the grand prize pool shall be an amount equal to the guaranteed annuitized amount divided by the MUSL annuity factor. Changes in the allocation of prize money

shall be designed to retain approximately the same prize allocation percentages, over a year's time, set out in these rules. Minimum guaranteed prizes or increases may be waived if the alternate funding mechanism set out in K.A.R. 111-5-26 becomes necessary. Approval of the product group is required to change the guaranteed minimum grand prize amounts or minimum increases in the grand prize amount. Any reduction in the guaranteed minimum grand prize amount or reduction in the minimum increases to the grand prize amount shall not become effective until after a grand prize win following the action taken by the product group.

(g) The holder of a winning play may win only one prize per play in connection with the winning numbers drawn, and shall be entitled only to the prize won by those numbers in the highest matching prize category.

(h) All prizes must be claimed within 365 days of the day of the drawing in which the prize was won.

111-5-29. Ticket validation requirements. To be a valid play and eligible to receive a prize, a ticket upon which the play appears shall satisfy all the requirements established by the Kansas lottery and MUSL (in accordance with K.S.A. 74-8731) for validation of winning plays sold through its online gaming system. The MUSL and the Kansas lottery shall not be responsible for tickets which are altered in any manner. (Authorized by and implementing K.S.A. 2015 Supp. 74-8710; effective, T-111-3-5-92, Feb. 21, 1992; amended, T-111-6-27-96, June 21, 1996; amended, T-111-10-8-15, Sept. 9, 2015.)

111-5-31. Ticket responsibility. (a) Prize claim procedures shall be governed by the rules of the Kansas lottery. The MUSL and the Kansas lottery shall not be responsible for prizes that are not claimed following the proper procedures as determined by the Kansas lottery.

(b) Until such time as a signature, mark or name is placed on the back of a ticket in the area designated for a signature, mark or name, a ticket shall be owned by the holder of the ticket. When a signature, mark or name is placed on a ticket in the place designated, the person whose signature, mark or name appears in that area shall be the owner of the ticket and shall be entitled to any prize attributable thereto.

(c) If the signature of more than one person appears on the back of the ticket in the designated place, the lottery shall make payment to the person presenting the ticket whose signature appears on both the ticket and the winner claim form. If all persons whose signatures appear in the appropriate space cannot identify one person to whom payment should be made, the lottery shall keep

the prize until a determination of entitlement is made by the parties. In no event shall more than one person be entitled to a particular prize.

(d) It shall be the sole responsibility of the player to verify the accuracy of the game play or plays and other data printed on the ticket. The placing of plays is done at the player's own risk through the online agent who is acting on behalf of the player in entering the play or plays.

(e) The product group, the MUSL and Kansas lottery shall not be responsible for lost, damaged, destroyed, misprinted, or stolen tickets, or tickets printed based on faulty information. 111-5-33. Multi-Draw. (a) In addition to a single play for each \$2.00, a player may also have his or her selections entered in multiple drawings. Multi-draw tickets must be purchased for consecutive drawings beginning with the next drawing. This is done by marking one of the multi-draw boxes designated by 2, 3, 4, 5, 10, or 15 on the play slip. The additional draw period(s) for which the ticket is valid will then appear on the computer generated ticket given to the player by the retailer.

(b) A player must pay an additional \$2.00 per play for each additional drawing in which he or she wishes to play

(c) Unless one of the multi-draw boxes is marked and the additional amount paid, the play will only be eligible for the current drawing up to 8:59 p.m. the day of the drawing.

(d) A player may purchase only the same numbers on the same boards for multiple drawings.

(e) Multi-draw tickets for Powerball drawings conducted after the October 7, 2015, business day shall not be available for purchase prior to the business day beginning October 4, 2015.

(f) A business day for the purposes of this game shall be defined at subsection (p) of K.A.R. 111-6-1.

(g) These amendments shall take effect October 4, 2015. (Authorized by and implementing K.S.A. 2015 Supp. 74-8710; effective, T-111-3-5-92, Feb. 21, 1992; amended, T-111-8-11-97, July 18, 1997; amended, T-111-10-27-97, Sept. 12, 1997; amended, T-111-10-15-02, Sept. 13, 2002; amended, T-111-2-20-09, Dec. 11, 2008; amended, T-111-2-9-12, Nov. 16, 2011; amended, T-111-10-8-15, Sept. 9, 2015.)

111-5-200. Powerball Power Play promotion. (a) The Kansas Lottery shall offer players the opportunity to participate in the Powerball Power Play promotion, with changes effective in these rules beginning October 4, 2015. The Power Play promotion shall offer a Powerball player a chance to increase the amount of any of the eight lump sum set prizes (the lump sum prizes normally paying \$4 to \$1,000,000) won in a drawing held during the promotion. The grand prize jackpot is not a set prize and will not be increased.

(b) A qualifying play is any single Powerball play for which the player pays an extra one dollar for the Power Play option play and which is recorded in the Kansas Lottery's central computer as a qualifying play.

(c) Except as provided in these rules, a qualifying play which wins one of the seven lowest lump sum set prizes (excluding the match 5+0 prize) will be multiplied by the number selected, either two, three, four, five, or sometimes 10 (2, 3, 4, 5, or sometimes 10), in a separate random Power Play drawing announced during the official Powerball drawing show. The ten (10X) multiplier will be available for drawings in which the initially advertised annuitized grand prize amount is one hundred fifty million dollars (\$150,000,000.00) or less. Each announced match 5+0 prize, for players selecting the Power Play option, shall be \$2,000,000 (two million dollars) unless a higher limited promotional dollar amount is announced by the group.

(d) The multi-state lottery association will conduct a separate random Power Play drawing and announce results during each of the regular Powerball drawings held during the promotion. During each Powerball drawing, a single number (2, 3, 4, 5, and sometimes 10) shall be drawn. The ten (10X) multiplier shall be available for all drawings in which the advertised grand prize amount is one hundred fifty million dollars (\$150,000,000.00) or less. The Powerball group may modify the multiplier features for special promotions from time to time.

(e) In drawings where the 10 (10X) multiplier is available, the expected payout for all prize categories shall consist of up to forty-nine and nine hundred sixty-nine thousandths percent (49.969%) of each drawing period's sales, including any specific statutorily mandated tax of a selling lottery to be included in the price of a lottery ticket. In drawings where the "ten (10)" multiplier is not available, the expected payout for all prize categories shall consist of up to forty-five and nine hundred thirty-four thousandths percent (45.934%) of each drawing period's sales, including any specific statutorily mandated tax of a selling lottery to be included in the price of a lottery ticket. The prize payout percentage per draw may vary. The Power Play prize pool shall be carried forward to subsequent draws if all or a portion of it is not needed to pay the Power Play prizes awarded in the current draw and held in the Power Play pool account.

(f) In drawings where the "ten (10)" multiplier is available, an additional thirty-one thousandths percent (0.031%) of sales, including any specific statutorily mandated tax of a selling lottery to be included in the price of a lottery ticket, may be collected and placed in trust in the Power Play pool account, for the purpose of paying Power Play prizes. In drawings where the "ten (10)" multiplier is not available, four and sixty-six thousandths percent (4.066%) of sales, including any specific statutorily mandated tax to be included in the price of a lottery ticket, may be collected and placed in trust in the Power Play pool account for the purpose of paying Power Play prizes. Any amount remaining in the Power Play pool account when the product group declares the end of this game shall be returned to all lotteries participating in the account after the end of all claim periods of all selling lotteries, carried forward to a replacement game, or ex-

pected in a manner as directed by the members of the product group and in accordance with Kansas law.

(g) The expected prize payout for Power Play prizes is as follows:

In certain instances the Powerball set prize amount may be less than the amount shown as otherwise provided in these rules. In such case, the eight (8) lowest Power Play prizes will be changed to an amount announced after the draw.

(h) The following table sets forth the probability of the various Power Play numbers being drawn during a single Powerball drawing, except that the Power Play amount for the Match 5+0 prize will be \$2,000,000 (two million dollars). The Powerball group may elect to run limited promotions that may modify the multiplier features.

Power Play does not apply to the grand prize. Except as provided in these rules, a Power Play match 5 prize is set at \$2,000,000 (two million dollars), regardless of the multiplier selected.

(i) The Prize pool percentage allocated to the Power Play set prizes shall be carried forward to subsequent draws if all or a portion of it is not needed to pay the set prizes awarded in the current draw. Except as provided in these rules, if the total of the original Powerball set prizes and the Power Play prizes awarded in a drawing exceeds the percentage of the prize pools allocated to the set prizes, then the amount needed to fund the set prizes (including the Power Play prize amounts) awarded shall be drawn from the following sources in the following order:

- (1) the amount allocated to the set prizes and carried forward from previous draws, if any;
- (2) an amount from the Powerball set prize reserve account, if available in the account, not to exceed \$40,000,000 (forty million dollars) per drawing; and
- (3) other amounts as agreed to by the product group in its sole discretion.

(continued)

If, after these sources are depleted, there are not sufficient funds to pay the set prizes awarded (including Power Play prize amounts), then the highest set prize (including the Power Play prize amounts) shall become a pari-mutuel prize. If the amount of the highest set prize, when paid on a pari-mutuel basis, drops to or below the next highest set prize and there are still not sufficient funds to pay the remaining set prizes awarded, then the next highest set prize, including the Power Play prize amount, shall become a pari-mutuel prize. This procedure shall continue down through all set prize levels, if necessary, until all set prize levels become pari-mutuel prize levels. In that instance, the money available from the funding sources listed in this rule shall be divided among the winning plays in proportion to their respective prize percentages. Powerball and Power Play prizes will be reduced by the same percentage.

(j) All Power Play prizes shall be paid in one lump sum. The lottery will begin paying Power Play prizes after receiving authorization to pay from the MUSL central office.

(k) Prizes that, under these rules, may become pari-mutuel prizes, may be rounded down so that prizes can be paid in whole dollars. Breakage resulting from rounding these prizes shall be carried forward to the prize pool for the next drawing.
