The work consists of the following:

The project consists of the reconstruction of 143rd Street to a wide two-lane arterial from Pflumm Road to Quivira Road. The improvements will consist of reconstruction of 143rd Street to a 46' back of curb to back of curb (B-B) section with a 10' trail on the north side and a 5' sidewalk on the south side from the east curb returns of the Pflumm Road intersection to the west curb returns of the Quivira Road intersection. This does include mill and overlay of the

existing divided 400' section just east of the Pflumm Road intersection and the existing divided 200' section west of the Quivira Road intersection. Also included is an eastbound right turn lane on 143rd Street at the Quivira Road intersection. Additional intersection improvements at Pflumm Road include widening 143rd Street from the west curb returns of the Pflumm Road intersection west approximately 500 feet to accommodate an additional eastbound left turn lane. Also included is widening Pflumm Road from the south curb returns of the intersection south approximately 500 feet to allow for an additional northbound through lane. Additional intersection improvements at Quivira Road include widening Quivira Road from the south curb returns of the intersection south approximately 750 feet to allow for an additional northbound through lane and an additional southbound receiving lane. This project will also include the installation of a traffic signal at 143rd Street and Pflumm Road, modifications to the signal at 143rd Street and Quivira Road, new street lighting, and an enclosed storm sewer system. This is a joint project between the cities of Olathe and Overland Park. The city of Olathe will administer the project with cooperation, communication, and input from the city of Overland Park.

Proposed CDBG program changes listed below will be discussed at the public hearing:

Amending 2017 Program Year

- Amend the KAN STEP program by eliminating the 2nd funding round dated August 15, 2017.

2018 Proposed CDBG Changes

- Eliminate the KAN STEP program as an eligible activity funded by the CDBG program.
- Accept Commercial Rehabilitation applications on a year round basis.
- The CDBG program proposes to fund only two phases of any particular project.
- Eliminate the 2nd Kansas Inter Agency Committee (KIAC) Meeting date in August for water and sewer projects.
- Three or more errors or omissions found in any CDBG application will automatically be thresholded and not rated.
- Community Facilities and Water/Sewer project funding limits are proposed to be as follows:
 - Projects with less than 1,500 beneficiaries may apply for \$2,000 per beneficiary up to \$500,000.
 - Projects with less than 10,000 beneficiaries may apply up to \$700,000.
 - Projects with beneficiaries greater 10,000 may apply up to \$800,000.
 - A minimum of 25% match will be required for all grants.
- Housing changes:
 - Currently: Housing Quality Standards (HQS) Inspections are limited to \$800 in CDBG funds.
 - Proposed Change: HQS Inspections will also require a Radon Inspection and are limited to \$1,000 in CDBG funds.
 - Currently: Lead Safe Work Practices (LSWP) is limited to 10 percent of the rehabilitation contract.
 - Proposed Change: LSWP is limited to 10 percent of the CDBG rehabilitation cost.

Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding a proposed air quality operating permit. Hess

Services, Inc. has applied for a Class I operating permit in accordance with the provisions of K.A.R. 28-19-510 et al. The purpose of a Class I permit is to identify the sources and types of regulated air pollutants emitted from the facility; the emission limitations, standards and requirements applicable to each source; and the monitoring, record keeping and reporting requirements applicable to each source as of the effective date of permit issuance.

Hess Services, Inc., P.O. Box 843, Hays, KS 67601, owns and operates a fiberglass and steel tank manufacturing facility in addition to a wet-batch concrete plant located at 1789 230th Ave., Hays, KS 67601.

A copy of the proposed permit, permit application, all supporting documentation, and all information relied upon during the permit application review process are available for public review, during normal business hours, at the KDHE, Bureau of Air (BOA), 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366 and at the Northwest District Office (NWDO), 2301 E. 13th St., Hays, KS 67601. To obtain or review the proposed permit and supporting documentation, contact Rasha Allen, 785-296-1693 at the (KDHE) central office or Larissa Parker, 785-625-5663, at the NWDO. The standard departmental cost will be assessed for any copies requested.

Written comments or questions regarding the proposed permit may be directed to Rasha Allen, KDHE, BOA, 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366. In order to be considered in formulating a final permit decision, written comments must be received no later than noon Monday, March 6, 2017.

A person may request a public hearing be held on the proposed permit. The request for a public hearing shall be in writing and set forth the basis for the request. The written request must be submitted to Rasha Allen, KDHE, BOA, 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366, no later than noon Monday, March 6, 2017, in order for the Secretary of Health and Environment to consider the request.

The U.S. Environmental Protection Agency has a 45-day review period, which will start concurrently with the public comment period, within which to object to the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the EPA to review the permit. The 60-day public petition period will directly follow the EPA's 45-day review period. Interested parties may contact KDHE to determine if the EPA's 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. Both regulations are being amended to reflect a change in their approved medication list allowing for the administration of naloxone by both provider levels. There are also changes in K.A.R. 109-3-4 to reflect changes in statutory language that went into effect on July 1, 2016.

There is no anticipated economic impact to any governmental agency or unit or to the general public in the adoption of these revised regulations.

Opinion No. 2017-01

Written January 25, 2017, to all interested persons.

Synopsis: For purposes of K.S.A. 25-4153a, a campaign contribution from a revocable living trust is treated as if made directly by the grantor when contributed during the life of the grantor.

Cited herein: K.S.A. 2015 Supp. 25-4153a.

To all interested persons:

Pursuant to K.S.A. 25-4159, the Kansas Governmental Ethics Commission issues this opinion regarding campaign contributions to legislators, candidates for the legislature, statewide elected officers or candidates for statewide office, and recognized political committees for the senate or house of representatives, made subsequent to January 1, through adjournment, sine die, or any other time the legislature is in session.

Factual Statement

Commonly called an inter vivos trust or living trust, one may be set up by an individual during his or her life for a variety of legal, tax, or estate planning reasons. Such trusts, when revocable, allow the grantor to retain complete control over trust assets. Trust assets are used by the grantor as if their own. Trust income is reported under the grantor's social security number, not a distinct tax identification number assigned to the trust.

Analysis and Opinion

Because the grantor can amend or revoke a revocable trust and the grantor's initial transfer of assets does not alienate those assets from the grantor's control, courts have held the assets are treated as if owned by the grantor for tax liability purposes. See Harry G. McNeely v. U.S., 16 F.3d 303 (8th Cir. 1994), and Estate of Kisling v. Commissioner, 32 F3rd 1222 (8th Cir. 1994). These holdings are now law, as codified by The 1997 Taxpayer Relief Act. We adopt this position expressed by the courts and tax code that disbursements from revocable living trusts during the grantor's life are considered as if made by the grantor.

Conclusion

We opine a campaign contribution to a legislator, candidate for the legislature, statewide elected officer or candidate for statewide office or a recognized political committee for the senate or house of representatives may be accepted from a revocable living trust as if the contribution was made by an individual if the trust grantor is living when the contribution is made.

Opinion No. 2017-02

Written January 25, 2017, to Chiquita Coggs, Executive Director, Kansas Board of Cosmetology, 714 SW Jackson St., Suite #100, Topeka, KS 66603.

Synopsis: employees of the Kansas Board of Cosmetology may accept a gifted treadmill on behalf of the state. If any giver is licensed, inspected, or regulated by the Board of Cosmetology, then the gift, or the giver's portion of the gift, may not be valued at more than \$40 in aggregate with any other gift to the Board of Cosmetology during a calendar year.

Dear Ms. Coggs:

We understand that, in your capacity as executive director for the Kansas Board of Cosmetology (Cosmetology), you request our opinion concerning application of the state governmental ethics law, K.S.A. 46-215 *et seq.* Our response to your request is limited to its applicability. This opinion does not address whether some other statutory system, common law theory, or agency rule or regulation applies to your inquiry.

Factual Statement

Agency staff is considering converting existing space into an employee lounge that would include exercise equipment for use by employees of the agency during breaks. The lounge would be dedicated to a longtime Cosmetology employee who was recently killed in an automobile accident. Staff is considering the purchase of a treadmill for the lounge with agency funds. A group of schools (predominantly private) that worked with and appreciated the late Cosmetology employee have asked if they could give a treadmill.

Question

Does the acceptance of a treadmill by the Cosmetology employees, to be given by the schools, violate the state level conflict of interest laws?

Analysis and Opinion

K.S.A. 2015 Supp. 46-237a states in pertinent part:

"(a) The provisions of this section shall apply to:

....

(4) all officers and employees of the executive branch of state government...

(b) No person subject to the provisions of this section shall solicit or accept any gift, economic opportunity, loan, gratuity, special discount or service provided because of such person's official position, except:

....

(3) anything of value received by the person on behalf of the state that inures to the benefit of the state or that becomes the property of the state."

K.A.R. 19-40-3a defines the term "gift" as follows:

"(b) 'Gift' means the transfer of money or anything of value unless legal consideration of a reasonably equal or greater value is received in return."

Since the Cosmetology employees are subject to K.S.A. 2015 Supp. 46-237a and the treadmill is a thing of value

for which the employees have not given any consideration in return for their receipt, the treadmill would be considered a gift pursuant to K.S.A. 2015 Supp. 46-237a. However, if the treadmill was received by the Cosmetology employees on behalf of the state and it inures to the benefit of the state, or becomes the property of the state, acceptance would not be in violation of the statute.

The request for this opinion does not indicate whether the schools offering to give the treadmill are licensed, inspected or regulated by Cosmetology. If so then each schools' pro rata portion of the gifted treadmill is subject to the \$40 limitation set forth in K.S.A. 46-237(c):

"[n]o person licensed, inspected or regulated by a state agency shall offer, pay, give or make any special economic opportunity, gift, loan, gratuity, special discount, favor, hospitality or service having an aggregate value of \$40 or more in any calendar year to such agency or any state officer or employee..."

Conclusion

The Cosmetology employees could not accept the treadmill on their own behalf. Cosmetology employees may accept the treadmill from the schools on behalf of the state without violating the state level conflict of interest laws. If a donating school is licensed, inspected, or regulated by Cosmetology, that school's pro rata share of the treadmill's cost must be less than \$40 in aggregate with any other gift to Cosmetology within any calendar year.

Opinion No. 2017-03

Synopsis: If a donor, or person to be solicited for a donation, does not have a special interest and the Office of the Governor does not license, inspect, or regulate the donor or person to be solicited, then a state employee in the Governor's office may solicit and accept financial donations for the Governor's Weight Loss Challenge when an exception of the general prohibitions of K.S.A. 2016 Supp. 46-237a applies.

Dear Mrs. Borchers:

We understand that you have requested this opinion in your capacity as Deputy Chief of Staff for the Office of the Governor. This opinion is in response to your request to the Kansas Governmental Ethics Commission (Commission), concerning application of the state governmental ethics law, K.S.A. 46-215 *et seq.* We note at the outset that the Commission's jurisdiction is limited to the applicability of K.S.A. 46-215 *et seq.*, and the Commission's opinion does not address whether some other statutory system, common law theory, or agency rule or regulation applies to your inquiry.

Factual Statement

The State of Kansas is in the process of launching an initiative that encourages a healthy lifestyle challenge for

state employees. Part of that initiative will involve a Governor's Weight Loss Challenge. As in the past, the state plans on awarding cash incentives for any state employee who chooses to participate and meets the criteria as laid out in the challenge. All funds collected will be directed to the Kansas Department of Administration and paid out from this agency. The program will be administered through the staff of the Kansas Department of Health and Environment. The prize money will be distributed as cash pay-outs and as gift certificates.

Question

May a state employee in the Office of the Governor solicit and accept financial donations for the Governor's Weight Loss Challenge from vendors of the state and other businesses and not violate the general prohibition to solicit and accept under K.S.A. 2016 Supp. 46-237a?

Analysis and Opinion

A gift, economic opportunity, loan, gratuity, special discount or service received by a state employee is not prohibited by the state governmental ethics laws unless it is because of the official position of the state employee. K.S.A. 2016 Supp. 46-237a(b). "'Gift' means the transfer of money or anything of value unless legal consideration of a reasonably equal or greater value is received in return." K.A.R. 19-40-3a(b). "'Economic opportunity' means any purchase, sale, lease, contract, option, or other transaction or arrangement involving property or services wherein a state [...] employee [...] may gain a personal economic benefit, but not including any gift." K.S.A. 46-217.

In Governmental Ethics Opinion 1999-50, the Commission determined that:

the term "official position" refers to an individual's particular position with the state and does not apply generally to a person because they are a state employee. For guidance, the Commission notes that a gift or discount which is provided to all state employees is not being provided to a person because of his or her "official position." On the other hand, a gift or discount which is provided to all purchasing agents, for example, or all employees of a particular agency, will be deemed to be provided because of such persons' "official position".

Applying this meaning of "official position" to the facts presented, the solicitation or acceptance by a state employee for financial donations to be used for the Governor's Weight Loss Challenge is within the employee's official position. Such solicitation or acceptance is prohibited *unless* one or more exceptions listed in subparagraphs (1)-(4) of K.S.A. 2016 Supp. 46-237a(b) applies. The following circumstances allow a state employee to solicit or accept gifts or economic opportunities in their official position:

1. A gift having an aggregate value of less than \$40 given at a ceremony or public function where the person is accepting the gift in such person's official capacity; or
2. Gifts from relatives or gifts from personal friends when it is obvious to the person that the gift is not

being given because of the person's official position; or

3. Anything of value received by the person on behalf of the state that inures to the benefit of the state or that becomes the property of the state; or
4. Contributions solicited on behalf of a nonprofit organization which is exempt from taxation under paragraph (3) of subsection (c) of section 501 of the internal revenue code of 1986, as amended.

Subparagraph (3) is directly applicable. The financial donations solicited or accepted for the Governor's Weight Loss Challenge inures to the benefit of the state because the state would have to otherwise pay for these cash incentives for state employees. Thus, an employee of the Office of the Governor may solicit and accept such financial donations for the challenge.

Finally, an employee of the Officer of the Governor must consider whether a donor has a *special interest*. A *special interest* exists if a donor is affected individually, distinct from the people of the state as a whole, in a matter pending before the legislature or state agency, officer or employee. K.S.A. 46-228. If a donor has a special interest *and* a donation is made under circumstances where such officer or employee knows or should know that a major purpose of the donor in granting the same could be to influence the performance of their official duties, the donation may not be accepted. K.S.A. 46-236.
