Background and Purpose of Project

The Kansas Department of Transportation (KDOT) is seeking four (4) consulting engineering firm(s) pre-qualified in category 231-Traffic Control Analysis and Design to provide services for the project as listed below.

Scope of Services to be Performed

The Bureau of Local Projects has a Traffic Engineering Assistance Program (TEAP). This program enables the Kansas Department of Transportation to utilize federal funds to assist local political subdivisions in solving traffic engineering operational and safety improvements when they do not have the traffic engineering expertise available.

The consultant(s) selected are to provide traffic engineering services during Federal Fiscal Years 2019 thru 2023 throughout the state. The development of detailed plans, designs, specifications, or estimates will not be approved under this program.

The following is a list of possible areas where the consultant may be called upon to do work. Work will not be limited to these categories and will depend upon the nature of a project and its impact on traffic safety.

Traffic accident analysis; traffic counts; speed surveys; minor traffic generation studies; limited transit analysis; parking problems; capacity analysis; lighting and visibility analysis; traffic signal progression and delay problems; intersection related safety problems; alignment problems; sight distance difficulties; railroad crossings; Central Business District (CBD) circulation studies; pavement marking analysis; high accident area analysis; school signing and markings; signal needs studies; major street operational analysis; and CBD operations, parking, or capacity analysis.

Instructions for Proposal

No costs shall be contained in the proposal. The proposal must not exceed six (6) pages total (including any cover letter, index, etc.) and 2MB to address the pertinent topics. Proposals submitted will consist of the proposal and a completed and signed Special Attachment No. 7 ("Certificate of Final Indirect Costs"), a completed and signed Special Attachment No. 8 ("Tax Clearance Certificate"), and Special Attachment No. 10 ("Policy Regarding Sexual Harassment"). Completed Special Attachments do not count against the page limitation. All these forms are attached to the original email announcement. The proposal shall indicate the consultant's ability to meet the needs described above. The proposal shall describe any processes or procedures, including best practices, that will be used to perform tasks and to produce the desired results described above under "Scope of Services."

Evaluation Factors

Proposals will be evaluated based on the factors listed below, evenly weighted, to select the most qualified firms.

1. Number of traffic engineers and their professional qualifications.
2. Experience of staff with small traffic studies and small traffic projects.
3. Firms ability to take on additional quickly.
4. Firm's performance record.
5. Firm's history working with smaller cities.

The firms accounting systems must have the following capabilities before the firm may be awarded a contract.

- Valid, reliable, and current costs must be available within the system to support cost and pricing data.
- Capability to provide a means of measuring the reasonableness of incurred costs.
- Capability to identify and accumulate allowable costs by contract or project records which will reconcile with the general ledger.
- Ability to provide supporting documentation of actual expenditures for each billing, based on costs.

The highest ranked four (4) firm(s) will be asked to enter into an on-call agreement with KDOT. Firms not selected will be notified.

Governor’s Grants Program

Notice of Available Grant Funding from the Federal Edward Byrne Memorial Justice Assistance Grant

The Kansas Criminal Justice Coordinating Council (KCJCC) establishes the guidelines for the Federal Edward Byrne Memorial Justice Assistance Grant (JAG). The JAG program is authorized by federal law 34 U.S.C. §10151-10158. The KCJCC and the federal JAG program guidelines establish eligibility criteria that must be met by all organizations that receive JAG funds. Grant funds may be awarded to units of state and local government, Native American Tribes, and non-profit, community, and faith-based organizations. The primary use of JAG is to support the following purpose areas: (1) law enforcement programs, (2) prosecution and court programs, (3) prevention and education programs, (4) corrections and community corrections programs, (5) drug treatment and enforcement programs, (6) planning, evaluation, and technology improvement programs, (7) crime victim and witness programs, and (8) mental health and related law enforcement and corrections programs. Grant funds must be requested within one or more of the seven purpose areas. Grant funds are available for the funding period of October 1, 2018, through September 30, 2019. This grant is competitive and there is a yearly application process with no guarantee of continued funding. *This grant opportunity is subject to funding from the United States Department of Justice and may be reduced or rescinded based on guidance*

or interpretation of grant terms and conditions made by the federal government, including but not limited to applicants’ compliance with 8 U.S.C. § 1373.

In distributing grant funds, priority will be given to applications that clearly support the objectives of the current Kansas Statewide Strategic Plan and to local government applicants who are not eligible to apply directly to the Federal Bureau of Justice Assistance for JAG funding. The Kansas Power Pool (KPP), a Municipal Energy Agency (the “KPP”), on behalf of itself and its member cities listed below (the “Participating Members”), hereby gives notice of its intent to file with the Federal Energy Regulatory Commission (“FERC”) requesting approval of a proposed Rules for Compliance (the “Plan”) to jointly implement their respective obligations under Section 210 of the Public Utility Regulatory Policies Act of 1978 (16 U.S.C. § 824a-3) (“PURPA”) and under Part 292 of the FERC’s Regulations. The Plan provides that (1) the Participating Members will interconnect with any Qualifying Facility (“QF”) that appropriately requests interconnection with their respective electric distribution systems in accordance with PURPA, (2) the KPP will purchase the energy and capacity offered by the interconnected QFs at rates that comply with the requirements of PURPA, and (3) the Participating Members will supply interconnected QFs with backup and supplementary power at rates that comply with PURPA. In the filing with FERC, the KPP, on behalf of itself and the Participating Members, plans to apply for waiver of certain obligations under Section 292.303 of FERC’s Regulations which, if granted, would result in all purchases from QFs being made by the KPP and all sales to QFs interconnected with the Participating Member electric distribution systems being made by the Participating Members.

Copies of the proposed Plan will be sent to interested parties upon request. The KPP will also accept written comments on the proposed Plan. The KPP intends to file for approval of the Plan with FERC on or after September

The proposed facility would consist of two enclosed confinement buildings, an animal mortality compost building, and a concrete waste storage tank. The facility would be located in the North Half of Section 17, Township 24 South, Range 4 East in Butler County, Kansas. A notice in the Kansas Register dated July 12, 2018, informed the public of the availability of the proposed water pollution control permit for Henry Creek Sow Farm – Doug Claassen. A public hearing has been scheduled in conformance with Kansas Administrative Regulation 28-16-61.

A public hearing on the proposed permit has been scheduled at 5:30 pm (CST) Tuesday, October 2, 2018, at the Potwin Community House, 201 N. Miller, Potwin, Kansas.

Opinion No. 2018-04

Written August 22, 2018 to all interested persons.

Synopsis: If childcare expenses would not exist irrespective of the candidacy for public office, and those expenses have a direct connection with or effect upon the campaign of the candidate, then they may be paid with campaign funds.

Cited herein: K.S.A. 2017 Supp. 25-4157a, 52 U.S.C. § 30114(a), (b); 11 C.F.R. §§ 113.1, 113.2.

To All Interested Persons,

Pursuant to K.S.A. 25-4159, the Kansas Governmental Ethics Commission issues this opinion regarding expenditure of campaign funds for childcare expenses.

Issue

In general, candidates subject to the requirements of the Kansas Campaign Finance Act may have personal situations affected by a campaign. Paid childcare may be a necessary accommodation for campaigning candidates and officeholders. May campaign funds be used to pay for childcare?

Analysis and Opinion

Permitted use of campaign funds is provided in K.S.A. 25-4157a(a) which provides:

No moneys received by any candidate or candidate committee of any candidate as a contribution under this act shall be used or be made available for the personal use of the candidate and no such moneys shall be used by such candidate or the candidate committee of such candidate except for legitimate campaign purposes, for expenses of holding political office or for contributions to the party committees of the political party of which such candidate is a member.

...

For the purposes of this section, expenditures for "personal use" shall include expenditures to defray normal living expenses for the candidate or the candidate's family and expenditures for the personal benefit of the candidate having no direct connection with or effect upon the campaign of the candidate or the holding of public office.

In Opinion No. 96-16, we stated:

To be a permissible use of campaign funds, an expenditure must be for a legitimate purpose, an expense of holding political office or a contribution to a party committee. *In order to be a "legitimate campaign purpose or an expense of holding political office", the expenditure must have a "direct connection with or effect upon the campaign of the candidate or the holding of public office".* All other expenditures are for personal use, and thus are prohibited. [emphasis added]

In the same opinion we provided non-exhaustive lists of permissible and non-permissible uses of campaign

funds. For uses of campaign funds not listed, we determine, on a case-by-case basis, whether a use is permitted.

The Federal Election Commission (FEC) recently considered the same issue. In FEC Advisory Opinion 2018-06, dated May 10, 2018, a Congressional candidate, prior to becoming a candidate, worked at home as a consultant while caring for her young children full time. Her husband worked full time. Since becoming a candidate, she has forgone income from her work and hired a part-time care-giver for her children so that she could fulfill responsibilities as a federal candidate. The candidate anticipates full-time care for her children as well as additional childcare support on evenings and weekends will be necessary so that she can devote the time necessary to run her campaign.

The relevant federal law is similar to Kansas law in that expenditures of campaign funds must be for (1) a listed permissible use, or a use determined to be permissible on a case-by-case basis, and (2) specific purposes, including “ordinary and necessary expenses incurred in connection with duties of the individual as a holder of [f]ederal office,” and “any other lawful purpose” (i.e., not a personal use). See 52 U.S.C. § 30114(a), (b); 11 C.F.R. §§ 113.1, 113.2. “Personal use” is use of campaign funds “to fulfill any commitment, obligation, or expense of a person that would exist irrespective of the candidate’s election campaign or duties as a federal office holder.” 52 U.S.C. §30114(b)(2); 11 C.F.R. § 113.1(g). The FEC concluded that the described childcare expenses, to the extent such expenses are incurred as a direct result of campaign activity, would not exist irrespective of the election campaign, and thus may be paid with campaign funds.

To highlight this key distinction drawn in the FEC opinion, which we view as an important consideration when interpreting whether a direct connection with, or effect upon the campaign exists under K.S.A. 25-4157a(a), we provide this example: if a candidate typically pays for childcare before becoming a candidate, this would not be a permissible expense for use of campaign funds after becoming a candidate. However, if additional childcare is needed because of the new campaign’s demands upon the candidate, the increase in expenses would be a permissible use of campaign funds, but not those existing prior to becoming a candidate.

Expenditures to defray normal living expenses for the candidate or the candidate’s family are personal. So are expenditures for personal benefit having no direct connection with or effect upon the campaign of the candidate or holding of public office. However, if childcare expenses would not exist irrespective of the candidacy for public office, then such expenses would have a direct connection with or effect upon the campaign of the candidate. In circumstances where facts demonstrate such a nexus between constraints imposed by a campaign or holding office, and childcare, we opine use of campaign funds to pay for childcare expenses is permitted.

In closing, the Commission suggests that candidates and office holders seek guidance from the Commission’s staff prior to using any campaign fund for expenses that may be considered questionable. Nothing in this opinion precludes a candidate or office holder from using their own personal funds for the payment of childcare expenses.

Conclusion

In taking a similar stance on childcare expenses as the FEC concluded in Advisory Opinion 2018-06, we opine campaign funds may be used for childcare expenses if (1) the need for childcare would not exist irrespective of the candidacy for public office and (2) the expenses have a direct connection with or effect upon the campaign of the candidate.
