The Kansas Department of Transportation (KDOT) is seeking a consultant to provide Construction Inspection Services for Project 166-63 KA-3906-01. The Project is located on U.S. 166 in Montgomery County, 1.99 Miles East of the Chautauqua County Line.

**Notice Concerning Proposed Kansas Air Quality  
Construction Permit and Public Hearing**

Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding a proposed air quality construction permit. Spirit AeroSystems, Inc. (Spirit) located at 3801 S. Oliver St., Wichita, KS 67210, has applied for an air quality construction permit in accordance with the provisions of K.A.R. 28-19-300 to add a thermal oxidizer and two sludge dryers to an existing construction permit issued on November 10, 2016.

Emissions of particulate matter (PM), PM with an aerodynamic diameter less than or equal to 10 micrometers (PM<sub>10</sub>), PM with an aerodynamic diameter less than or equal to 2.5 micrometers (PM<sub>2.5</sub>), sulfur dioxide (SO<sub>2</sub>), carbon monoxide (CO), volatile organic compounds (VOC), oxides of nitrogen (NO<sub>x</sub>), hazardous air pollutants (HAPs), lead, and greenhouse gases (GHGs) were evaluated as part of the permit review process.

The proposed permit is to be issued in accordance with the provisions of K.A.R. 28-19-350, Prevention of Significant Deterioration (PSD) which adopts the federal standards, procedures, and requirements of 40 CFR 52.21 by reference. These air quality regulations apply to major stationary sources and major modifications of major stationary sources located in areas designated as "attainment" or "unclassifiable" under the federal Clean Air Act



(CAA). Attainment areas are areas where the air quality meets or is better than the National Ambient Air Quality Standards (NAAQS).

The PSD regulations require evaluation of emission reduction techniques to identify the best available control technology (BACT) for each regulated pollutant, including GHGs, for which the emission rate exceeds the PSD significant level. The purpose of BACT is to affect the maximum degree of reduction achievable, taking into account energy, environmental, and economic impacts for each regulated pollutant under review. Evaluation of the estimated emissions for the proposed Spirit's 737 Expansion Project indicates that the emission rates of VOCs exceed the significant emission rate. Spirit conducted the required BACT analyses and KDHE concurs with their findings as follows:

- For the CAMO1 Paint Area, the use of Emission Control Enclosures (ECEs) with a regenerative thermal oxidizer (RTO) and compliance with 40 CFR Part 63 Subpart GG, National Emission Standards for Aerospace Manufacturing and Rework Facilities (Aerospace NESHAP) are BACT for VOC.
- For the two natural gas-fired sludge dryers, compliance with 40 CFR Part 63 Subpart DDDDD, the use of pipeline quality natural gas, and good combustion practices are BACT for VOC.

An ambient air quality impact analysis was reviewed and updated on the potential air emissions of VOC from the modification to Spirit's 737 Expansion Project.

- An ambient air quality analysis using a qualitative approach was updated on the potential VOC emissions from the proposed project. After considering data specific to the project and the area, the department has concluded that the proposed modifications will not cause or significantly contribute to air pollution in violation of any NAAQS. EPA has not established a 1-hour Class II maximum allowable increment for VOC or ozone. Therefore, no potential consumption of such increment is possible.

- Any federal land manager who has reason to believe they may have a class I area adversely impacted by the emissions from the proposed project has the opportunity to present KDHE with a demonstration of the adverse impact on the air quality-related values of the federal class I area during the comment period.

**SENATE BILL No. 9**

AN ACT making and concerning appropriations for the fiscal year ending June 30, 2019, for the Kansas public employees retirement system; authorizing certain transfers from the state general fund to the Kansas public employees retirement fund.

Be it enacted by the Legislature of the State of Kansas:

Section 1.

KANSAS PUBLIC EMPLOYEES RETIREMENT SYSTEM

(a) On the effective date of this act, or as soon thereafter as monies are available, the director of accounts and reports shall transfer \$115,000,000 from the state general fund to the Kansas public employees retirement fund (365-00-7002-7000) of the Kansas public employees retirement system for payment, in full or in part, of reduced employer contributions from participating employers under K.S.A. 74-4931, and amendments thereto, in prior fiscal years.

Sec. 2. This act shall take effect and be in force from and after its publication in the Kansas register.
