The website will allow the contractor to request approval from KDOT to bid as a prime contractor and be included on the "Bid Holders List," or to be included on the "Non-Bid Holders List" as a subcontractor/

supplier. KDOT's approval is required to bid as a prime contractor. To bid as a prime contractor, KDOT needs to be notified of the intent to bid no later than the close of business on the Monday preceding the scheduled letting date. Failure to obtain prior approval to bid as a prime contractor on any projects listed below will be reason to reject your bid. The Secretary reserves the right to reject bids that do not comply with all requirements for preparing a bidding proposal as specified in the 2007 edition of the Kansas Department of Transportation *Standard Specifications for State Road and Bridge Construction*.

KDOT will open and read these proposals at the Eisenhower State Office Building, 700 SW Harrison, Topeka, Kansas, at 1:30 p.m. (CST) July 17, 2019. Each bidder shall certify that such person, firm, association, or corporation has not, either directly or indirectly, entered into any agreement, participated in any collusion, or otherwise taken any action in restraint of free competitive bidding in connection with the submitted bid. This certification shall be in the form of a required contract provision provided by the state to each prospective bidder. Failure to complete the required contract provision and certify the completeness of the preceding statement when electronically signing the proposal will make the bid nonresponsive and not eligible for award consideration.

Rental rate shall be assessed per leased or leaseable square foot of the building but is negotiable based on term of lease and benefit to the university. **Notice of Proposed Permit Renewal Action**

The Kansas Department of Health and Environment (KDHE) received a Hazardous Waste Facility permit renewal application from The Sherwin-Williams Company (Operator/Owner). The facility is located at 1700 W. 4th St., Coffeyville, Kansas and has an Environmental Protection Agency (EPA) identification number KSD0007163355.

KDHE is providing notice of its intent to renew the RCRA hazardous waste management permit for the facility. The proposed permit will require The Sherwin-

Williams Company to conduct post-closure care for the regulated units, and implement site-wide groundwater monitoring at the facility.

In October 1985, the State of Kansas received final authorization from the EPA to implement a hazardous waste management program in lieu of the federal program, except for those portions covered by the 1984 Hazardous and Solid Waste Amendments (HSWA). In September 2013, authority for the corrective action portion of the RCRA program was delegated to the State of Kansas.

The draft permit sets forth, in a concise document, the applicable requirements that KDHE will require the permittee to comply with during the 10-year duration of the permit. The draft hazardous waste permit includes standard permit conditions, general facility conditions, post-closure care requirements, groundwater monitoring and remediation as well as corrective action for all Solid Waste Management Units and Areas of Concern.

The draft permit is being considered for issuance under authority of the Kansas Statutes Annotated (K.S.A.) 65-3430 *et seq.* and Kansas Administrative Regulations (K.A.R.) 28-31-4 through 28-31-279a. Documents that support the permit conditions specified in the draft permit are part of the administrative record. Applicable regulations are found in 40 CFR Parts 124, 260 through 264, 268, and 270, as specified in this permit. All citations found in the draft permit to federal regulations are for the sake of convenience. Some modifications to federal regulations by applicable state regulations are noted in this permit, but all modifications to federal regulations by state regulations are incorporated. To the extent that state regulations exclude any sections of applicable federal regulations, those sections are not in effect. In the instance of inconsistent language or discrepancies between conditions found in the permit, state regulations, or federal regulations, the language of the more stringent provision will govern; otherwise, state law governs.

State hazardous waste laws require that the public be given at least 45 days to review the administrative record for the draft permit prior to KDHE taking a final action. The purpose of having a public comment period is to ensure that interested parties have an opportunity to evaluate the conditions specified in the draft permit and to provide their input into the permit decision-making process. A copy of the administrative record which includes the draft permit, the fact sheet, the permit application, and all information pertaining to this permit action is available for public review from June 25, 2019 through August 14, 2019, Monday through Friday, during normal business hours at the following locations:

Additionally, a public availability session will be held from 6:00 p.m. to 7:30 p.m. July 31, 2019, in the Community Room at the Coffeyville Public Library, to provide the public an opportunity to discuss the renewal of the RCRA hazardous waste permit with representatives of KDHE and The Sherwin-Williams Company. As specified in 40 CFR 124.11, during the public comment period any interested person may request a public hearing in writing which states the nature of the issues proposed to be raised in a public hearing. In the event that a hearing is scheduled, advance notice of the date will be given to the public. The Secretary of KDHE will make the decision regarding the issuance of the permit after the close of the public comment period, and will consider all comments received during the public hearing and comment period.

When the final decision to issue or deny the permit is made, notice will be given to the applicant, all persons who submitted written comments, and those who requested notice of the final permit decision. If none of the comments received during the public comment period result in revision(s) to the draft permit, the permit will become effective immediately upon issuance of the final permit decision. If comments received during the public comment period result in revision(s), the permit will become effective 30 days after service of notice of the final decision to allow for public review of the revisions in accordance with 40 CFR 124.15 and K.A.R. 28-31-124(c)(8). Appeals of the final permit decision for the permit must be filed within 15 days after service of notice in accordance with K.S.A. 65-3440 and K.S.A. 77-601 *et seq.*

#### Notice Concerning Proposed Kansas Air Quality Class I Operating Permit Renewal

Notice is hereby given that the Kansas Department of Health and Environment (KDHE) is soliciting comments regarding a proposed air quality operating permit. Kansas Gas Service has applied for a Class I operating permit renewal in accordance with the provisions of K.A.R. 28-19-510 *et al.* The purpose of a Class I permit is to identify the sources and types of regulated air pollutants emitted from the facility; the emission limitations, standards, and requirements applicable to each source; and the monitoring, record keeping, and reporting requirements applicable to each source as of the effective date of permit issuance.

Kansas Gas Service, PO Box 20149, Tulsa, OK 74102-1049 owns and operates the Calista Compressor Station located at Section 6, Township 28S, Range 8W in Kingman County.

A copy of the proposed permit, permit application, all supporting documentation, and all information relied upon during the permit application review process are available for public review during normal business hours

of 8:00 a.m. to 5:00 p.m. at the KDHE, Bureau of Air (BOA), 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366 and at the South Central District Office, 300 W. Douglas, Suite 700, Wichita, KS 67202-2921. To obtain or review the proposed permit and supporting documentation, contact Cathy Richardson, 785-296-1947, at the central office of the KDHE or David Butler, 316-337-6042, at the South Central District Office. The standard departmental cost will be assessed for any copies requested. The proposed permit, accompanied with supporting information, is available, free of charge, at the KDHE BOA Public Notice website, <http://www.kdheks.gov/bar/publicnotice.html>.

Please direct written comments or questions regarding the proposed permit to Cathy Richardson, KDHE, BOA, 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366. In order to be considered in formulating a final permit decision, written comments must be received no later than 12:00 p.m. Monday, July 22, 2019.

A person may request a public hearing be held on the proposed permit. The request for a public hearing shall be in writing and set forth the basis for the request. The written request must be submitted to Cathy Richardson, KDHE BOA, 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366, no later than 12:00 p.m. Monday, July 22, 2019 in order for the Secretary of Health and Environment to consider the request.

The U.S. Environmental Protection Agency has a 45-day review period, which will start concurrently with the public comment period, within which to object to the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the EPA to review the permit. The 60-day public petition period will directly follow the EPA's 45-day review period. Interested parties may contact KDHE to determine if the EPA's 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. #### Notice of Hearing on Proposed Administrative Regulations

A public hearing will be conducted at 3:30 p.m. Tuesday, August 20, 2019, at 909 N. Pearl, Paola, Kansas, to consider the adoption of proposed rules and regulations of the Kansas Board of Examiners in Fitting and Dispensing of Hearing Instruments.

This 60-day notice of public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties may submit written comments prior to the hearing to Board of Examiners in Fitting and Dispensing of Hearing Instruments, PO Box 464, Paola, KS 66064 or [zack.miller@ks.gov](mailto:zack.miller@ks.gov). All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statements in an accessible format. Requests for accommodation should be made at least five working

days in advance of the hearing by contacting Zack Miller at 913-594-4142.

These regulations are proposed for adoption on a permanent basis. A summary of proposed regulations and their economic impact follows.

**K.A.R. 67-1-8 Potentially disqualifying civil and criminal records; advisory opinion; fee.** This new regulation helps with the safety of consumers by limiting licenses issued for applicants with certain civil and criminal records.

The economic impact will be insignificant.

**K.A.R. 67-2-4 Examinations.** This amended regulation requires examinees to take and pass the written examination prior to sitting for the practical exam. It explains the scoring for the written and practical examinations as well as the application process for the written and practical examinations.

The economic impact will benefit the board and examinees by decreasing the number of examinees that fail the practical exam, thus limiting the number of retakes.

**K.A.R. 67-5-5 Fees.** This amended regulation combines all board fees and, through revisions to fees and implementation of new fees, will generate an increase in the board's operating income in order to maintain adequate funds for operation.

The proposed regulation is not mandated by federal law.

There will be no cost to the agency proposing the regulation. There should be no economic impact to other governmental agencies or units or to the general public or consumers of hearing instruments or hearing instrument services. All licensees will see a decrease of \$25 in the annual renewal fee. Fees will remain lower than surrounding states.
