Public notice is hereby given that Wichita State University (WSU) intends to directly lease, and indirectly sublease through its affiliate corporation Wichita State Innovation Alliance, Inc., subject to all required state approvals, an approximate ground area consisting of 150,000 square feet or less with the potential for expansion for parking, for the private development of one or more partnership buildings. This private development shall be located west of Oliver, between 17th and 18th streets, on the Wichita State University main campus. Public notice is hereby given that a public hearing will be held by the Kansas Development Finance Authority (the "Authority") at 9:30 a.m. August 30, 2019, in the conference room in the offices of the Authority, 534 S. Kansas Ave., Suite 800, Topeka, Kansas, concerning a plan of finance involving the issuance by the City of Wichita, Kansas of one or more series qualified 501(c)(3) rev-

enue bonds in a maximum stated principal amount of \$53,000,000 (the "Bonds") for the purpose of making the proceeds of the bonds available to Presbyterian Manors, Inc., a Kansas not for profit corporation (the "Corporation"), to finance, refinance, and reimburse costs of senior living and health care facilities and equipment for the Corporation and its affiliates, as further described in this public notice. Seventh, Newton, KS 67114; (9) \$3,500,000 at 17500 W. 199th St., Olathe, KS 66061; (10) \$500,000 at 3501 Dirr Ave., Parsons, KS 67357; (11) \$10,100,000 at 2601 E. Crawford St., Salina, KS 67401; and (12) \$800,000 at 4712 SW Sixth, Topeka, KS 66606. At the Corporation's discretion, the forgoing estimated Bond proceeds may be allocated to any of the above described projects to finance all, a part, or none, of the capital and related working capital expenditures at each location.

This public hearing does not impose any liability on the Authority or the State of Kansas but is an accommodation by the Authority to satisfy the requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended.

All individuals who appear at the hearing will be given an opportunity to express their views for or against the proposed financing of the projects described above, and all written comments previously filed with the Authority at its offices at 534 S. Kansas Ave., Suite 800, Topeka,

Background and Purpose of Project

The Kansas Department of Transportation is seeking a consultant to provide statewide bridge inspection services consisting of requested underwater inspections on the local system, starting with the inspections due in 2019. Due to the unique nature of these inspections, as well as the need at times to use specialized equipment, this program is offered to the local bridge owners as a method to make use of economy of scale by bundling inspections. Inspections are to be performed in accordance with the latest published edition of the KDOT Bureau of Local Projects Local Bridge Inspection Manual and Local Underwater Inspection Scope of Services (available at <https://kart.ksdot.org>). This contract may be for up to 5 years.

Scope of Services to be Performed

Consultant shall complete the following tasks and produce the deliverables described below:

- Provide an estimate of cost for work to be performed each year to be approved prior to commencing inspections.
- Provide underwater inspections on local system bridges (historically about 80 bridges—currently two on a 36-month interval (2020), remaining bridges on a 48-month interval (2020: 9; 2021: 36 2022: 33)).
- Provide a final cost-per-bridge for each inspection performed at the end of each program year.
- Input inspection data into the KDOT-BLP Bridge Inspection Portal.
- Provide PDFs of the Draft Inspection Reports to the KDOT Program Manager for review and approval.
- Upload PDFs of the Final Inspection Reports into the Bridge Inspection Portal and provide them to

Consulting engineering services are sought for the load ratings for all required structures on the local system and owned by Local Public Authorities (LPA). The selected firm(s) will review design plans, analyze structure geometries and conditions, and develop required load rating(s) for the structures. All wastewater discharged from the main laboratory is treated to kill any live pathogens prior to discharge into the wastewater collection system using an effluent decontamination system (EDS) or autoclave. Cooling tower blowdown, boiler water, and a small stream of domestic wastewater generated from the visitor center bypasses the pretreatment system and is pumped from the site lift station to the sanitary sewer. The NBAF’s onsite wastewater treatment system begins with multi-step processes to reduce concentrations of pollutants to meet City of Manhattan pretreatment requirements prior to discharge to the City of Manhattan sanitary sewer. These processes include micro-screening, three dual-stage trickling filter systems operated in parallel, and a two-cell constructed wetlands.

Executive Order No. 19-09

Promoting Cooperation in Economic Development

WHEREAS, the Kansas City Region is of vital importance to the economic well-being and prosperity of the State of Kansas; and

WHEREAS, movement of existing businesses and jobs across the state line does not result in tangible economic growth within the Region; and

WHEREAS, Kansas and its citizens will benefit from real economic growth through new job creation and capital investment within the Region; and

WHEREAS, Kansas and Missouri should use their limited resources on efforts to grow the region and cease providing incentives to businesses that move across the border merely to access economic development incentives; and

WHEREAS, the states have long considered and discussed opportunities to help end the "Border War"; and

WHEREAS, greater cooperation between Kansas and Missouri and their respective local units of government will result in economic development opportunities to produce greater prosperity throughout the Region by allowing economic development incentives to be used to create new jobs and capital investment; and

WHEREAS, reaching a true resolution of the issues referred to as the "Border War" requires understanding and cooperation between the states and local governments.

NOW, THEREFORE, pursuant to the authority vested in me as Governor of the State of Kansas, I hereby declare that:

1. On and after August 28, 2019, no state-level economic development incentive programs under my jurisdiction shall be used to incent businesses with jobs currently located in the Missouri counties of Jackson, Platte, Clay, or Cass to relocate those existing jobs to the Kansas counties of Johnson, Wyandotte, or Miami.
2. On and after August 28, 2019, Kansas' state-level economic development incentive programs shall be limited to the net new jobs created for any business or company relocating from the Missouri border counties of Platte, Jackson, Clay, or Cass into Johnson, Wyandotte, or Miami counties in Kansas.
3. State of Kansas economic development incentive programs subject to this Order include Promoting Employment Across Kansas, Kansas Industrial Training and Retraining, Job Creation Fund and any other state loan funding or administered discretionary economic development incentive programs.
4. I also strongly encourage and expect local units of government in Kansas, who are not under my jurisdiction but whose cooperation will be critical to resolving the "Border War" and promoting true economic growth across the Region, to limit local incentives to net new jobs in the Region.

5. Additionally, in order to equalize local economic development incentives to the greatest extent possible, local government units in Missouri must not offer property tax abatements to relocating companies that exceed the 10-year term allowed in Kansas.
6. The Kansas Secretary of Commerce is directed to share with the Missouri Department of Economic Development information necessary to effectuate the purposes of this Order.
7. Additional provisions or steps required to accomplish the intent of this Order will be reflected in an Agreement signed by the governors of Kansas and Missouri. In the event this Order and the forthcoming Agreement are inconsistent or contradictory, this Order will control.
8. This Order is intended to satisfy the provisions of Mo. Rev. Stat. § 135.1670, Section 3, as amended by 2019 Senate Bill 182, regarding the issuance of "an executive order or similar action which prohibits the Kansas Department of Commerce or any other Kansas executive department from providing economic incentives for jobs that are relocated from a Missouri border county to a Kansas border county."
9. In the event any party—including relevant local government units—fails to demonstrate the requisite good faith and cooperation necessary to achieve the purposes of this Order, I may exercise my authority as Governor to rescind this Order. In particular, if any local government unit in Platte, Jackson, Clay, or Cass counties in Missouri, including the Kansas City Port Authority, provides property tax incentives for a term exceeding 10 years for the relocation of existing jobs from the Kansas counties of Johnson, Wyandotte, or Miami, I may exercise my authority to rescind this Order.

This document shall be filed with the Secretary of State as Executive Order No. 19-09 and is effective immediately.

During the hearing, all written and oral comments submitted by interested parties will be considered by the commission as a basis for approving, amending and approving, or rejecting the proposed regulations.

The regulations that will be heard during the regulatory hearing portion of the meeting are as follows:

K.A.R. 115-7-1. This permanent regulation sets legal equipment, methods of taking and other provisions for fishing. The proposed amendments would require closed-cell construction for float material on trotlines.

Economic Impact Summary: No substantial negative economic impact to the department, other state agencies, small businesses, or individual members of the public is anticipated.

K.A.R. 115-7-10. This permanent regulation sets special provisions for fishing. The proposed amendments would update the department's Kansas aquatic nuisance species designated waters reference document.

Economic Impact Summary: No substantial negative economic impact to the department, other state agencies, small businesses, or individual members of the public is anticipated.

K.A.R. 115-9-9. This permanent regulation sets requirements for electronic licenses, permits, tags, and other issues of the department. The proposed amendments would allow for use of mobile devices to carry licenses.

Economic Impact Summary: No substantial negative economic impact to the department, other state agencies, small businesses, or individual members of the public is anticipated.

K.A.R. 115-15-1. This permanent regulation designates threatened and endangered species in Kansas. The proposed amendments would list one species, the Cylindrical papershell mussel, as endangered and de-list one species, the Arkansas darter, from threatened status.

Economic Impact Summary: No substantial negative economic impact to the department, other state agencies, small businesses, or individual members of the public is anticipated.

K.A.R. 115-15-2. This permanent regulation designates nongame species, otherwise known as Species In Need of Conservation or SINC status. The proposed amendments would add one new SINC species, the Arkansas Darter, and remove one SINC species, the Wabash pigtoe mussel.

Economic Impact Summary: No substantial negative economic impact to the department, other state agencies, small businesses, or individual members of the public is anticipated.

K.A.R. 115-18-6a. This new permanent regulation would exempt school motor vehicles from needing a motor vehicle permit to enter a state park.

Economic Impact Summary: No substantial negative economic impact to the department, other state agencies, small businesses, or individual members of the public is anticipated.

K.A.R. 115-25-14. This exempt regulation sets creel limit, size limit, possession limit and open season for fishing. The proposed amendments would update the reference document for length and creel limits at various locations across the state.
