Filing fee	The filing fee for this registration is \$20.
Payment	Please enclose a check or money order payable to the Secretary of State. Forms received without the appropriate fee will not be accepted for filing. Please do not send cash. NOTICE: There is a \$25 service fee for all checks returned by your financial institution. Also, to expedite processing, please do not use staples on your documents or to attach checks.
Citizen	Applicant must be a citizen of the United States.
Constitution and bylaws	Any labor organization that has a business agent must file a copy of its constitution and bylaws with the secretary of state before doing business in Kansas. Amendments or changes to the constitution or bylaws must be filed with the secretary of state within 30 days of adoption.
