INSTRUCTIONS FOR FILING ARTICLES OF ORGANIZATION

Note: All documents filed by the Secretary of State's office are considered public record and may be viewable online.

How to complete the Articles of Organization for a domestic (Kansas) Statutory Public Benefit Limited Liability Company (SPBLLC):

Each of the numbered instructions below corresponds to a section on the form.

1. Provide the name of the SPBLLC. All domestic SPBLLCs must contain a word of formation. Pursuant to K.S.A. 17-76,149(c), that word must be one of the following in English or in any other language if they are written in Roman characters:

STATUTORY PUBLIC BENEFIT LIMITED LIABILITY COMPANY, S.P.B.L.L.C., or SPBLLC

Or, if the SPBLLC does not contain one of these words of formation as provided for in K.S.A. 17-76,149(c), the business entity name must contain a word of formation that must be one of the following in English:

L.L.C., L.C., LLC, LC, LIMITED LIABILITY COMPANY or LIMITED COMPANY.

Check to see if the name of the covered business entity is in use by any other business entity already registered with our office online at https://www.sos.ks.gov/eforms/BusinessEntity/ NameAvailability.aspx.

If the name is currently in use, either a Written Consent to Use of Similar Business Name or a letter advertising must be submitted with the formation document.

Consent to Use of Similar Business Name: Pursuant to K.S.A. 17-7918, the business may submit a Written Consent to Use of Similar Business name (Form CN), completed by the business registered with the Secretary of State's office, found at https://www.sos.ks.gov/forms/business_services/CN.pdf.

2. Provide the name of the resident agent.

Resident agent: This is either an individual or a business entity registered in Kansas (may be the business entity the articles of organization are for) who will receive any legal documents (e.g., subpoenas, court orders, summons, etc.) for the business entity named in section 1. If the resident agent is a business entity, search for the legal name of the business at https://www.sos.ks.gov/eforms/BusinessEntity/Search.aspx.

3. Provide the registered office for the resident agent.

Registered office: Must be an address in Kansas where the resident agent may be regularly present. The address must include the building number, street, city, state, and zip code. This can't be a PO box.

- 4. The specific public benefits that are to be promoted by the SPBLLC must be provided.
- 5. An authorized person on behalf of the business entity must sign.
