How to complete the Foreign Application for a foreign (non-Kansas) business:

Each of the numbered instructions below corresponds to a section on the form.

1. Select the business type the business is operating as in their foreign (non-Kansas) state or country.
2. Provide the name of the business. The business name must be the legal name on record with the foreign (non-Kansas) state or country of the business. DBA, fictitious, assumed, and trade names are not registered with the Kansas Secretary of State's office.

Check to see if the name of the business is in use by any other business already registered with our office online at <https://www.sos.ks.gov/eforms/BusinessEntity/NameAvailability.aspx>.

If the name is currently in use, either a Consent to Use of Similar Business Name or a letter of advertising must be submitted with the formation document.

Consent to Use of Similar Business Name: Pursuant to K.S.A. 17-7918, the business may submit a Consent to Use of Similar Business name (Form CN), completed by the business registered with the Secretary of State's office, found at https://www.sos.ks.gov/forms/business_services/CN.pdf.

Letter of advertising: Pursuant to K.S.A. 17-7933, a letter of advertising must indicate that the business, in all means of identification and advertising, will identify as a business out of their foreign (non-Kansas) state or country. If the current business is domesticated in the same foreign state or country, a letter of advertising can't be used and a Consent to Use of Similar Business Name from the current business must be provided.

3. Provide the jurisdiction where the business organized. This must be either a U.S. state, U.S. territory, or foreign country.
4. Provide the name of the resident agent.

Resident agent: This must be either an individual, a business registered in Kansas, or the business itself who will receive any legal documents (i.e. subpoenas, court orders, summons, etc.) for the business named in section 2. If the resident agent is a business, search for the legal name of the business at <https://www.sos.ks.gov/eforms/BusinessEntity/Search.aspx>.

5. Provide the registered office for the resident agent.

Registered office: Must be an address in Kansas where the resident agent may be regularly present. The address must include the building number, street, city, state, and zip code. This can't be a PO box.

6. Provide the date the business began doing business in Kansas. This field may be left blank if this date would be the date the application is filed with the Kansas Secretary of State's Office. This date determines if information reports must be filed with the foreign application.

Information report: This is a document that is filed every two years to maintain good standing with the Kansas Secretary of State. If an even year was entered in section 6, the information report would have been filed every following even year, and if an odd year was entered in section 6, the information report would have been filed every following odd year. Perform the following steps for the type selected in section 1 to determine how many reports to submit.

Not-for-profit corporations: If the business has passed a reporting period for an information report, the foreign application must be submitted with the most recent information report missed.

All other businesses: Each of the information reports that have not been filed within the reporting period that would have been due, limited to the last 10 years of information reports, must be submitted with the foreign application.

7. Provide the date of organization in the business's domestic state. This may be found on the certificate issued by the business's domestic state.
8. Provide the business's purpose statement. This statement is a general indication as to the nature of business.
9. **This section only applies to LLCs that can create series:** These two statements must be reviewed, and at least one of the statements checked for the business to be registered with our office as an LLC that can create series in their domestic state. If not true, then leave the boxes blank and the LLC will not be registered as a series LLC.
10. **LLPs only:** At least 2 partners must sign.

All other businesses: At least 1 authorized person must sign.

Fee Schedule

Foreign Application

The filing fee for the Foreign Application is as follows:

All businesses:..... \$115

For all businesses, except for not-for-profit corporations, a one-time penalty fee of \$85 must be submitted if one or more information reports are being filed after the business's forfeiture date. Forfeiture dates are 3 months after the end of the reporting period.

If information reports are being submitted, the filing fee for each must also accompany the information reports. The following reports must be submitted with the foreign application:

Kansas Attorney General Notice

Effective July 1, 2025, it is required for businesses or individuals owning or acquiring any interest in real property located within 100 miles of the boundary of any military installation located in Kansas, Nebraska, Colorado, Oklahoma, Iowa, and Texas to register said interest with the Kansas Attorney General's Office.

The following are subject to this requirement:

The government, any political party or subdivision, any corporate entity, any agent, or any citizen of the following:

- People's Republic of China (including the Hong Kong special administrative region)
- Republic of Cuba
- Islamic Republic of Iran
- Democratic People's Republic of Korea
- Russian Federation
- Bolivarian Republic of Venezuela
- Any organization that is designated as a foreign terrorist organization

This includes any individual having a controlling interest in any company formed for the purpose of holding interest in real property on behalf of any of the foregoing.

Any of the above businesses or individuals owning an interest in real property described above must submit the Foreign Principal Real Property Interest Registration Form found on the Attorney General's website at <https://www.ag.ks.gov> to the Kansas Attorney General on or before 90 days of either registering with the Kansas Secretary of State or upon acquisition of the real property.

The foreign business hereby consents, without power of revocation, that actions may be commenced against it in the proper court of any county in the state of Kansas; and the foreign business stipulates and agrees that such service shall be taken and held in all courts to be valid and binding as if due service had been made upon the authorized persons of the foreign business.

As of the day of this filing, the foreign business exists in good standing under the laws of the jurisdiction of its organization.
