Proposals shall indicate the consultant's ability to meet the project inspection needs described above. Evaluation Factors

Proposals will be evaluated based on the factors listed below, evenly weighted, to rank the most qualified firm in order of preference as first, second, third, etc. Evaluation factors include:

- 1. How the consultant plans to meet the fluctuating inspection needs of the project;
- Project manager and two project inspectors names, certifications and qualifications proposed for services;
- 3. Past performance history on similar projects (list project numbers) for KDOT;
- 4. Anticipated time to close out project paperwork;
- 5. Proximity of inspectors to project;
- 6. Types of direct expenses anticipated (lodging, mileage, etc.).

The highest ranked firm will be asked to enter into negotiations with KDOT for an agreement. In the event KDOT cannot reach agreement with the highest ranked firm, it will terminate negotiations with such firm and commence negotiations with the next highest ranked firm, and so on, until either agreement is reached for a satisfactory scope of services for a fair and reasonable price, or KDOT decides to pursue other alternatives.

Introduction

Through this Request for Information (RFI), the Kansas Department of Transportation (KDOT) seeks to gather relevant information from industry stakeholders and potential applicants to help establish program criteria for determining eligibilities, technical specifications, station locations, and other program elements to subsequently aid in the development of a Request for Proposals (RFP). The eventual RFP will assist KDOT in administering Volkswagen Mitigation Trust Funds for the Electric Ve-

hicle Direct Current Fast-Charging (EV DCFC) Station Installation Program.

The following sections outline draft program elements and expectations. Please review all sections and follow the guidance provided in Section 9 "Instructions to RFI Respondents" to prepare your letter of interest to this RFI.

Background

KDOT is administering approximately \$2,000,000 available from the Volkswagen Mitigation Trust funds allocated for investment in EV charging infrastructure. KDOT has identified approximately twelve preliminary locations for the installation of DC Fast Charging stations (50 kW or greater) to help advance the state's effort to support publicly accessible charging stations every 50 miles along primary corridors. The twelve preliminary locations have been identified along the I-70, I-35, and I-135/US-81 corridors by the Clean Cities EV Working Group.

Eligible Applicants

Eligible applicants may include one or more of the following organization types:

- Businesses/vendors
- Utility companies
- Federal, state, local, or tribal government agencies
- Nonprofit organizations

Applicants are strongly encouraged to demonstrate collaboration with local governments including cities, towns, and county governments as well as other local partners such as other public and private stakeholders. Proposals that have strong support from local and regional stakeholders will be evaluated more favorably.

Applicants are required to collaborate with the local electric utility and include appropriate documentation from the utility, such as a letter or service notice, indicating power supply availability for the proposed project. The following link provides a map of electric utility service areas in Kansas: https://kcc.ks.gov/images/PDFs/maps/ks_electric_certified_areas.pdf.

Applicants are strongly encouraged to identify one or more potential charging station location hosts; and must present a plan for five years of ownership and maintenance of the equipment and public access. Proposals that have identified an interested charging station host will be evaluated more favorably.

Applicants are required to provide a description of the business model which includes utility rates, operational costs, cost to charge at the stations, and anticipated revenue. The proposed pricing structures and rates to charge drivers should be fair and reasonable.

Funding and Reporting Requirements

KDOT will administer approximately \$2,000,000 to awardees for the installation of DCFC charging stations at twelve preliminary locations and along the identified priority corridors.

KDOT will reimburse up to 80% of eligible costs for charging stations installation. Total average reimbursable cost per installation is expected to be approximately \$150,000. Donation of land, driveway access, or reduced energy charges to the customer are not reimbursable expenses.

In-kind match and non-cash match sources will not be eligible match sources. Only expenses incurred on eligible costs may be considered toward the match.

Eligible Costs

Only costs necessary for and directly connected to the acquisition, installation, operation, and maintenance of the EV charging equipment are eligible for reimbursement. The following items are eligible for reimbursement up to 80% upon project completion:

- DC fast charging equipment costs
- Charger installation costs
- Equipment shipping costs
- Necessary electric service upgrades and connection of the charger to electric service; including utility upgrades such as transformers and line extensions
- Other hard costs of site preparation (concrete, conduit, cable/wiring)
- Signage and lighting (directly associated with the charging infrastructure)
- Networking costs (up to five years)
- Charging equipment extended warranties and service contracts (up to five years)
- Other equipment and non-labor project costs including design and engineering and project management
- Permit costs/fees
- Warranties for equipment (up to five years)

Ineligible Costs

Costs not directly connected to the acquisition, installation, operation, and maintenance of the EV charging equipment are not eligible for reimbursement. Ineligible costs include but are not limited to the following:

- Purchase or rental of real estate
- Other capital costs (construction of buildings or parking facilities)
- General maintenance (other than that of the EV charging equipment)
- Administrative costs
- Battery storage serving the charging equipment
- Solar photovoltaic panels providing power to the charging equipment
- Cost of electricity to power the EV charging equipment
- Restriping or repaving/resurfacing of parking lots or outside of DCFC installation

Award Payment Schedule

Invoices may be submitted for a one-time reimbursement following the completion of the applicant's committed installation(s). Invoices will be reviewed and approved by KDOT and must include photographs of the installed charging station, receipts for equipment, contractor hours, installation costs, and supplies. If applicant wishes to have any five-year operational and maintenance expenses included, prepaid invoices will need to be provided with invoice. All project work must be completed within 12 months from the date the KDOT agreement is signed.

Reporting

Awardees are required to have their charging stations registered on the following databases for a minimum of five years following the date of project completion:

- U.S. Department of Energy's Alternative Fuels Data Center at https://afdc.energy.gov/stations/#/station/new
- PlugShare at https://www.plugshare.com/

Awardees are required to provide usage reports on a prescribed schedule that will be established in agreement with KDOT. The report will include but is not limited to, the number of charging sessions, average kilowatt-hours used per charging session, maximum instantaneous peak power, hours of equipment downtime, and charging duration. Such information will help the program better understand the demand for charging and usage trends.

All awardees must submit annual station utilization data to KDOT for a minimum of five years after project completion. The following information shall be submitted for each charger installed:

- Connect and disconnect times
- Start and end charge times
- Maximum instantaneous peak power
- Average power
- Number of charging events
- Total energy (kWh) per changing event
- Rolling 15-minute average power
- Date/time stamp
- Unique ID for charging event
- Unique ID for identifying the EVSE
- Other non-dynamic EVSE information such as GPS ID
- · Percentage of station downtime

Equipment and Installation Requirements

<u>Equipment</u>

- Stations with two DCFC must be capable of providing at least 150 kW charging for a single vehicle and at least 50 kW simultaneous charging for two vehicles.
- Stations with four DCFC must be capable of providing at least 150 kW simultaneous charging for two vehicles and at least 50 kW simultaneous charging for four vehicles.
- Stations must be backward compatible to CHAde-MO v0.9 and SAE J1772 Oct2012 or other similar standard to allow model year 2010 or newer DC charging equipped vehicles to charge at lower kW.
- The DCFC and supporting equipment must comply with NEC (2020edition) Article 625 and related articles and tables.

- DCFC and supporting electrical components, enclosures, and mounting systems must be built to UL 2202 and UL2594 standards or equivalent.
- DCFC and supporting equipment shall be listed by a Nationally Recognized Testing Laboratory (NRTL).
- DCFC and supporting equipment shall comply with state and local codes and electrification requirements including, but not limited to, third party certification as appropriate (documentation to be included for each unit).
- DCFC shall have payment or access control to allow users to authenticate using a credit card (magnetic stripe and chip card) using equipment at the station. KDOT will consider additional payment methods beyond credit cards including use of RFID device, NFC, smart phone apps, or other identifying and authorizing methods. These additional payment methods shall operate on equipment, software, and networks using publicly available open standard(s), such as Open Charge Point Protocol (OCPP) v1.6. The DCFC should have back-end capabilities to collect payment or provide reporting mechanisms such that another system, through secure re-programming of back-end server location and credentials, would be able to collect payment and provide access control.
- DCFC shall be type evaluated through the National Type Evaluation Program (NTEP) and the installation and use shall comply with all requirements of the National Institute of Standards and Technology (NIST) Handbook 44 Section 3.40. Electric Vehicle Fueling Systems—Tentative Code and shall have received safety certification by a nationally recognized testing laboratory (NRTL). j. DCFC shall be indicated and recorded in megajoules (MJ) or kilowatt-hours (kWh) and decimal subdivisions thereof, with the value of the smallest unit of indicated delivery by a DCFC, and recorded delivery if the DCFC is equipped to record, shall be 0.005 MJ or 0.001 kWh.
- Physical Appearance, Function, and Design
 - DCFC and supporting equipment must utilize tamper-resistant screws and design but provide a locked or easy opening mechanism for service work.

- Access to full-service amenities within a short walking distance is preferred, such as local restaurants, retail shopping, or tourist attractions.
- Each station site shall have adequate parking to allow for the maximum number of vehicles that can be charged simultaneously (at least two vehicles per site).
- Station sites shall have dusk-to-dawn area lighting.
- The sites must provide or have access to shelter for inclement weather.
- Applicants shall clearly describe safety precautions implemented on site for EV drivers charging their vehicles with the installed equipment.

Payment

- The charging equipment must be capable of supporting multiple point-of-sale methods including credit or debit cards without incurring any additional fees, inconvenience, or delays versus other payment or access control methods. Other payment options may include pay per use subscription methods, RFID or smart cards, and smart phone applications.
- Equipment shall allow for flexible pricing including, but not limited to, per minute or per hour, by kWh, by time of day.
- Equipment and software shall be futureproofed to allow for alternative forms of payment as payment technology evolves.

Operation and Maintenance

- 24/7 customer service availability.
- Five-year service guarantee.
- Must register with the Alternative Fuels Data Center and PlugShare.
- The applicant will be responsible for ensuring payment of all operating and maintenance costs including, but not limited to, payment of leases, rents, royalties, licenses, fees, taxes, revenue sharing, utilities, and electric power supply for the charging equipment and supporting elements, such as area lighting.
- The applicant is responsible for ensuring the maintenance of the chargers including cables, ancillary equipment, and any awnings, canopies, shelters, and information display kiosks for signage associated with the charging station. "Maintain" as used in this RFI shall mean "to provide all needed repairs or desired and approved alteration, as well as regular maintenance needed to ensure optimal performance and minimize downtime. Equipment shall be kept safe and presentable."
- The applicant must address any issues such as, but not limited to, malfunctions and repairs. The applicant must propose a plan to ensure that the equipment is operational at least 95% of the time based on a week of 24 hours a day and seven days (no more than 5 hours cumulative downtime in a seven-day period). It is the applicant's responsibility to ensure the 95% uptime requirement is met. For significant or complex issues leading to extended downtime (such as vandalism), applicants shall notify appropriate sources so drivers are aware, including, but not limited to, website and application hosts, as appropriate.
- Applicants shall include snow removal plan to ensure access during/after inclement weather.
- The applicant must provide customer support service that is accessible 24/7. This may include an onsite station operator or a toll-free telephone number clearly posted near the charging equipment that is available to EV drivers accessing the charging equipment.

Upgradability

 Applicants shall include future-proofing strategies such as larger or additional concrete pads, transformers, and other utility-related equipment, and

- larger and/or additional conduit to avoid having additional construction and conduit costs in the future.
- Applicants are strongly encouraged to consider opportunities for current or future use of onsite storage, dispatchable load, and renewable energy.

K.A.R. 30-10-214 provides for the annual review and adjustment of Class II ICF/IID cost center limits, approved by the secretary of the Kansas Department for Aging and Disability Services (KDADS) or designee, based on current cost information supplied by the enrolled, licensed providers of ICF/IID services, and formula set forth in the Kansas State Medicaid Plan (Attachment 4.19-D, Part II, Subpart O, page 1). The formula is as follows: total allowable costs, including an inflation factor, are compared to the amount to be reimbursed under the current limits.

The formula threshold requires that 60 percent of all ICF/IIDs are reimbursed 90 percent of their allowable costs. If less than 60 percent of the facilities are reimbursed at 90 percent of their allowable costs, then the cost center limits are adjusted until the threshold is met. The inflation factor is based on the IHS Global Insight, National Skilled Nursing Facility Market Basket Without Capital Index (IHS Index).

To determine where to make the adjustments, two major cost centers are analyzed according to the following prescription:

- Administrative costs are based on facility size
- Habilitation costs are based on facility size and level of care (LOC)

The cost analysis for SFY2022 demonstrates 80 percent of the Class II ICF/IIDs are being reimbursed at 90 percent or more of their allowable costs. Per the state plan the analysis indicates that adjustments are not required.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes. These regulations are proposed for adoption on a permanent basis.

K.S.A. 82a-1041 authorizes groundwater management districts to develop local enhanced management areas (LEMA) that address any of the criteria in K.S.A. 82a-1036(a)-(d), which include groundwater declines, waste of water, and the unreasonable deterioration of water quality. K.S.A. 82a-1041(k) directs the Chief Engineer to adopt rules and regulations to effectuate and administer LEMAs. There are currently three LEMAs in place, one of which was renewed for a second five-year term beginning in 2018. All active LEMAs include mandatory reductions in water use to achieve a total savings in water use. While K.S.A. 82a-1041 already requires substantial due process and specific procedural protections for water right owners, including at least two public hearings, these regulations reflect the lessons learned from previous hearing processes and from a district court challenge which upheld a LEMA order. They also generally provide guidance as to the specific information that is most helpful for a hearing process, the specific hearing procedures to be followed, and procedures for later modifying existing LEMAs. A summary of the proposed regulations and their economic impact is as follows:

K.A.R. 5-19-1 – Provides definitions for relevant terms used throughout the regulations.

K.A.R. 5-19-2 – Sets forth the requirements for a LEMA plan and provides that the Kansas Department of Agriculture's Division of Water Resources may assist in developing a plan or may informally review a plan before it is submitted to the Chief Engineer for formal review.

K.A.R. 5-19-3 – Sets forth the requirements for proceedings conducted for the designation of a LEMA. This regulation provides that the Chief Engineer may preside over a public hearing for such purpose or designate a presiding officer to do so. This regulation sets out the authority and responsibilities of the hearing officer as well as the rights and obligations of the parties to a LEMA proceeding.

K.A.R. 5-19-4 – Provides that the board of directors or staff of a groundwater management district ("GMD") shall give due consideration to past voluntary reductions in water use that resulted in water conservation when determining water quantity allocations or eligible acres under a LEMA plan, if the plan's allocations or eligible acres are based on past water use. The regulation further

provides that, if a GMD determines that past voluntary reduction in water use has been accomplished through management or conservation practices, an allocation or determination of eligible acres under the LEMA plan, or any average used to calculate the same, may be adjusted based on the amount of water conserved for each year that the conservation measure was in place. Finally, this regulation provides that a GMD, in consultation with the Chief Engineer, develop any methods or criteria for determining reductions in water use that resulted in voluntary conservation as may be suitable to local conditions.

K.A.R. 5-19-5 – Sets forth the requirements for implementing changes to a LEMA plan after a LEMA has been designated, including changes resulting from an informal review of the plan by the GMD board of directors or a formal review by the Chief Engineer.

Economic Impact Statement for K.A.R. 5-19-1 through K.A.R. 5-19-5:

These regulations are not mandated by the federal government. Contiguous states do not have a similar law in place.

The proposed rules and regulations will not enhance or restrict business activities any further than the development of a LEMA already impacts such activities. The regulations provide procedural steps prior to the adoption or amendment of a LEMA and do not further impact business activities. If there is any impact, it is only to expand the due process and information made available to individual water right owners prior to establishment of a LEMA.

The regulations themselves will not have a direct economic impact on any sector, but they will provide predictability and ensure that adequate public outreach and due process is provided to water right owners prior to establishment or modification of a LEMA. While data is still somewhat limited, one study produced by Kansas State University shows that enactment of a LEMA in areas facing groundwater declines resulted in an increase of profits compared to areas just outside the LEMA area. We expect future studies and additional data to continue to be collected. (Monitoring the Impacts of the Sheridan 6 Local Enhanced Management Area, Dr. Bill Golden at https://www.agmanager.info/sites/default/files/pdf/SheridanCounty6_LEMA_2013-2017.pdf.)

Farmers, ranchers, feedlot owners, and any business that owns a water right within a groundwater management district would be directly affected by the proposed rules and regulations.

Additional costs are not anticipated because these regulations largely clarify and codify work that is already being performed. The costs are already carried by the GMDs and Division of Water Resources. These costs are mostly in the form of the additional staff time that is necessary to ensure LEMA plans were developed with adequate public outreach and that the goals, corrective controls, and benefits of the plan are clearly documented at a public hearing that provides adequate due process protections to water right owners.

Per K.S.A. 82a-1041, the Division of Water Resources will cover the costs of all public hearings necessary for (continued)

the designation of a LEMA, and any proposed LEMA plan must meet specific requirements prior to hearing proceedings being initiated so that resources are not wasted on a plan that is not sufficient.

There will be no annual implementation and compliance costs incurred by or passed along to businesses, local governments, or members of the public.

K.S.A. 82a-1041 was adopted in 2012 and there have been three LEMAs successfully adopted since then, with one LEMA being renewed for a second term with modifications to allow for a simplified process based mostly on existing data. One LEMA proposal submitted to the Chief Engineer was rejected after initial review because of various shortcomings. These regulations do not require any additional costs for either the state or groundwater management districts and mostly place into regulation current standard practice regarding hearings and LEMA plan requirements. Each local district may approach development of a LEMA differently and is free to devote whatever resources they believe necessary during that process. Though such efforts will vary widely, this codification of standard practice is not expected to result in any additional cost.

Although there will be no direct impact on cities, counties or school districts, the Kansas Association of Counties, Kansas Association of School Boards, and League of Kansas Municipalities were each provided a copy of the regulations and asked to assess the economic impact of the proposed regulations on those entities. All of these entities either did not respond or stated that they would incur no impact.

In the summer and fall of 2019, an initial copy of these regulations was shared with various stakeholders, including the Kansas Farm Bureau and the Kansas Livestock Association. Division of Water Resources staff also attended, in-person, a board meeting of each of the five groundwater management districts. Over the last 18 months, multiple in-person meetings and conference calls were conducted with these same stakeholders. In addition, a meeting regarding these regulations was held with the Kansas Water Congress, the Kansas Municipal Utilities, and various individual water users were consulted.

If it were determined that LEMAs could not be created without these rules and regulations, then excessive declines in groundwater levels will likely continue to exhaustion in some areas, thereby substantially decreasing the value of the property and the economic impact on those respective communities, including limited ability to attract new business that requires substantial water amounts to operate.

Any individual with a disability may request accommodations to participate in the public hearing and may request the proposed regulations and impact statements in an accessible format. Article 19.—SPECIFIC PLAYER LOYALTY CLUB RULES

- **111-19-114.** Rivalry Getaway drawing. (a) The Kansas lottery may conduct a drawing entitled "Rivalry Getaway" in which two Kansas lottery players will win tickets and a parking pass for the Kansas State University versus Kansas University football game at David Booth Kansas Memorial Stadium in Lawrence, Kansas on November 6, 2021. The Kansas lottery will accept entries into the drawing beginning at 12:01 a.m. on September 20, 2021. Entry deadline for the drawing will be 11:59 p.m. on October 10, 2021. The drawing will be conducted sometime after entry into the drawing has closed but before noon on October 14, 2021, at which time the winners will be announced.
- (b) Only registered Kansas Lottery PlayOn ("PlayOn") members may enter the drawing. PlayOn members must enter themselves into the drawing according to the terms and conditions of PlayOn. Entries shall not be accepted

which are submitted by any method other than through PlayOn.

- (c) A total of 249 player loyalty club points are required for a PlayOn member to enter once in the drawing. A player may enter the drawing as many times as his or her points allow, but may win only one prize package.
- (d) The procedures set forth in K.A.R. 111-18-5 for selecting winners and alternate winners shall be followed. The Kansas lottery shall award the winners selected Touchdown Club tickets for two people and a parking pass to the November 6, 2021 Kansas State University versus Kansas University football game. Each winner will also receive: pre-game hospitality; a one-night stay at the hotel designated by the Kansas University Athletics Department; choice of a Coach Lance Leipold autographed Kansas University football or a Coach Chris Klieman autographed Kansas State football; \$400 cash; and state and federal mandatory income withholding taxes paid by the Kansas lottery. The prize package is valued at approximately \$1,493.
- (e) The procedures set forth in K.A.R. 111-18-5 for contacting the winner and the claiming of prizes shall be followed, except as follows: in this promotion the 10-day deadline for the winner to return their claim form shall be seven days and commence with the date of the announcement of the winner. The Kansas lottery is not responsible for electronic malfunction or player error.
- (f) In the event any prize awarded for this drawing is postponed, changed, or canceled in whole or in part, no cash prize substitutions shall be provided.
- (g) The Kansas lottery retains the right to substitute an alternate prize of approximate equal value.
- (h) By entering the drawings, entrant agrees to PlayOn terms and conditions.
- (i) Rules applicable to this online event drawing are contained in K.A.R. 111-19-114 and K.A.R. 111-18-1 *et seq.* (Authorized by K.S.A. 74-8710 and 74-8748; implementing K.S.A. 74-8710; effective, T-111-8-23-21, Aug. 11, 2021.)

Article 501.—SOUTH CENTRAL GAMING ZONE

- **111-501-16. Definitions.** The following words and terms, when used in the game of Ultimate Texas Hold'em Poker, shall have the following meanings unless the context clearly indicates otherwise:
- (a) "Ante" or "ante wager" means an initial wager, separate from but equal in amount to the player's blind wager, required to be made prior to any cards being dealt in order to participate in the round of play.
- (b) "Blind" or "blind wager" means an initial wager, separate from but equal in amount to the player's ante, required to be made prior to any cards being dealt in order to participate in the round of play.
- (c) "Burn" means to remove the top or next card from the deck and place it face down in the discard rack without revealing it to anyone.
- (d) "Check" means that the player waives the right to place a play wager but remains in the round of play.
- (e) "Community card" means any of the five cards dealt face up in the center of the table, all of which may be used by each player and the dealer together with his

- or her own two cards to form the best possible five-card poker hand.
- (f) "Envy bonus" means the bonus for which a player qualifies if the player has bet a progressive wager, which bonus is won when any other player at the table receives a hand consisting of a straight flush or higher ranking hand using the other player's two cards and the flop.
- (g) "Flop" means the first three community cards dealt face up in the area designated for the placement of the community cards.
- (h) "Fold" means the withdrawal of a player from a round of play by discarding his or her two cards and not making a play wager.
- (i) "Hand" or "poker hand" means the highest ranking five-card hand that can be formed from the five community cards and the two cards dealt to the dealer or a player.
- (j) "Play wager" means a wager made after two cards have been dealt to each player and the dealer, which wager can be made before the flop is dealt, after the flop is dealt but before the final two community cards are dealt, or after the final two community cards are dealt but before the dealer reveals his or her two cards.
- (k) "Progressive pool" means the set percentage of all progressive wagers made in the game of Ultimate Texas Hold 'Em and any other linked progressive game that accumulates until paid to one or more winners of a progressive wager.
- (l) "Progressive wager" means an optional wager that a player may make prior to any cards being dealt that the player's two cards and the flop will constitute a three of a kind, straight, flush, full house, four of a kind, straight flush, or a royal flush, with a winning progressive wager being paid in accordance with a posted pay table regardless of the outcome of the player's hand otherwise.
- (m) "Push" means a tie or draw, and occurs if the player's five-card hand and the dealer's five-card hand are of equal rank. In a push, the dealer shall not take or pay the player's ante, blind, or play wagers.
- (n) "Rank" or "ranking" means the relative position of a card or group of cards as set forth in K.A.R. 111-501-17, "Ultimate Texas Hold'em hand rankings."
- (o) "Round of play" or "round" means one complete cycle of play during which all players playing at the table have been dealt a hand, have folded or wagered upon it, and have had their wagers paid or collected.
- (p) "Stub" means the remaining portion of the deck after all cards in the round of play have been dealt.
- (q) "Suit" means one of the four categories of cards: club, diamond, heart, or spade, with no suit being higher in rank than another.
- (r) "Trips wager" means an optional wager that a player may make prior to any cards being dealt that the player's best five-card hand will be a three-of-a-kind or better, with a winning trips wager being paid in accordance with a posted pay table regardless of the outcome of the player's hand against the dealer's hand. (Authorized by K.S.A. 74-8710 and 74-8748; implementing K.S.A. 74-8710; effective, T-111-12-22-11, Oct. 12, 2011; amended, T-111-8-23-21, Aug. 11, 2021.)
- **111-501-18.** Wagers. (a) All wagers at Ultimate Texas Hold'em shall be made by placing gaming chips or, if (continued)

applicable, a match play coupon on the appropriate betting areas of the table layout. A verbal wager accompanied by cash shall not be accepted.

- (b) All ante, blind, and trips wagers shall be placed prior to the dealer dealing the hand. Except for a "play wager" as provided in K.A.R. 111-501-19, no wager shall be made, increased, or withdrawn after the dealer begins to deal the hand.
- (c) Upon placing an ante wager and a blind wager, a player may also place a trips wager by placing a wager on the designated betting area of the layout. The outcome of the trips wager shall have no bearing on any other wager made by the player at the game of Ultimate Texas Hold'em.
- (d) Any player who places an ante wager may also make a progressive wager by placing gaming chips on the progressive wager sensor in front of their betting position prior to the dealer dealing the first card.
- (e) Play wagers shall be made in accordance with the provisions set forth in these rules.
- (f) Only players who are seated at the Ultimate Texas Hold'em poker table may place a wager at the game. Once a player has placed a wager and received cards, that player must remain seated until the completion of the round of play.
- (g) A player shall not be permitted to wager on more than one player position at an Ultimate Texas Hold'em table. (Authorized by K.S.A. 74-8710 and 74-8748; implementing K.S.A. 74-8710; effective, T-111-12-22-11, Oct. 12, 2011; amended, T-111-8-23-21, Aug. 11, 2021.)
- **111-501-19. Play.** (a) For the start of play, the dealer shall remove 5 cards from the automatic shuffler and spread those cards in the community area, then starting with the player farthest to his or her left and continuing around the table in a clockwise manner, deal the cards as follows:
- (1) Two cards at a time face down to each player who has placed wagers.
- (2) Two cards face down to the area designated for the dealer's hand.
- (b) After the dealing procedures specified above have been completed, each player shall examine his or her cards and replace the cards face down on the layout. The dealer shall then, starting with the player farthest to his or her left and proceeding in a clockwise manner around the table, ask each player if the player wishes to place a play wager prior to the dealing of the first three community cards. The player may either check or place a play wager in an amount equal to three or four times the amount of the player's ante wager.
- (c) If a player places a play wager, the wager shall be placed in the designated play betting area.
- (d) If a player checks, the player shall remain in the game and defer his or her decision to place a play wager to the next betting opportunity.
- (e) Once all players have either placed a play wager or checked, the dealer shall turn the first three cards in the community area face up.
- (f) After the flop has been turned over, the dealer shall, starting with the player farthest to his or her left and proceeding in a clockwise manner around the table, ask each player who has not placed a play wager if he or she wish-

- es to place a play wager prior to the dealing of the final two community cards. The player may either check or place a play wager in an amount equal to two times the amount of the player's ante wager.
- (g) If a player places a play wager, the wager shall be placed in the designated play betting area.
- (h) If a player checks, the player shall remain in the game and defer his or her decision to place a play wager to the next betting opportunity.
- (i) Once all players have either placed a play wager or checked, the dealer shall then turn the next two cards in the community area face up.
- (j) After the final two community cards have been turned face up, the dealer shall, starting with the player farthest to his or her left and proceeding in a clockwise manner around the table, ask each player who has not yet placed a play wager whether he or she wishes to fold his or her hand or place a play wager equal in amount to his or her ante wager.
- (k) If a player places a play wager, the wager shall be placed in the designated play betting area.
- (l) If a player folds, the ante and blind wagers of the player shall be collected by the dealer and placed in the table inventory container.
- (m) If the player has also placed a trips wager, the dealer shall place the cards of the player face down underneath the player's trips wager pending its resolution at the conclusion of the round of play.
- (n) If the player has not placed a trips wager, the dealer shall immediately spread the cards of the folded hand face down and place them back in the shuffle machine's discard area.
- (o) After each player has either folded or placed a play wager, the dealer shall then turn his or her two cards face up, position his or her cards near the three community cards that can be used to form the best possible five-card hand and announce the dealer's hand to the players.
- (p) If the dealer's best possible five-card hand is lower than a pair, the dealer shall, starting with the player farthest to the dealer's right who has placed a play wager and proceeding in a counterclockwise manner around the table, return each player's ante wager and resolve all other wagers in accordance with subsection (q) below.
- (q) If the dealer's best possible five-card hand is a pair or above, the dealer shall, starting with the player farthest to the dealer's right who has placed a play wager and proceeding in a counterclockwise manner around the table, turn the two cards of each player who has placed a play wager face up and announce the best possible five-card poker hand that can be formed using the player's two cards and the five community cards. The wagers of each player shall be resolved one player at a time regardless of outcome. After all wagers placed by a player are settled, the player's cards shall then be immediately collected by the dealer and placed back in the shuffle machine's discard area.
- (r) If the player's five-card hand is ranked lower than the dealer's five-card hand, the player shall lose and the dealer shall immediately collect any ante, blind and play wagers made by the player.
- (s) If the player's five-card hand is ranked higher than the dealer's five-card hand, the player shall win and the

dealer shall pay any ante, blind and play wagers made by the player provided that the blind wager shall not be paid unless the player's winning hand has a rank of straight or higher.

(t) If the player's five-card hand and the dealer's fivecard hand are of equal rank, the player's hand shall be a push. In such case, the dealer shall not collect or pay the player's ante, blind, or play wagers.

(u) After settling a player's ante, blind, and play wagers, the dealer shall settle any trips wager made by the player by determining whether the player's five-card hand qualifies for a payout in accordance with K.A.R. 111-501-20. A winning trips wager shall be paid without regard to the outcome of any other wager made by the player.

(v) A player making the progressive wager also qualifies to win an envy bonus. If any player at the table is dealt a hand that wins a progressive bonus, all other players who made a progressive wager win the envy bonus. The player dealt the hand that wins the progressive bonus shall not be paid an envy bonus but shall only be paid the applicable progressive prize.

(w) The dealer shall pay all envy bonuses at the end of the round. If more than one hand triggers an envy bonus, then multiple envy bonuses may be paid.

(x) After settling a player's ante wager, street wagers, and three card bonus wager, the dealer shall settle any progressive wagers. (Authorized by K.S.A. 74-8710 and 74-8748; implementing K.S.A. 74-8710; effective, T-111-12-22-11, Oct. 12, 2011; amended, T-111-8-23-21, Aug. 11, 2021.)

111-501-20. Payout odds. (a) Each winning ante and play wager shall be paid at odds of 1 to 1.

(b) If a player's five-card hand ranks higher than the dealer's five-card hand, the player shall be paid on the player's blind wager in accordance with the following odds:

Straight flush	50 to 1*
Four-of-a-kind	10 to 1*

*This does not include the return of the player's original bet.

(c) Players shall be paid on each winning trips wager at no less than the odds set forth in the alternative pay table set forth below that is implemented by the lottery gaming facility manager as approved by the executive director of the Kansas lottery:

(d) Players shall be paid on each winning progressive wager in accordance with the following pay tables based upon either a \$1 or \$5 progressive wager. The prizes for a royal flush or straight flush are for a percentage of the funds in the progressive pool at the time of the win:

Prizes do not include the return of the player's original wager and only the two prizes denoted as percentages shall be paid out of the progressive pool.

- (e) The minimum progressive wager shall be in the amount of either \$1.00 or \$5.00 as posted at each table that offers the progressive wager.
 - (f) The progressive pool shall be funded as follows:
- (1) The casino manager shall initially contribute \$10,000 if the minimum progressive wager is \$1.00 or shall initially contribute \$50,000 if the minimum progressive wager is \$5.00 to establish the beginning amount for the progressive pool. The progressive pool will be replenished in those same amounts each time the 100% progressive prize is awarded; and
- (2) 21% of each progressive wager shall be added to the progressive pool.
- (g) If during the same round of play one or more players are entitled to 100% of the progressive pool and one or more players are also entitled to 10% of the progressive pool, the winning player farthest to the right of the dealer shall first receive either 100% or 10% of the progressive pool, as applicable. After paying the player farthest to the right of the dealer and deducting that amount from the progressive pool, working from that player to the dealer's left each player winning a share of the progressive pool shall be paid either 10% of the amount then remaining in the progressive pool or 100% of the remaining amount, as applicable.
- (h) The following rules regarding irregularities shall apply:
- (1) If any card dealt to the dealer in Ultimate Texas Hold'em is exposed prior to each player having either folded or placed a play wager, all hands shall be void. Notwithstanding the foregoing, if a player has placed a trips wager, the community cards shall be dealt and each trips wager shall be settled.
- (2) A card that is found face up in the shoe or the deck while the cards are being dealt shall not be used in the game and shall be placed in the discard rack. If more than one card is found face up in the shoe or the deck during the dealing of the cards, all hands shall be void and the cards shall be reshuffled. Notwithstanding the foregoing, if the card(s) are found face up after each play-

er and the dealer has received his or her initial two cards, the community cards shall be dealt and any trips wager shall be settled in accordance with the payout odds set forth above.

- (3) A card drawn in error without its face being exposed shall be used as though it was the next card from the shoe or the deck.
- (4) If a player is dealt an incorrect number of cards, that player's hand shall be void. If the dealer is dealt an incorrect number of cards, all players' hands shall be void unless the dealer can deal himself or herself the correct number of cards in sequence, provided that such cards have not already been turned face up and the deck contains the correct number of cards.
- (5) If an automated card shuffling device is being used and the device jams, stops shuffling during a shuffle,

or fails to complete a shuffle cycle, the cards shall be reshuffled.

- (6) If an automated dealing shoe is being used and the device jams, stops dealing cards, or fails to deal cards during a round of play, the round of play shall be void and the cards shall be removed from the device and reshuffled with any cards already dealt.
- (7) Any automated card shuffling device or automated dealing shoe shall be removed from a gaming table before any other method of shuffling or dealing may be utilized at that table. (Authorized by K.S.A. 74-8710 and 74-8748; implementing K.S.A. 74-8710; effective, T-111-12-22-11, Oct. 12, 2011; amended, T-111-8-23-21, Aug. 11, 2021.)
