In order to be considered in formulating a final permit decision, written comments must be received no later than 12:00 p.m. Monday, November 15, 2021.

A person may request a public hearing be held on the proposed permit. The request for a public hearing shall be in writing and set forth the basis for the request. The written request must be submitted to Rumela Bhadra, KDHE BOA, 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366, no later than 12:00 p.m. Monday, November 15, 2021, in order for the Secretary of Health and Environment to consider the request.

The U.S. Environmental Protection Agency (EPA) has a 45-day review period, which will start concurrently with the public comment period, within which to object to the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the EPA to review the permit. The 60-day public petition period will directly follow the EPA's 45-day review period. Interested parties may contact KDHE to determine if the EPA's 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. KDOT is seeking consultant services to prepare preliminary engineering and construction drawings for the K-96 Pavement Replacement and Expansion Project in Sedgwick County. Consultant will complete full survey and existing right of way survey along the entire project limits, including sideroad improvements, to be completed June 1, 2022. Consultant will include the development of a traffic and safety study, surveying, interchange layout, and scoping estimates for alternatives to be completed by May 1, 2022. **Establishing the Office of Public Advocates**

**WHEREAS**, Kansas is committed to the continued well-being of its citizens and families;

**WHEREAS**, ensuring the effective delivery of public human services is an essential component of our support for healthy families;

**WHEREAS**, improved coordination among the Department for Children and Families, the Department for Aging and Disability Services, the Department of Health and Environment, and other executive branch agencies is vital to the successful delivery of services for the protection and care of Kansans; and

**WHEREAS**, independent advocates tasked with advocating for and assisting those who rely on human services will ensure that citizens receive assistance resolving their complaints and concerns and will improve the operations and responsiveness of Kansas government.

**NOW, THEREFORE**, pursuant to the authority vested in me as Governor of the State of Kansas, I hereby establish the Office of Public Advocates and order the following:

*(continued)*

1. The Office of Public Advocates shall consist of the following entities:
  - a. The Long-Term Care Ombudsman, whose position was established pursuant to K.S.A. 75-7301, *et seq.*, and is already attached to the Department of Administration; this order does not affect the provisions of K.S.A. 75-7301, *et seq.*;
  - b. The KanCare Ombudsman, who shall be transferred from the Kansas Department of Aging and Disability to the Office of Public Advocates by way of this Executive Order and who shall be appointed by the Governor to serve for a term of five years, and may continue to serve beyond such five-year term if needed until a successor is appointed;
  - c. The Division of the Child Advocate, created by separate executive order; and
  - d. Any additional entities or offices created by future administrative action or legislative enactment.
2. The Office of Public Advocates shall be attached to the Department of Administration and located in Topeka, Kansas.
3. The Secretary of the Department of Administration shall provide such technical assistance and advice as the Secretary deems reasonable and necessary to assist the Office of Public Advocates and its entities to function as independent state officials or agencies.
4. Neither the Secretary of the Department of Administration nor the Department of Administration shall have authority over the Office of Public Advocates.

This document shall be filed with the Secretary of State as Executive Order No. 21-27 and shall become effective immediately.

**Executive Order No. 21-28**

**Establishing the Division of the Child Advocate**

**WHEREAS**, ensuring safe and healthy childhoods is of the highest importance to the state of Kansas;

**WHEREAS**, increasing support for families, protecting of Kansas children from harm, and ensuring adequate care are vital to improving the delivery of child welfare services;

**WHEREAS**, independent oversight and greater accountability are critical components of safeguarding Kansas children and deepening confidence in the child welfare system; and

**WHEREAS**, to systematically improve the protection of Kansas children, there must be effective accountability mechanisms, including the impartial review of policies, procedures, and practices of actors in the child welfare

system and the evaluation of concerns voiced by children and families.

**NOW, THEREFORE**, pursuant to the authority vested in me as Governor of the State of Kansas, I hereby establish the Division of the Child Advocate and order the following:

1. The Division of the Child Advocate shall be a part of the Office of Public Advocates, as established by Executive Order 21-27, and shall be attached to the Department of Administration and located in Topeka, Kansas.
2. The Secretary of the Department of Administration shall provide such technical assistance and advice as the Secretary deems reasonable and necessary to assist the Division of the Child Advocate to function as an independent state agency.
3. The Secretary of the Department of Administration and the Department of Administration shall have no authority over the Division of the Child Advocate.
4. The Division of the Child Advocate shall be under the direct supervision of the Child Advocate. Employees in the division shall be employed by and be responsible to the Child Advocate who shall fix the compensation of each such employee.
5. The Child Advocate shall possess a professional degree in law, social work, public health, or a related field and be qualified by reason of education, experience, and expertise to perform the duties of the office. The Advocate shall have experience in child welfare, and in federal and state laws and policies governing abused, neglected, and dependent children. The Child Advocate shall be appointed by the Governor for a term of five years and may continue to serve beyond such five-year term if needed until a successor is appointed.
  - a. The Child Advocate shall not be a current or former executive of the Department for Children and Families or any current child welfare case management grantee, unless that individual is 12 months removed from their period of service with DCF or such child welfare case management grantee.
6. The Child Advocate shall be in the unclassified service and shall receive an annual salary set by the Governor’s Office. That salary may be increased but not diminished during service.
7. The purpose of the Division of the Child Advocate is to ensure that children and families receive adequate coordination of child welfare services, for child maltreatment prevention, protection and care through services offered by the Department for Children and Families, the Department for Aging and Disability Services, the Department of Corrections, the Department of Health and Environment and juvenile courts. The Division of the Child Advocate shall have access to appropriate information to assist in fulfilling this purpose, in accordance with applicable Kansas law, including K.S.A. 38-2212(c)(13) and 38-2213(c)(7) and/or as authorized by court order.

8. The Division of the Child Advocate shall:
  - a. Address complaints made by or on behalf of a child in the custody of the Secretary for the Department for Children and Families or alleged to be a Child In Need of Care that relate to state agencies, service providers, including contractors, subcontractors and any juvenile court, that may adversely affect the health, safety, welfare or civil or human rights of such child;
  - b. Establish a procedure for receiving, processing, responding to and resolving such complaints;
  - c. Compile, collect and preserve a record of complaints received and processed that may reveal concerning patterns to be addressed;
  - d. Submit any findings and recommendations to the Department for Children and Families and recommend changes to the policies and procedures to improve the delivery of child welfare services or the function of any entity review pursuant to subsection (9)(c);
  - e. Make inquiries and review relevant information and records the division deems necessary for investigations required by subsections (9)(a) and (c);
  - f. Recommend changes to policies, procedures or adopted or proposed rules and regulations of any state or local agency that adversely affect or may adversely affect the health, safety, welfare or civil or human rights of any child;
  - g. Analyze and monitor the development and implementation of federal, state and local laws, rules and regulations and policies with respect to child welfare services in the state and recommend changes in such laws, rules and regulations and policies to the Department for Children and Families, Department for Aging and Disability Services, the Department of Health and Environment, the Department of Corrections, juvenile courts, the legislature and the governor;
  - h. Inform and educate children, their guardians and families of the child's rights and entitlements under state and federal laws;
  - i. Fulfill responsibilities in this section guided by generally accepted principles of best practices in child welfare;
  - j. Provide the Department for Children and Families with a notice of availability that describes the division and procedures for contacting the division.
  - k. Maintain a publicly available website, and
  - l. Publicize and notify individuals of the division's services, purpose, and contact information.
9. The Division of the Child Advocate may:
  - a. Access records as provided in K.S.A 2020 Supp. 38-2201 *et seq.* and 38-2301 *et seq.*, and amendments thereto, related to complaints received;
  - b. Access all records of child abuse and neglect maintained by the Secretary of Children and Families related to complaints received;
  - c. Communicate privately with any child or child's siblings, after consultation with treatment professionals and service providers, and with anyone working with the child, including the family, relatives, employees of the Department for Children and Families, Department for Aging and Disability Services, juvenile courts and other persons or entities providing treatment and child welfare services to such child;
  - d. Work in conjunction with guardians ad litem;
  - e. File amicus curiae briefs of the findings and recommendations of the division in appeals from child in need of care matters;
  - f. Initiate meetings with personnel from the Department for Children and Families, Department for Aging and Disability Services, and juvenile courts;
  - g. Establish local panels on a regional or county basis to adequately and efficiently carry out the functions and duties of the office and address complaints in a timely manner as appropriate;
  - h. Conduct an independent review of any policy, procedure or practice that is the subject of a complaint submitted as provided in this section.
    - i. Nothing in this section shall create a just cause for delay of court proceedings or excuse any court, county attorney or district attorney, guardian ad litem or other agency from their duties in proceedings related to a child.
    - ii. No review of any complaint shall require any licensed professional to engage or not engage in conduct required or prohibited by any governing professional code of responsibility or conduct.
10. The Secretary for the Department for Children and Families and the Division of the Child Advocate shall enter into agreements for the provision of financial assistance to the Division of the Child Advocate by the Department for Children and Families from available state and federal funds of the Department for Children and Families. This financial assistance shall be to assist the Division of the Child Advocate's services in accordance with this order, applicable federal programs, and the provisions of this section. Such agreements shall respect the independent nature of the Division of the Child Advocate.
11. Any relevant state agency and their agents, including the Department for Children and Families, the Department for Aging and Disability Services, the Department of Corrections, and the Department of Health and Environment, shall:
  - a. Allow employees of such department, agency, or agents to file a complaint with or provide information to the office without supervisory approval;
  - b. Not willingly interfere with or obstruct any of the division's duties provided by the executive order;
  - c. Promptly meet and consult with the division upon request of the division.

12.No person within the executive branch shall take reprisal or retaliatory action against any recipient of child welfare services or employee of the Department for Children and Families and such department’s grantees, the Department for Aging and Disability Services, the Department of Corrections, the Department of Health and Environment for any communication made or information given to the Division of the Child Advocate for the purpose of compliance with this executive order.

- a. No employee of the Division of the Child Advocate shall:
  - i. Knowingly disclose false information; or
  - ii. disclose confidential information without lawful authority
- b. As used in this section, “reprisal or retaliatory action” includes, but is not limited to:
  - i. Letters of reprimand or unsatisfactory performance evaluations;
  - ii. transfer;
  - iii. demotion;
  - iv. reduction in pay;
  - v. denial of promotion;
  - vi. suspension;
  - vii. dismissal; and
  - viii.denial of employment

13.On or before the first day of the legislative session in 2022, and each year thereafter, the Child Advocate shall submit an annual report to the Governor, the Chief Justice and/or the Office of Judicial Administration, the Secretary of Administration, the Secretary for Children and Families, the Joint Committee on Child Welfare Oversight, the House Committee on Children and Seniors or other relevant House Committee, the Senate Committee on Public Health or other relevant Senate Committee, and other relevant legislative committees. Such report shall include, but not be limited to, the number of complaints received by the Division of the Child Advocate, the disposition of such complaints, the number of children involved in such complaints, the state entities named in such complaints, whether such complaints were found to be substantiated and any recommendations for improving the delivery of child welfare services to reduce complaints or improving the function of the Division of the Child Advocate. The report shall remain confidential until its submission to the entities outlined in this section.

- a. Such reports shall not include names or personally identifiable information of children, guardians or families in complaints.

This document shall be filed with the Secretary of State as Executive Order No. 21-28 and shall become effective immediately.

The Kansas Board of Regents will conduct a public hearing to consider the revocation of K.A.R. 88-29-12, 88-29-13, 88-29-14, 88-29-15, 88-29-16, 88-29-17, 88-29a-1, 88-29a-5, 88-29a-6, 88-29a-7, 88-29a-8, 88-29a-8c, 88-29a-9, 88-29a-10, 88-29a-11, 88-29a-18, 88-29a-19, 88-29b-1, 88-29b-5, 88-29b-6, 88-29b-7, 88-29b-8, 88-29b-8c, 88-29b-9, and 88-29b-10; the amendment of K.A.R. 88-29a-7a, 88-29b-3, 88-29b-4, 88-29b-7a, 88-29c-1, 88-29c-5, 88-29c-7, 88-29c-9, 88-29d-1, 88-29d-5, 88-29d-7, 88-29d-9, and 88-29d-10; and proposed new regulations K.A.R. 88-29c-6,

A summary of the proposed regulations and the economic impact statement of the regulations follows:

The overall purpose for the proposed amendments, new regulations, and revocations for Article 29b and Article 29d is to establish different criteria, beginning with the summer 2022 cohort, for admission to the University of Kansas of first-time freshmen who have graduated from an accredited high school.

With the onset of the COVID-19 pandemic in spring of 2020, ACT/SAT testing sites were shut down and in-person testing appointments were cancelled. Since many applicants were not able to take either entrance exam, and therefore weren't able to meet the guaranteed admission requirements at the University of Kansas, the University had to refer those applications to a review committee for consideration.

Currently, the qualified admission regulations applicable to the University of Kansas offer two guaranteed admission options:

1. 21+ ACT and a minimum 3.25 cumulative high school GPA or
2. 24+ ACT and a minimum 3.0 cumulative high school GPA.

Both of the options require an ACT score and both options also require that a student achieve at least a 2.5 GPA on any transferable college course work taken while in high school.

The Board of Regents is proposing to replace these two guaranteed admission options for the University of Kansas qualified admissions with the following two options:

1. 21+ ACT and a minimum 2.0 cumulative high school GPA or
2. minimum 3.25 cumulative high school GPA<sup>1</sup> regardless of test score.

Both of the above options would require a student to achieve at least a 2.0 GPA on any transferable college course work taken while in high school.

These changes would allow for a test-optional guaranteed admission alternative at the University of Kansas as already exists at the other state universities.

Also, for freshmen admission to the University of Kansas currently, there is an application deadline for guaranteed admission, which is February 1. Applications received after February 1 are referred to the review committee, regardless of whether they meet the ACT and GPA requirements. The Board is proposing a removal of the February 1 deadline for all categories of students thus giving more prospective students the opportunity for guaranteed admission.

The new University of Kansas criteria would be established by amendments to existing regulations that will take effect with the review of applications for the 2022 summer session.

Each of the new regulations in Article 29c and Article 29d will replace existing regulations in Article 29a and Article 29b that are being revoked. The goal is to have the majority of the qualified admissions regulations in just the two newest Articles, 29d for the University of Kansas and 29c for the other five state universities, to make navigating the regulations simpler for students, families, high school administrators and other stakeholders. At this time, the Board of Regents is proposing revocation of 25 Article 29, Article 29a and Article 29b regulations.

The remainder of the proposed amendments are to update internal references.

There is no anticipated economic impact on Kansas high schools from these amendments. The University of Kansas may see an increase in enrollment as more students become eligible for admission and may therefore choose to apply to that institution. If this occurs, and to the extent these students would have chosen to attend other institutions in the state if not eligible for admission to the University of Kansas, those other institutions (some public and some private) may see a decline in enrollment and the students/parents may see a difference in the net cost of attendance they would incur (higher or lower depending on each student's other options as well as potential financial aid awards). However, there are too many factors that go into students' decisions whether and where to attend a postsecondary educational institution to estimate the impact of these regulations on any individual student or institution. Any implementation and compliance costs on businesses, business sectors, public utility ratepayers, other individuals and local government units are expected to be negligible.

There will be no economic impact on other public agencies or private businesses as a result of these reg-

ulations and the regulations will neither enhance nor restrict business activities and growth other than as previously mentioned.

A summary of the proposed regulations and estimated economic impact follows:

#### Summary of Regulations:

**K.A.R. 28-1-40. Definitions.** In addition to the terms defined in L. 2021, ch. 116, sec. 38, and amendments thereto, defines the terms department, personal information, protected health information, and third party, as used in L. 2021, ch.116, sec. 38, and amendments thereto.

**K.A.R. 28-1-41. Contact tracers.** Specifies the qualifications and training requirements and the oath or affirma-

tion for individual contact tracers acting under the authority of the secretary or a local health officer.

**K.A.R. 28-1-42. Contact data; communication with contacts.** Specifies the personal information, including name, date of birth, and sex, that may be collected for any contact by an individual acting as a contact tracer under the authority of the secretary or a local health officer. Specifies the health data, including vaccination and testing status, that may be collected for any contact by an individual acting as a contact tracer under the authority of the secretary or a local health officer. Provides the text for a contact tracer to use whenever communicating with a contact. Requires that a contact tracer document whether the text was provided and the contact's responses to the questions.

**K.A.R. 28-1-43. Surrender or destruction of contact data.** Sets forth when contact tracers must surrender contact data to the secretary or local health officer and when contact data must be destroyed safely and securely in a manner approved by the secretary when contact data is no longer necessary for the purpose of contact tracing.

**K.A.R. 28-1-44. Sunset provision.** Specifies that K.A.R. 28-1-40 through 28-1-43 will have no force and effect after June 30, 2022.

#### Economic Impact:

**Cost to the agency:** The proposed regulations will result in minimal costs to KDHE that can be absorbed in the ongoing KDHE budget. KDHE has overseen contact tracing for a number of years, working with local health departments and businesses.

**Cost to the public:** KDHE does not anticipate that any costs will be passed to members of the public because of the proposed regulations. These regulations do not impose costs on businesses and economic development.

**Cost to other governmental agencies or units:** The proposed regulations will impose costs on local health departments. However, KDHE estimates that the annual and total implementation and compliance costs of these regulations on local health departments will be minimal.

While these proposed regulations will only result in minimal costs, the cost of contact tracing due to COVID-19 will be extensive.
