Pursuant to K.S.A. 82a-1041, the Western Kansas Groundwater Management District No. 1 (GMD No. 1) has requested the designation of the Four County Local Enhanced Management Area (Four County LEMA) in a designated area in Greeley, Lane, Scott, and Wallace counties within the boundaries of GMD No. 1. The plan for the proposed designation of the Four County LEMA was previously submitted to the chief engineer by GMD No. 1 and was found to be acceptable for further consideration.

Therefore, the chief engineer has scheduled an initial public hearing pursuant to K.S.A. 82a-1041. The hearing will be held at 9:00 a.m. (CDT) October 17, 2022, at the William Carpenter Building, Scott County Fairgrounds, 608 N. Fairground Rd., Scott City, Kansas. A secondary location with virtual access to the hearing will also be available at Risen King Community Church, 504 Chesley Ave., Weskan, Kansas. The hearing will continue as long as is necessary for a full disclosure of relevant facts. If a full disclosure of relevant facts cannot be achieved on October 17, 2022, the hearing will continue on a future date that allows adequate notice to be given as required by K.S.A. 82a-1041.

The chief engineer has also scheduled a pre-hearing conference to take place prior to the hearing. The pre-hearing conference will be held virtually via Zoom at 10:00 a.m. (CDT) September 27, 2022. Members of the public who wish to attend the prehearing conference must pre-register. A link to pre-register is located at http://www.agriculture.ks.gov/FourCountyLEMA and

can also be obtained by contacting Ronda Hutton at 785-564-6715 or ronda.hutton@ks.gov. The chief engineer may complete the hearing without the participation of any party who fails to participate in the pre-hearing conference, the hearing, or any other stage of the proceedings. At this time, the formal parties to the hearing are the Kansas Department of Agriculture's Division of Water Resources, 1320 Research Park Dr., Manhattan, KS 66502 and GMD No. 1, 906 W. 5th, PO Box 604, Scott City, KS 67871.

At the hearing, the chief engineer will serve as the hearing officer. The hearing will be conducted pursuant to K.S.A. 82a-1041, K.A.R. 5-19-3, and K.A.R. 5-19-5 and will determine whether one or more of the circumstances specified in K.S.A. 82a-1036(a) through (d), and amendments thereto, exist within the boundaries of the proposed LEMA; whether the public interest of K.S.A. 82a-1020, and amendments thereto, requires that one or more corrective control provisions be adopted; and whether the geographic boundaries of the proposed LEMA are reasonable. If the chief engineer's findings as to all of these factors are favorable, then the chief engineer will hold a subsequent public hearing as required by K.S.A. 82a-1041, at a future date that allows adequate notice to be given as required by that statute.

Anyone may submit written or oral comments to be included in the hearing record. Oral comments will be accepted only from in-person attendees at the hearing locations in Scott City, Kansas and Weskan, Kansas. Written comments may be submitted at the public hearing, at either location, or sent to the Four County LEMA, c/o Ronda Hutton, 1320 Research Park Dr., Manhattan, KS 66502; faxed to 785-564-6777; or emailed to ronda. hutton@ks.gov. Written comments may be submitted until October 27, 2022 and must be postmarked by that date. After that date, the chief engineer will close the record of the initial hearing and will determine whether a subsequent hearing to consider the designation of the Four County LEMA should be held.

A person may request a public hearing be held on the proposed permit. The request for a public hearing shall be in writing and set forth the basis for the request. The written request must be submitted to Cathy Richardson, KDHE BOA, 1000 SW Jackson, Suite 310, Topeka, KS 66612-1366, no later than 12:00 p.m. Monday, October 10, 2022, in order for the Secretary of Health and Environment to consider the request.

The U.S. Environmental Protection Agency (EPA) has a 45-day review period, which will start concurrently with the public comment period, within which to object to the proposed permit. If the EPA has not objected in writing to the issuance of the permit within the 45-day review period, any person may petition the administrator of the EPA to review the permit. The 60-day public petition period will directly follow the EPA's 45-day review period. Interested parties may contact KDHE to determine if the EPA's 45-day review period has been waived.

Any such petition shall be based only on objections to the permit that were raised with reasonable specificity during the public comment period provided for in this notice, unless the petitioner demonstrates that it was impracticable to raise such objections within such period, or unless the grounds for such objection arose after such period. Consultant Prequalification

Consulting firms interested in providing service on a given project must be prequalified by KDOT in one of each of All the following category bullets:

- 211 Highway Design–Major Facility OR 212 Highway Design–Minor Facility (see "FY27 PBRP.xlsx") and
- 221 Non-Standard Span Bridge Design OR 222 Standard Span Bridge Design (see "FY27 PBRP.xlsx")

- 301 Land Surveying and

In addition, consultants hoping to execute projects which will begin at Discovery Phase must be prequalified in Category 201 Location and Design Concept Studies/Corridor Studies.

Tabulated information shall not be relied upon in design. It is being provided for the convenience of consultants, specifically to aid in their decision making about which projects they are interested in executing.

Anticipated Consultant Scope

The scope of services required will vary for each project and may include Survey Services, Right of Way Services, Discovery Phase Services, Preliminary Design Services, Final Design Services, Environmental Documentation Preparation (Permitting). Initial agreements will be signed for the first required phase of each project. Subsequent phases of any particular project may be added to the selected consultant's scope via supplemental (at KDOT Secretary's discretion), are not guaranteed to progress to subsequent phases, and may be resolicited (at KDOT Secretary's discretion).

Depending on the project, KDOT anticipates some variation of the following will be included in the selected consultant's scope: land and engineering survey to support right of way development, bridge type selection, bridge design, road design, traffic engineering, hydrology/hydraulics, designer construction services, and permitting assistance for some projects. Current expectations for consultant scope and what will be provided by KDOT are detailed below. The scope included herein may not be all-inclusive and is subject to change. A scoping meeting will take place for each project after consultant selection is made.

Project Management

- Develop and communicate Project Management Plan and Quality Assurance Plan.
- Perform quality control checks according to Quality Assurance Plan.
- Provide electronic plan files compliant with KDOT Graphic Standards Manual, including CAD conformance checks and ControlCAD indexed DGN files with ProjectWise attributes.
- Provide bi-annual construction cost estimates and at major project milestones.

Road Design

- Discovery Phase (for projects listed as beginning at that phase).
- Develop plans to Materials and Research.
- Building of the existing right of way.
- Develop Preliminary Plans to Field Check.
- Perform roadway geometric design, drainage design, and roadside safety analysis. Note that, in most cases:
 - The existing horizontal and vertical alignments will be utilized for the proposed condition in most cases.
 - Retaining the existing typical section of the roadway will be a priority so that no new right of way (including temporary easements) will need to be acquired.
- Visit the project site location.

Survey and Right of Way

Bridge Design

 For some projects, the consultant will propose and evaluate different (e.g.: skewed) framing layouts for review and acceptance by the KDOT Bridge Office. Focus shall be to minimize disruption to the site and facilitate efficient construction to minimize closures.

^{**} If "Project Letting" field on a project states "Discovery," it means that KDOT intends to select a consultant to provide Discovery Phase services only (at this time) but could add subsequent phases to the selected consultant's scope (at KDOT's discretion). KDOT anticipates these will be significant and more complex discovery efforts.

^{***} For BR/serial #039, the selected consultant shall only provide bridge design services (KDOT will perform highway design for that bridge).

- In most cases, the proposed structure will need to match the existing structure's geometry (vertical, horizontal, and cross-slope). The proposed structure will need to preserve existing vertical clearance windows for feature(s) crossed.
- Bridge hydraulics for stream crossings.
- Develop Preliminary Plans to Field Check for the replacement.

Traffic Engineering

- Development of Traffic Management Plan, including coordination with the local government and KDOT office.
- Develop permanent signing and pavement marking plans.
- Develop Traffic Control Plans.
- Traffic Modeling may be required for projects which begin at Discovery Phase but likely will be performed by KDOT for projects not listed as such. See below for how Traffic Forecasting will likely be handled.

Activities to be performed by KDOT include:

- Traffic forecasting data will be provided by KDOT.
- Environmental Services, including lead paint testing and permit application.
 - Note: Technical data to support these activities will be required from the consultant immediately after field check.

The following Interim Care Facility for Individuals with Intellectual Disabilities (ICF/IID) cost center limits are being set forth for public comment. Comments should be sent to Kansas Department for Aging and Disability Services, Attn: Trescia Power, Program Finance Oversight Manager, 503 Kansas Ave., Topeka, KS 66603. The comment period will expire 30 days from the publication of this notice.

K.A.R. 30-10-214 provides for the annual review and adjustment of Class II ICF/IID cost center limits, approved by the secretary of KDADS or designee, based on current cost information supplied by the enrolled, licensed providers of ICF/IID services, and formula set forth in the Kansas State Medicaid Plan (Attachment 4.19-D, Part II, Subpart O, page 1). The formula is as follows: Total allowable costs, including an inflation factor, are compared to the amount to be reimbursed under the current limits.

The formula threshold requires that 60 percent of all ICF/IIDs are reimbursed 90 percent of their allowable costs. If less than 60 percent of the facilities are reimbursed at 90 percent of their allowable costs, then the cost center limits are adjusted until the threshold is met. The inflation factor is based on the IHS Global Insight, National Skilled Nursing Facility Market Basket Without Capital Index (IHS Index).

To determine where to make the adjustments, two major cost centers are analyzed according to the following prescription:

- Administrative costs are based on facility size
- Habilitation costs are based on facility size and level of care (LOC)

The cost analysis for SFY2022 demonstrates 80 percent of the Class II ICF/IIDs are being reimbursed at 90 percent or more of their allowable costs. Per the state plan the analysis indicates that adjustments are not required.

Opinion No. 2022-05

Synopsis: A municipal councilmember may use email addresses obtained from emails sent to the councilmember's municipally supplied email address to invite subscription to their newsletter and provide a link to their Facebook page.

Cited herein: K.S.A. 25-4169a and Opinion No. 2007-11.

Dear Ms. Owens,

We understand that you request this opinion as city attorney for Overland Park, Kansas. Our opinion regarding application of the Kansas campaign finance act, K.S.A. 25-4119e, et seq., (act) responds to your request dated July 15, 2022. Pursuant to K.S.A. 75-4303a(a), jurisdiction of the Kansas Governmental Ethics Commission (commission) is limited to applicability of the act. The commission's opinion does not address whether some other statutory system, common law theory, or agency rule or regulation applies to your inquiry.

Questions

- 1. Is it a violation of the act to extract a resident's email address from an email sent to the Councilmember at the city's email address and automatically subscribe that individual to the councilmember's newsletter?
- Is it a violation of the act to reply to a resident who would email the councilmember at the city email address with an invitation to subscribe to the

- councilmember's newsletter and/or visit the councilmember's Facebook page?
- 3. Is it a violation of the act to include a link to sign up for the newsletter and/or to visit the Facebook page in the Councilmember's signature block from the Councilmember's City email address?

Analysis and Conclusion

The Councilmember activities described in each question do not violate the Kansas campaign finance act. However, one caveat should be noted.

K.S.A. 25-4169a prohibits the use of municipal funds, equipment or supplies to expressly advocate the election or defeat of candidates for elective office. In Opinion No. 2007-11 we opined that such express advocacy is prohibited within a URL or link. When a councilmember includes a link to sign up for their newsletter or visit their Facebook page, words constituting express advocacy should not be included within the URL or link if the email is being emailed from municipally provided equipment or supplies such as computers and email addresses.

Your request includes "the Councilmember has considered sending a newsletter endorsing candidates." Many endorsements utilize express advocacy. If a newsletter that includes express advocacy is sent from equipment that is publicly funded, such as a city email address or from a city computer, this conduct would constitute a violation of K.S.A. 25-4169a.

Summaries of the proposed regulation and its economic impact follow.

K.A.R. 16-12-4—**Program requirements**: Amendments to K.A.R. 16-12-4 make effective revisions to two documents incorporated by reference, "the essential elements and standards of batterer intervention programs in Kansas" and the "certified batterer intervention program statistical report."

"The essential elements and standards of batterer intervention programs in Kansas" specifies minimum standards for batterer intervention programs certified to provide batterer intervention program (BIP) services in Kansas. The proposed changes include the addition of minimum standards for juvenile BIP due to recent changes in the Kansas Juvenile Code that allow for juveniles to be ordered in BIP classes. There are also changes in allowing unlicensed professionals who are trained as described to assist in the completion of specific forms used in the assessment process as long as the full domes-

tic violence offender assessment is reviewed and completed by a licensed professional, who meets all training requirements of an assessor as laid out in the standards. Only a licensed professional can complete the Kansas Domestic Violence Offender Assessment (KDVOA). Additional changes include adding parameters for virtual programming and a new requirement for new and certified programs to complete KBI criminal record checks for all BIP direct service staff as part of new or renewal certification processes.

The "certified batterer intervention program statistical report" is a document identifying specified statistical information submitted by certified BIPs twice yearly to the Batterer Intervention Program Unit. The proposed changes include reformatting the document and the addition of demographic and referral information categories.

Economic Impact

Certified Batterer Intervention Programs are responsible for setting the cost for services for participants. This includes the cost of assessments and group fees, which can include materials. The Office of the Kansas Attorney General does not dictate how much these services cost for each program. Programs set up their payments depending on the type of business program operated. These programs can be private business, non-profit agencies, or local, state and federal government agencies.

The cost for a KBI criminal record check for all BIP direct service staff as part of new or renewal certification is \$20.00 per individual. For programs not already performing a record check, this will be an added cost. In 2021, BIPs reported a total of approximately 130 direct service BIP staff in 41 certified BIPs, with an average of 3.2 (median 2) direct service staff per program. \$20 x 130 staff = \$2600/ 2 years = \$1300/year (or \$20 x 3.2 = \$64/ 2 years= \$32/year/program, based on average number of direct service staff reported by BIPs in 2021).

Revisions also include minimum operating requirements for those programs seeking to provide virtual/tele or juvenile BIP services, but does not mandate programs provide these services. If programs choose to provide services in these capacities, those programs may incur additional operational costs.

K.A.R. 102-1-1 and K.A.R. 102-1-5a language is being changed to allow individuals seeking licensure as Licensed Psychologists to attain all required supervision hours either in person or by televideo, rather than requiring some hours to be in the same physical space as the supervisor. Additionally, the modifications allow for supervision by phone, under extenuating circumstances as approved by the Board. These changes better align with statutory changes enacted for other professions under the BSRB in 2021 Senate Sub. for HB 2208.

K.A.R. 102-2-1a, K.A.R. 102-2-8, and K.A.R. 102-2-12 language is being changed to sync regulatory language with statutory language changes enacted in 2021 Senate Sub. for HB 2208, which allows individuals seeking licensure as a Clinical Level Social Worker to attain all required supervision hours either in person or by televideo, rather than requiring some hours to be in the same physical space as the supervisor; allows for supervision by phone, under extenuating circumstances as approved by the Board; allows all required postgraduate supervised hours of experience to be in person, by televideo, or by phone; and deletes previous statutory language requiring not less than 350 hours of direct client contact as

part of a practicum (other decreases in supervision hours were enacted by the 2019 Legislature). These changes also include a definition of "one-hour" to provide clarity to questions relating to the length of supervision and include changes to supervision requirements to bring the language for this profession more in line with requirements of other professions overseen by the BSRB.

K.A.R. 102-3-1a, K.A.R. 102-3-3a, and K.A.R. 102-3-7a language is being changed to sync regulatory language with statutory language changes enacted in 2021 Senate Sub. for HB 2208, which allows individuals seeking licensure as a Clinical Professional Counselor to attain all required supervision hours either in person or by televideo, rather than requiring some hours to be in the same physical space as the supervisor; allows for supervision by phone, under extenuating circumstances as approved by the Board; allows all required postgraduate supervised hours of experience to be in person, by televideo, or by phone; decreases the number of direct client contact hours during the practicum experience from 350 hours to 280 hours; and decreases the number of hours of post-graduate supervised work experience required for clinical licensure from 4,000 hours to 3,000 hours and decreases the number of direct supervision hours required for clinical licensure from 150 hours to 100 hours. The changes also provide a definition of "one-hour" and "quarter credit hour" to provide clarity to questions relating to the length of supervision and better align with other professions under the BSRB. A definition of "related field" was added to clarify what other areas of practice could qualify for licensure as a professional counselor.

K.A.R. 102-4-1a and K.A.R. 102-4-7a language is being changed to sync regulatory language with statutory language changes enacted in 2021 Senate Sub. for HB 2208, which allows individuals seeking licensure as Clinical Psychotherapists (the clinical level for Master's Level Psychologists) to attain all required supervision hours either in person or by televideo, rather than requiring some hours to be in the same physical space as the supervisor; allows for supervision by phone, under extenuating circumstances as approved by the Board; allows all required postgraduate supervised hours of experience to be in person, by televideo, or by phone; and decreases the number of direct supervision hours required for clinical licensure from 150 hours to 100 hours. These changes also provide a definition of "one hour" to provide clarity to questions relating to the length of supervision.

K.A.R. 102-5-1 and K.A.R. 102-5-7a language is being changed to sync regulatory language with statutory language changes enacted in 2021 Senate Sub. for HB 2208, which allows individuals seeking licensure as a Clinical Level Marriage and Family Therapist to attain all required supervision hours either in person or by televideo, rather than requiring some hours to be in the same physical space as the supervisor; allows for supervision by phone, under extenuating circumstances as approved by the Board; allows all required postgraduate supervised hours of experience to be in person, by televideo, or by phone; and decreases the number of hours of post-grad-

uate supervised work experience required for clinical licensure from 4,000 hours to 3,000 hours and decreases the number of direct supervision hours required for clinical licensure from 150 hours to 100 hours. These changes also include a definition of "one-hour" to provide clarity to questions relating to the length of supervision.

K.A.R. 102-7-1 and K.A.R. 102-7-6 language is being changed to sync regulatory language with statutory language changes enacted in 2021 Senate Sub. for HB 2208, which allows individuals seeking licensure as a Clinical Level Addiction Counselors to attain all required supervision hours either in person or by televideo, rather than requiring some hours to be in the same physical space as the supervisor; allows for supervision by phone, under extenuating circumstances as approved by the Board; allows all required postgraduate supervised hours of experience to be in person, by televideo, or by phone; and decreases the number of hours of post-graduate supervised work experience required for clinical licensure from 4,000 hours to 3,000 hours and decreases the number of direct supervision hours required for clinical licensure from 150 hours to 100 hours. These changes also provide a definition of "one-hour" to provide clarity to questions relating to the length of supervision.

Economic impact: There would be a small economic impact for individuals seeking a license as a psychologist, clinical social worker, clinical professional counselor, clinical psychotherapist, clinical marriage and family therapist, and clinical addiction counselor, as these applicants would be able to complete necessary supervision hours and other postgraduate supervised work experience requirements more quickly.

Temporary Administrative Regulations

Article 69.—ATHLETIC TRAINING

100-69-10. License renewal; continuing education.

- (a) As a condition of renewal, each licensed athletic trainer shall submit, in addition to the annual application for renewal of licensure, evidence of satisfactory completion of at least 20 hours of continuing education within the preceding year and proof of continuous certification in emergency cardiac care procedures including administration of an automated external defibrillator (AED) through a nationally recognized provider approved by the board. Each course approved by the board of certification for the athletic trainer shall meet this requirement.
- (1) Acceptable providers of certification in emergency cardiac care (ECC) procedures shall be those adhering to the most current international guidelines for cardiopulmonary resuscitation and emergency cardiac care.
- (2) Online ECC courses shall not be accepted, unless the provider confirms in writing that the skills were demonstrated and tested in person by a qualified instructor.

- (3) Instructor certifications shall not be accepted, unless the provider confirms in writing that the instructors are required to maintain and successfully demonstrate provider skills to renew instructor status.
- (b) Any licensee who suffered an illness or injury during the 12-month period before the expiration date of the license that made it impossible or extremely difficult to reasonably obtain the required continuing education hours may be granted an extension of not more than six months, in order to complete the continuing education requirements.
- (c) Each athletic trainer initially licensed within one year of the expiration date of the license shall be exempt from the continuing education required by subsection (a) for that first renewal period.
- (d) All continuing education shall be related to the field of athletic training and shall be presented by providers approved by the board. In order to qualify as board-approved, the continuing education shall be delivered by an approved provider or shall be intended for an audience of credentialed health care providers. The content shall be at least entry-level and shall pertain to one of the current domains of athletic training practice identified by the board. The current domains of athletic training practice identified by the board of certification of athletic trainers shall meet this requirement.
- (e) One hour shall be 60 minutes of continuing education meeting the requirements of subsection (f).
- (f) The categories of continuing education experiences shall be the following:
- (1) Category A. The number of hours for all category A continuing education experiences shall be granted upon receipt of documented evidence of attendance or documented evidence of satisfactory completion issued by a national, state, or local organization meeting the requirements of subsections (a) and (d). Category A continuing education experiences shall include the following:
- (A) Symposium. "Symposium" shall mean a conference of more than a single session organized for the purpose of discussing a specific subject from various viewpoints and by various speakers.
- (B) Seminar. "Seminar" shall mean directed advanced study or discussion in a specific field of interest.
- (C) Workshop. "Workshop" shall mean a series of meetings designed for intensive study, work, or discussion in a specific field of interest.
- (D) Conference. "Conference" shall mean a formal meeting of a number of people for a discussion in a specific field of interest.
- (E) Home study course. "Home study course" shall mean an online webinar course designed for advanced study in a specific field of interest.
- (2) Category B. Category B continuing education experiences shall include the following:
- (A) Scholarly presentations. The number of hours granted for scholarly presentations shall be the following:
- (i) 10 hours for a speaker at a clinical symposium where the primary audience is allied health care professionals; and
- (ii) five hours for a speaker at a seminar, workshop, or conference where the primary audience is allied health care professionals.

- (B) Publication activities. The number of hours granted for writing a professional publication shall be the following:
- (i) Five hours to author an article in a nonrefereed journal;
 - (ii) 15 hours to author an article in a refereed journal;
 - (iii) 10 hours to coauthor an article in a refereed journal;
 - (iv) 20 hours to author a published textbook;
 - (v) 10 hours to coauthor a published textbook;
- (vi) five hours for being a contributing author of a published textbook;
- (vii) 10 hours to author a refereed or peer-reviewed poster presentation; and
 - (viii) five hours to coauthor a poster presentation.
- (3) Category C. Category C continuing education experiences shall consist of postcertification education. The number of hours assigned to category C continuing education experiences shall be 10 hours for each credit hour for postcertification education. The content shall be related to one of the domains of athletic training.
- (4) Category D. Category D continuing education experiences shall consist of miscellaneous activities, which shall include evidence-based practice. The number of hours granted upon receipt of documented evidence of satisfactory completion for category D continuing education experiences shall be the following:
- (A) One hour shall be granted for each hour of attendance at continuing education program activities that are not approved by the board for category A or category B, but that are related to specific athletic training and sports medicine topics.
- (B) One hour shall be granted for each hour of listening to unapproved continuing education programs or other multimedia products related to one of the domains of athletic training. No more than five hours per renewal period shall be allowed.
- (g) No credit shall be granted for making any repeated presentations of the same subject matter.
- (h) No credit shall be granted for reiteration of material or information obtained from attendance at a continuing education program.
- (i) To provide evidence of satisfactory completion of continuing education, the following shall be submitted to the board:
- (1) Documented evidence of attendance at category A and category D activities;
- (2) proof of participation in category B activities, which shall include a copy of any professional publication or documentation of any presentation;
- (3) receipt and verification of completion of approved self-instruction from home study courses;
- (4) a copy of each transcript or grade report for category C activities; and
- (5) personal verification of listening to or viewing continuing education program videotapes, audiotapes, or other multimedia products, as described in paragraph (f)(4)(B). Article 73.—RADIOLOGIC TECHNOLOGISTS

100-73-7. License renewal; continuing education.

- (a) On the license renewal form, each licensed radiologic technologist shall certify either of the following:
- (1) The person completed at least 12 credits of continuing education during the 12-month period immediately preceding the license expiration date. Each person renewing a license for the first time shall be exempt from the 12-month requirement.
- (2) The person completed at least 24 credits of continuing education during the 24-month period beginning on the first day of the person's next birth month after initial certification from the American registry of radiologic technologists and extending 24 months to the end of the month before the birth month. Each subsequent 24-month period shall be measured using the same beginning and ending months.
- (b) Any licensee may request that the board grant an extension of the time to complete the required continuing education if, during the 12-month period immediately preceding the license expiration date, the person experienced an undue hardship resulting from illness, injury, or any other circumstance preventing the licensee's timely completion of continuing education.
- (c) One credit shall be 50 minutes of continuing education meeting the requirements of subsection (f).
- (d) Each person who certifies completion of continuing education shall, for at least three years following the date of certification, maintain documentation of completion that shall include one of the following:
- (1) A verification of completion issued by a national, state, or local organization meeting the requirements of subsections (f) and (g);
- (2) a copy of the written materials provided with the continuing education activity, along with documentation of all of the following:
- (A) The name, address, and telephone number of the activity sponsor and the name and telephone number of a contact person for the activity sponsor;
 - (B) the title of the continuing education activity;
 - (C) the date and location of the activity;
- (D) specification of whether the activity was presented in person or by video, satellite, or internet;
- (E) the number of continuing education credits completed;
 - (F) the activity agenda;
- (G) the name and professional biographical information of each presenter; and
 - (H) written proof of participation; or
- (3) a notarized certificate of current registration with the American registry of radiologic technologists or the nuclear medicine technology certification board.
- (e) Within 30 days following a written request by the board to a licensee, the licensee shall provide the board with proof of completion of continuing education as specified in this regulation.
- (f) The categories of continuing education experiences shall be the following:
- (1) Meetings and courses. Meetings and courses shall be planned, organized, and administered to enhance (continued)

the knowledge and skills that a radiologic technologist uses to provide services to patients, the public, or the medical profession. Meetings and courses shall include the following:

- (A) Symposium. "Symposium" shall mean a conference of more than a single session organized for the purpose of discussing a specific subject from various viewpoints and by various speakers.
- (B) Seminar. "Seminar" shall mean directed advanced study or discussion in a specific field of interest.
- (C) Workshop. "Workshop" shall mean a series of meetings designed for intensive study, work, or discussion in a specific field of interest.
- (D) Conference. "Conference" shall mean a formal meeting of a number of people for a discussion in a specific field of interest.
- (E) Home study course. "Home study course" shall mean a correspondence course designed for advanced study in a specific field of interest.
- (2) Leadership. Leadership shall include any presentation at one of the types of meetings described in paragraphs (f)(1)(A) through (D). The number of credits granted for leadership shall be the following:
- (A) Six credits for instructor or instructor-trainer at a cardiopulmonary resuscitation (CPR) course provided by the American red cross, American heart association, or American safety and health institute; and
- (B) two credits for the development of each one-hour presentation that meets the requirements of paragraph (f)(1)(A), (B), (C), or (D).
 - (3) Classwork. Classwork shall include the following:
- (A) Six credits for satisfactory completion of an advanced life support class or a pediatric life support class provided by the American red cross, the American heart association, or the American safety and health institute; and
- (B) 12 credits for each academic quarter or semester credit granted by a postsecondary educational institution in a course that is relevant to radiologic technology or patient care for which the student received a grade of at least C or its equivalent, or a grade of pass in a passfail course. Relevant courses shall include courses in the biologic sciences, physical sciences, radiologic sciences, health and medical sciences, social studies, communication, mathematics, computers, management, and education methodology.
- (g) Each continuing education activity offered using distance-learning media shall qualify for continuing education credit if the activity is in one of the categories of continuing education experiences specified in subsection (f) and meets all of the following conditions:
- (1) The activity has a mechanism in place for the user to be able to contact the provider regarding questions about the continuing education activity.
- (2) The provider of the activity evaluates the user's knowledge of the subject matter discussed in the continuing education activity.
- (3) The activity limits the amount of time within which a user can complete the activity, which shall be no more than twice the number of hours for each credit awarded for the activity.
- (4) The person or organization offering the activity provides a printed verification of completion of the ac-

Article 36.—ABSENTEE AND ADVANCE VOTING

- **7-36-7.** Processing advance voting ballot applications. This regulation shall govern the processing of each application for an advance voting ballot received by a county election officer if the applicant is registered to vote in that election officer's county and wants to receive the ballot by mail.
- (a) If the application does not contain sufficient information or if the information is illegible, the county election officer shall contact the applicant to obtain the information before election day, if practicable.
- (b) If the application is not signed or the signature on the application is not consistent with the applicant's signature on the official voter registration list, the election officer shall comply with the procedures specified in K.A.R. 7-36-9.
- (c) If the application does not contain the number of the applicant's current and valid Kansas driver's license number or nondriver's identification card number or a photocopy of any other identification specified in K.S.A. 25-2908 and amendments thereto or if the number or photocopy is illegible, the county election officer shall attempt to contact the applicant by any means to obtain the information. The county election officer shall provide the applicant with the information required by K.S.A. 25-1122(e)(2), and amendments thereto.
- (d) The county election officer may collect an applicant's current and valid Kansas driver's license number or nondriver's identification card number or a photocopy of any other identification specified in K.S.A. 25-2908, and amendments thereto. If the county election officer obtains the necessary identification number or photocopy and the identification number or photocopy is consistent with the voter registration list, the county election officer shall issue a regular advance voting ballot.
- (e) If an applicant submits a photocopy of the qualifying photographic identification document and the document contains information that is illegible or inconsistent with the information on the voter registration list, the county election officer shall attempt to contact the applicant by any means to confirm that the applicant intended to apply for an advance voting ballot and shall attempt to obtain a satisfactory photocopy of the qualifying photographic identification document.
- (f) If it is not practicable to contact the applicant before the election or if the information, signature, or photocopy provided is incomplete or inconsistent with the

voter registration list, the county election officer shall issue a provisional advance voting ballot.

- (g) The county election officer shall present each provisional advance voting ballot to the county board of canvassers for a determination of validity. If the voter provided additional information, an updated signature, or an additional photocopy upon request by the county election officer and if the information, signature, or photocopy is consistent with the voter registration list, the ballot shall be counted unless the ballot is determined to be invalid for another reason. If the voter did not provide additional information, an updated signature, or an additional photocopy upon request by the county election officer or if the information, signature, or photocopy is inconsistent with the information on the voter registration list, the ballot shall not be counted. (Authorized by K.S.A. 25-1122; implementing K.S.A. 25-1122, K.S.A. 25-1123, and K.S.A. 25-1124; effective Feb. 24, 2012; amended, T-7-5-26-22, May 26, 2022; amended Sept. 23, 2022.)
- **7-36-9.** Signature verification for advance voting by mail. (a) For purposes of this regulation, each of the following terms shall have the meaning specified in this subsection:
- (1) "Application" means the submission by a registered voter to apply for an advance voting ballot to be transmitted by mail on which the voter affixes a signature, as specified in K.S.A. 25-1122 and K.S.A. 25-1122d, and amendments thereto.
- (2) "Inconsistent," when used regarding a signature, means that the signature differs in multiple, significant, or obvious respects from the voter's signature in the voter registration database.
- (3) "Mail ballot envelope" means the envelope containing a completed ballot on which the voter affixes a signature, as specified in K.S.A. 25-1124 and K.S.A. 25-433(b) and amendments thereto.
- (4) "Match," when used regarding a signature, means that the signature is generally uniform and consistent with the voter's signature in the voter registration database.
- (5) "Signature verification" means the process to verify the authenticity of a voter's signature on applications, as required by K.S.A. 25-1122(e)(1) and amendments thereto, and on mail ballot envelopes, as required by K.S.A. 25-1124(d) and (h) and K.S.A. 25-433(e) and amendments thereto
- (b) When a county election officer receives from a voter either an application or a mail ballot envelope, the county election official shall conduct signature verification as follows:
- (1) If the signature matches the voter's signature on file, the application or mail ballot envelope shall be processed pursuant to K.S.A. 25-1134, K.S.A. 25-1135, and K.S.A. 25-1136, and amendments thereto.
- (2) If the signature on the application or mail ballot envelope is inconsistent with the voter's signature on file or there is no signature, the county election official shall attempt to contact the voter as follows:
- (A) If the voter's phone number is reasonably available, the county election official shall attempt to call the voter at least three times. The county election official shall inform the voter or leave a message with another person

- who answered the call or on voice mail of the apparently inconsistent or missing signature and the way to verify the voter's identity or correct the missing signature.
- (B) The county election official shall send to the voter by first-class mail a notice informing the voter of the apparently inconsistent or missing signature, with instructions on how to verify the voter's identity or correct the missing signature.
- (C) The county election official may also attempt to contact the voter by any other means, including electronic mail or personal visit at the voter's residence.
 - (c) The county election official shall record the following:
- (1)(A) For contact by phone, the date, time, and phone number for each call and specification of whether instructions were left by voice mail, by conversation with the voter, or by conversation with another individual;
- (B) for contact by mail, the date the letter was sent to the voter, the address to which the letter was sent, and a copy of the letter; or
- (C) for other means of contact, a general description of the means of voter contact; and
- (2) for all means of contact, specification of whether the voter corrected the missing or inconsistent signature.
- (d) If a voter receives notice of a signature that is inconsistent with the voter's signature on file, the signature deficiency may be corrected as follows:
- (1) On a mail ballot envelope, by providing an updated signature consistent with the signature on file at any time until the commencement of the county board of canvassers: or
- (2) on an application, by providing an updated signature consistent with the signature on file at any time through the Tuesday of the week preceding the election.
- (e) If a voter receives notice of a missing signature, the signature deficiency may be corrected as follows:
- (1) On a mail ballot envelope, by appearing in person before a county election official and providing a signature at any time until the commencement of the county board of canvassers; or
- (2) on an application, by submitting a new application with a signature or by appearing in person before a county election official and providing a signature at any time through the Tuesday of the week preceding the election.
- (f) Before performing signature verification, the county election official shall complete training approved by the secretary of state on procedures to determine whether a voter's signature is consistent with the signature in the voter registration database.
- (g) When conducting signature verification, the following shall apply:
- (1) The voter's signature shall be compared to as many recorded signatures as possible from the voter registration database.
- (2) Signature verification may occur by electronic device or by human inspection.
- (3) All signatures that match those in the voter registration database shall be accepted.
- (4) Before a signature on any application or mail ballot envelope is deemed inconsistent, at least two election officials who have been trained by the secretary of state shall agree that the signatures are inconsistent.

(5) Signature verification shall not be required if a voter has a disability preventing the voter from signing the ballot or preventing the voter from having a signature that matches the voter's registration form. Article 4.—QUALIFICATIONS CRITERIA— CERTIFIED RESIDENTIAL APPRAISER CLASSIFICATION

- **117-4-1.** Residential classification; education requirements. (a) Each applicant shall meet one of the following requirements:
- (1) Have a bachelor's degree or higher from an accredited four-year college or university;
- (2) have an associate's degree in a field of study related to one of the following:
 - (A) Business administration;
 - (B) accounting;
 - (C) finance;
 - (D) economics; or
 - (E) real estate;
- (3) successfully complete 30 semester hours of collegelevel courses in the following subjects, with the hours specified:
 - (A) English composition (three semester hours);
 - (B) microeconomics (three semester hours);
 - (C) macroeconomics (three semester hours);
 - (D) finance (three semester hours);
- (E) algebra, geometry, or higher mathematics (three semester hours);
 - (F) statistics (three semester hours);
 - (G) computer science (three semester hours);
- (H) business or real estate law (three semester hours);
 - (I) two elective courses in any of the following subjects:
 - (i) Accounting (three semester hours);
 - (ii) geography (three semester hours);
 - (iii) agricultural economics (three semester hours);
 - (iv) business management (three semester hours); or
 - (v) real estate (three semester hours);
- (4) successfully complete at least 30 semester hours of college-level examination program (CLEP) examinations in the following subjects:
 - (A) College algebra (three semester hours);
 - (B) college composition (six semester hours);
- (C) college composition modular (three semester hours);
 - (D) college mathematics (six semester hours);
- (E) principles of macroeconomics (three semester hours);

- (F) principles of microeconomics (three semester hours);
- (G) introductory business law (three semester hours); and
 - (H) information systems (three semester hours); or
- (5) successfully complete any combination of paragraphs (a)(3) and (4) that ensures coverage of all topics and the associated hours listed in those paragraphs.
- (b) Each applicant shall meet the following requirements:
- (1) Have received credit for 200 classroom hours in the following subjects, as specified:
 - (A) 30 classroom hours in basic appraisal principles;
 - (B) 30 classroom hours in basic appraisal procedures;
- (C) 15 classroom hours in the national uniform standards of professional appraisal practice course or its equivalent;
- (D) 15 classroom hours in residential market analysis and highest and best use;
- (E) 15 classroom hours in the residential appraiser site valuation and cost approach;
- (F) 30 classroom hours in residential sales comparison and income approaches;
- (G) 15 classroom hours in residential report writing and case studies;
- (H) 15 classroom hours in statistics, modeling, and finance;
- (I) 15 classroom hours in advanced residential applications and case studies; and
- (J) 20 classroom hours in appraisal subject matter electives, which may include hours over the minimum specified in paragraph (b)(1); and
- (2) provide evidence, satisfactory to the board, of one of the following:
- (A) Successful completion of courses approved by the board as specified in paragraph (b)(1); or
- (B) successful completion of courses not approved by the board, with evidence that the education covered all of the requirements specified in paragraph (b)(1).
- (c) Credit toward the education requirements specified in paragraph (b)(1) may also be obtained by completing a degree in real estate from an accredited degree-granting college or university approved by the association to advance collegiate schools of business or a regional or national accreditation agency recognized by the U.S. secretary of education if the college or university has had its curriculum reviewed and approved by the appraiser qualifications board (AQB).
- (d) Classroom hours may be obtained only if both of the following conditions are met:
- (1) The length of the educational offering is at least 15 classroom hours.
- (2) The applicant successfully completes an approved closed-book examination pertinent to that educational offering.
- (e) Any appraiser holding a valid state license as a real property appraiser may meet the educational requirements for the certified residential classification by performing the following:
- (1)(A) Satisfying the college-level educational requirements as specified in subsection (a); or
- (B) having a state license for at least five years immediately preceding the date of application if there has been

no record of any adverse, final, and non-appealable disciplinary action affecting the state licensed appraiser's legal eligibility to engage in appraisal practice within the five years immediately preceding the date of application for a certified residential credential; and

- (2) completing an additional 50 hours of classroom or distance education, or both, in the following subjects:
 - (A) 15 hours of statistics, modeling, and finance;
- (B) 15 hours of advanced residential applications and case studies; and
 - (C) 20 hours of appraisal subject matter electives.
- (f) The 200 classroom hours specified in paragraph (b)(1) may include a portion of the 150 classroom hours required for the licensed classification as required by K.Ā.R. 117-2-1.
- (g) A distance education course may be deemed to meet the classroom hour requirement specified in paragraph (b)(1) if all of the following conditions are met:
- (1) The course provides an environment in which the student has verbal or written communication with the instructor.
- (2) The sponsor obtains course content approval from any of the following:
 - (A) The appraiser qualifications board;

- (B) an appraiser licensing or certifying agency in this or any other state; or
- (C) an accredited college, community college, or university that offers distance education programs and is approved or accredited by the commission on colleges, a regional or national accreditation association, or an accrediting agency that is recognized by the U.S. secretary of education. Each non-academic credit college course provided by a college shall be approved by the appraiser

qualifications board or the appraiser licensing or certifying agency in this or any other state.

- (3) The course design and delivery are approved by one of the following sources:
- (A) The appraiser qualifications board;
- (B) a college that qualifies for course content approval as specified in paragraph (g)(2)(C) and awards academic credit for the distance education course; or
- (C) a college that qualifies for course content approval as specified in paragraph (g)(2)(C) with a distance education delivery program that includes a delivery system incorporating interactivity.
- (h) Each distance education course intended for use as qualifying education shall include a written examination proctored by an official approved by the college or university or by the sponsor.
- (i) Any applicant who has completed two or more courses generally comparable in content, meaning topics covered, may receive credit only for the longest of the comparable courses completed. The national uniform standards of professional appraisal practice (USPAP) course taken in different years shall not be considered repetitive.
