Notice of Available Grant Funding

Grant funds are available from the Federal John R. Justice Student Loan Repayment Program for calendar year 2023. The purpose of this grant program is to provide student loan repayment assistance for full-time local, state, and federal government public defenders and full-time local and state government prosecutors who commit to serving as public defenders and prosecutors for at least three years. Kansas has \$73,070 available for awards and will be available to prosecutors (maximum of \$36,535) and public defenders (maximum of \$36,535). Federal John R. Justice Grant funds awarded under this program are a supplement to, not a substitute for, personal student loan obligations. To be eligible to receive funding, an attorney must not be in default on repayment of any federal student loans. Notice is hereby given of the commencement of the selection process for architectural and engineering services for the Wichita State University NIAR Technology and Innovation Building. The NIAR Technology + Innovation Building has been programmed as an 85,000 square foot research facility to be located on an undeveloped 4.77 acre parcel on the Innovation campus. Comprised of six research labs (robotics and automation, emerging tech and digital manufacturing, composites, advanced machining and prototyping, and additive manufacturing) in combination with related student and faculty support spaces, this facility is organized with flexibly-designed high-bay research labs surrounding a central core of support spaces. This new NIAR building will provide an opportunity for students to engage in smart manufacturing, applied research, and training opportunities through a comprehensive center that promotes the safety, research, manufacturing, and design elements of today's aviation industry. The project construction budget is \$30,700,000.

Sealed bids for the primary spillway replacements at Floodwater Retarding Dams 7-34A and 7-4 in Finney County, Kansas will be received until 7:00 p.m. November 21, 2022, by Pawnee Watershed Joint District No. 81, PO Box 367, 20476 SE US-283 Hwy., Jetmore, KS 67854, at which time and place bids will be publicly opened and read aloud.

Description of Work

Primary spillway replacement at up to two floodwater dams located five miles apart in Finney County, Kansas. Work at FRD 7-34A includes excavating to remove existing primary spillways and installing new primary spillway consisting of 48-inch diameter precast concrete manhole and 24-inch diameter PVC pipe. Estimated

quantities include 7,850 cubic yards of excavation, 9,800 cubic yards of earthfill, installation of 188 feet of 24-inch AWWA C900 PVC pipe, 60 cubic yards of flowable fill, and appurtenant items.

Work at FRD 7-4 includes excavating to remove existing primary spillways and installing new primary spillway consisting of 48-inch diameter precast concrete manhole and 24-inch diameter PVC pipe. Estimated quantities include 6,440 cubic yards of excavation, 8,900 cubic yards of earthfill, installation of 171 feet of 24-inch AWWA C900 PVC pipe, 55 cubic yards of flowable fill, and appurtenant items.

FRD 7-4 will be considered alternate work that may be added to the contract. The successful bidder will be determined by the FRD 7-34A Bid Total.

All work shall be completed in conformance with the project construction drawings, construction specifications and Stormwater Pollution Prevention Plan.

Work Timing

The work is to commence within twenty (20) calendar days after the Notice to Proceed is issued. Notice to Proceed is anticipated to be issued on January 3, 2023. Completion of the work is desired within 150 days after such notice.

Public Notice

The Kansas Department of Health and Environment (KDHE) has received an application to expand the Champlin Tire Recycling, Inc. waste tire monofill. The requested modification would expand the total waste tire monofill site from 32.17 acres to 62.20 acres and the permitted disposal area from 13.7 acres to 31.97 acres. The permitted volume would increase from 604,000 cubic yards to 1,504,000 cubic yards. The proposed monofill expansion would accept only waste tires as defined by Kansas Statutes and would be constructed and operated in conformance with state solid waste regulations. The proposed landfill expansion site is located at 1240 S. 190th St., Pittsburg, Kansas, in the W½ of the NW¼ of Section 14, in Township 31 South, Range 24 East in Crawford County.

The Crawford County Commissioners have previously certified that the landfill is consistent with the county's solid waste management plan and local land use restrictions or zoning. KDHE has reviewed the application and found it to be in conformance with the state solid waste statutes and regulations.

KDHE is providing public notice of the intent to approve the proposed landfill expansion. However, a final decision to approve the expansion has not been made, and KDHE will consider information gathered during the public comment period before making a final decision. A copy of the administrative record which includes the permit application, engineering drawings, draft permit, and other information with respect to this permit action will be available for public review from October 27, 2022 through Monday November 28, 2022 during normal business hours at the following locations:

 - 350 crossties per mile (Satanta, Kansas to Hugoton, Kansas – 23 miles)

- Performing 3,577 flash butt welds to rail (east of Ensign, Kansas to Sublette, Kansas – 13.2 miles)
- Relaying 3.7 miles of rail in curves (spread throughout seven curves from Satanta, Kansas to just west of Hugoton, Kansas)
- Applying new ballast to 67 miles of track (Dodge City, Kansas to Moscow, Kansas)
- Surfacing 85 miles of track (Dodge City, Kansas to Hugoton, Kansas)

The objective of the project is to be able to continue to provide freight rail service, and improve it, to customers along the Satanta and Keys Subdivisions. CVR cannot provide adequate freight rail service along the 85 miles of line between Dodge City, Kansas and Hugoton, Kansas because train speeds are limited to 10 mph. The current track conditions require a two-day round trip increasing costs and limiting asset productivity. When complete, this project will increase the speed of the project area on railroad from 10 mph to 25 mph.

The project will commence upon KDOT receiving a signed and executed agreement from the Federal Railroad Administration (FRA), as well as signed and executed agreements between KDOT and CVR. The anticipated project start date is April 2023. It is expected that the project will take approximately 12 months to complete. Federal reporting will continue for three years from project completion.

- Quarterly federal financial reports (Federal Standard Form 425) with reimbursement requests and/or outlay figures for the reported quarter. This report shall be submitted on the same schedule as the quarterly progress report. The final Standard Form 425 is due within 90 days after the end of the project performance period but may be submitted as soon as all outstanding expenditures have been completed.
- Final performance report.
- Project performance measures reporting.

A brief narrative, not to exceed seven pages, detailing the consultant's ability to carry out this project – including, but not limited to: special assets, areas of expertise, and analytical tools should be included in the narrative. Proposals shall also include:

- A listing, including a brief project scope and budget, of similar projects undertaken within the last five (5) years by consultant and/or subconsultants, showing contract amounts, description of work performed and project results.
- Staff that would be assigned to this project along with their qualifications to manage this project.
- Description of the workload of staff assigned to this project during the term of the project (any reassignment of designated key staff will not occur without consultation and consent by KDOT).
- A copy of the firm's DBE Plan.
- Listing of any DBE firms that will serve as subconsultants on the project.
- A project schedule that includes, but is not limited to, demonstration of expected task completion timelines, deliverables, conference calls, meetings, on site project reviews/inspections, and project milestones.
- A detailed budget and consultant personnel time to complete the project.
- Quality Assurance/Quality Control (QA/QC) plan that will cover the entire scope of the project. The QA/QC activities should include preparation of monthly status reports, invoices, and attendance at project meetings as requested by the KDOT Project Manager. The consultant shall record and submit typed minutes, in electronic format, for all meetings to the KDOT Project Monitor within two weeks of each meeting. The consultant shall also distribute minutes to all project partners. On the first of each month, the consultant shall submit a monthly status report to the KDOT Project Monitor.

The Kansas Board of Regents will conduct a public hearing to consider amendments of K.A.R. 88-28-1, 88-28-2, 88-28-3, 88-28-4, and 88-28-8 and proposed new regulations K.A.R. 88-28-9 and 88-28-10. The hearing will be held at 10:00 a.m. December 27, 2022, in the Kansas Board of Regents Board Room, 1000 SW Jackson St., Suite 520, Topeka, KS 66612.

This 60-day notice of the public hearing shall constitute a public comment period for receiving written public comments on the proposed amendments and new regulations. All interested parties may submit comments prior to the hearing to Renee Burlingham at the Kansas Board of Regents' above address, at 785-430-4239 or via email to rburlingham@ksbor.org. All interested parties will be given a reasonable opportunity to present their views orally on the proposed regulations during the hearing. To provide all parties with an opportunity to present their views, it may be necessary to request each participant limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statement in an accessible format. A summary of the proposed regulations and the economic impact statement of the regulations follows:

The 2021 Legislature amended K.S.A. 74-32, 163 et seq. and these amendments took effect on July 1, 2021. In addition to aligning the regulations with the updated statute, the overall purpose for the regulation amendments and new regulations is to increase consumer protection and institutional accountability while eliminating some outdated requirements. The proposed amendments provide clarification and update minimum requirements, including the following:

- clarify the official termination date used for refund calculations, allowing institutions to consider the week during which the student last attended to be an entire week of attendance completed;
- add to catalog requirements, most notably requiring the institution's attendance policy and grievance policy with Board contact information;
- modify the advertising requirements to allow institutions that quote salaries of program graduates to use more readily available sources such as a governmental agency or nationally recognized source;
- change the minimum financial requirements that in-

stitutions must meet to maintain a certificate of approval from the Board. Based on recommendations from a certified public accountant, the proposed modifications will require an institution to demonstrate a profit earned and either a current liquidity ratio of at least 1 or a positive net worth in order to obtain a certificate of approval without conditions related to financial monitoring; and

- expand procedures for institutions that are closing to require specific documentation and transfer of records.

Additionally, the agency is proposing changes to remove some reporting requirements to reduce the burden on regulated institutions, including the following:

- reduce the requirements related to the annual fire inspection. Many cities do not conduct annual inspections, making it difficult for institutions to provide an annual report to the Board as required under the current regulation. To reduce the reporting burden, the proposed amendments require institutions to receive inspections as required by the local fire department, state fire marshal, and other public health and safety organizations. The proposed amendments will require these reports to be made available to the Board upon request;
- remove restrictions related to student loans that the institution receives on behalf of the student from private lenders; and
- modify the requirements related to the institution's library to no longer require that the institution employ a professional librarian or include an annual budget line item for library maintenance and improvement.

The proposed amendments also create new regulations to establish requirements related to the required documentation for provisional certificates of approval for institutions in the process of obtaining accreditation and changes of ownership.

There is no anticipated economic impact expected to be incurred or passed along to regulated institutions as a result of enacting the proposed amendments. The proposed amendments are intended to update and clarify the regulatory language. The specific regulation regarding fees charged to regulated institutions is not impacted by the proposed amendments.

These definitions serve to assist in understanding the terms as they are used in K.A.R. 10-25-2.

K.A.R. 10-25-2 – Preliminary oral fluid screening test devices. This is a new regulation that identifies a preliminary oral fluid screening test device approved by the director of the KBI.

The proposed new regulations are not anticipated to have any economic impact.

Article 6. — LICENSES

100-6-6. Reentry active license; medicine and surgery and osteopathic medicine. (a) Any physician, whether an applicant or a licensee, who has not engaged in the prac-

tice of the healing arts for the two-year period immediately preceding the filing of an application for a license or change of designation type pursuant to K.S.A. 65-2809, and amendments thereto, may be required to complete the terms and conditions of a reentry agreement that has been approved by the board, as a condition of licensure.

(b) Each physician who has not practiced the healing arts for the two-year period immediately preceding the filing of an application for a license or change of designation type shall submit a proposed reentry plan for review by the board. The proposed reentry plan shall contain the following:

(1) The name of a supervising physician, who shall be approved by the board;

(2) an assessment of the physician's current strengths and weaknesses in the intended area or areas of practice. The assessment may include testing and evaluation by colleagues, educators, or others;

(3) an education component that addresses the physician's area or areas of needed improvement, if any, and consists of a reentry period of monitored practice and education upon terms based on the factors listed in subsection (c); and

(4) documentation that an insurer intends to issue the physician a policy of professional liability insurance pursuant to K.S.A. 40-3402, and amendments thereto, and certification from the physician that the premium surcharges pursuant to K.S.A. 40-3404, and amendments thereto, will be paid.

(c) Factors that may affect the length and the scope of the reentry plan shall include the following:

(1) The physician's amount of time out of practice;

(2) the prior work schedule when practicing;

(3) the reason for the interruption in practice;

(4) the physician's activities during the interruption in practice, including the amount of practice-relevant continuing medical education or any healthcare-related volunteer work;

(5) the physician's previous and intended area or areas of practice;

(6) the changes in each intended area of practice during the time that the physician has been out of continuous practice;

(7) the number of years since the physician completed graduate medical education, including fellowship if applicable; and

(8) the physician's length of active practice after completing graduate medical education.

(d) Depending on the amount of time out of practice, the physician may be required to meet one or more of the following requirements:

(1) Undergo a competency evaluation or assessment approved by the board;

(2) practice for a specified period of time under a supervising physician, who shall provide periodic reports to the board;

(3) complete any accredited postgraduate or clinical fellowship training approved by the board, if the need for this training is indicated by the competency evaluation or assessment; or

(4) complete a board-approved reentry-to-practice or monitoring program.

(e) If the board approves the physician's proposed reentry plan, the approved agreement shall be a professional development plan pursuant to K.S.A. 65-2838a, and amendments thereto, or shall be incorporated by reference into a nondisciplinary approved reentry plan and executed by the physician, the board, and any applicable board staff.

(f) After the reentry plan has been signed and approved by the board, the physician shall receive a reentry active license. While holding a reentry active license, the physician shall not practice outside the scope of the approved reentry plan during the reentry period.

(g) Each reentry active license for medicine and surgery and osteopathic medicine shall expire on June 30 of each year, if not renewed. The reentry active license may be renewed one time without board approval. Each additional renewal of the reentry active license shall be subject to board approval.

(h) The license may be cancelled upon any of the following, subject to notice and an opportunity for a hearing:

(1) The licensee practiced outside the scope of the approved reentry plan.

(2) The licensee did not satisfactorily complete the approved reentry plan.

(3) The licensee failed to maintain a policy of professional liability insurance pursuant to K.S.A. 40-3402, and amendments thereto, and to pay the premium surcharges pursuant to K.S.A. 40-3404, and amendments thereto.

(i) Upon successful completion of the approved reentry plan, the physician shall be granted an active license.

(j) A reentry active license shall not be issued to a physician who ceased practice as a result of revocation of that individual's license or voluntary surrender of the license in lieu of formal proceedings. (Authorized by and implementing K.S.A. 65-2809; effective Nov. 11, 2022.)

Article 4. — MOTOR CARRIERS OF PERSONS AND PROPERTY

82-4-30a. Applications for interstate registration.

(a)(1) For the purposes of this regulation, "base state" shall have one of the following meanings:

(A) The meaning assigned to "base-state" in 49 U.S.C. 14504a(a)(2), as adopted in paragraph (a)(2) of this regulation; or

(B) If an entity does not have a principal place of business, office, or operating facility in any participating state, the participating state chosen by the entity that is nearest to the location of the entity's principal place of business or any participating state within the entity's FMCSA region.

(2) 49 U.S.C. 14504a, as in effect on January 14, 2019, is hereby adopted by reference, except for the following portions:

(A) In 49 U.S.C. 14504a(a), the following:
 (i) The phrase “and section 14506 (except as provided in paragraph (5))”;
 (ii) 49 U.S.C. 14504a(a)(3);
 (iii) 49 U.S.C. 14504a(a)(5)(B); and
 (iv) 49 U.S.C. 14504a(a)(7);
 (B) 49 U.S.C. 14504a(c) and (d);
 (C) in 49 U.S.C. 14504a(f), 49 U.S.C. 14504a(f)(1)(B) through (E); and
 (D) 49 U.S.C. 14504a(g) through (j).
 (3) Each interstate motor carrier designating Kansas as the carrier’s base state and operating in interstate commerce over the highways of Kansas under authority issued by the relevant federal agency shall file the uniform application for registration issued by the relevant federal agency. The carrier shall file this application for registration with the transportation division of the state corporation commission.
 (b) Each interstate motor carrier designating Kansas as the carrier’s base state shall pay a fee to the state corporation commission through the national registration system. This fee shall be in accordance with the fee schedule

in 49 C.F.R. Part 367, as in effect on October 1, 2021 and as amended by 87 fed. reg. 53694-53695 (2022), which is hereby adopted by reference except for all sections marked “reserved.”

(c) An interstate regulated motor carrier shall not operate in interstate commerce over the highways of Kansas unless the carrier is registered in the carrier’s base state as defined in paragraph (a)(1).
