CAMSO Manufacturing USA, Ltd., 1601 E. South Ave., Emporia, KS 66801, owns and operates the stationary source located at 1601 E. South Ave., Emporia, KS 66801 (1st location) and at 1730 E. Logan Ave., Emporia, Lyon County, KS 66801 (2nd Location). Certain requirements were found to no longer be appropriate in the construction permit dated December 14, 2006. These regulations are proposed for adoption on a permanent basis. A summary of the proposed regulations and their economic impact follows:

K.A.R. 74-1-3. Retaking the examination and granting of credits. Amendments to this Regulation follow recent revisions to the Uniform Accountancy Act relative to the time that CPA exam scores expire, increasing from 18 months to 30 months from the date the scores are released by the National Association of State Boards of Accountancy (NASBA), or the Board. All states are adopting this new amendment.

K.A.R. 74-4-7. Continuing education requirements. Amendments to this Regulation clarify "proof of attendance or completion" of continuing education credits claimed for renewal of a permit to practice. Removing any reference to "Licensed Municipal Public Accountants," as that class of licensure no longer exists.

K.A.R. 74-4-8. Continuing education programs; requirements. Amendments to this Regulation include the NASBA Registry number which is required for all webinar and self-study courses; increase the retention period to six years from five years for proof of attendance/ completion of continuing education; limits the number of college credit courses to 50% of the total number of continuing education hours required for renewal or reinstatement.

K.A.R. 74-4-9. Continuing education controls and reporting. Corrects an omission for group internet-based courses; requires the certificates of completion/attendance issued by the course sponsor to include the NASBA registry number.

K.A.R. 74-5-2. Definitions. Deletes the definition of "Licensed Municipal Public Accountant;" defines NASBA.

K.A.R. 74-5-2a. Definitions of the AICPA code of professional conduct. Deletes reference to "Licensed Municipal Public Accountant."

K.A.R. 74-5-2b. Applicability of AICPA professional standards. Deletes reference to "Licensed Municipal Public Accountant."

K.A.R. 74-5-101. Independence. Deletes reference to "Licensed Municipal Public Accountant."

K.A.R. 74-5-102. Integrity and objectivity. Deletes reference to "Licensed Municipal Public Accountant."

K.A.R. 74-5-201. General standards. Deletes reference to "Licensed Municipal Public Accountant."

K.A.R. 74-5-202. Compliance with standards. Reverts back to the correct title of Kansas Department of Admin-

istration "Accounts and Reports." Deletes reference to "Licensed Municipal Public Accountant."

K.A.R. 74-5-203. Accounting principles. Deletes reference to "Licensed Municipal Public Accountant."

K.A.R. 74-5-301. Confidential client information. Deletes reference to "Licensed Municipal Public Accountant."

K.A.R. 74-5-407. Revokes this Regulation and moves it to a new Article (Article 16).

K.A.R. 74-5-408. Revokes this Regulation and moves it to a new Article (Article 16).

Article 10. Licensed Municipal Public Accountants.

K.A.R. 74-10-1 and K.A.R. 74-10-2. Revokes this Article as there are no longer any Licensed Municipal Public Accountants.

K.A.R. 74-12-1. Fees. Removes any reference to Licensed Municipal Public Accountant fees.

Article 16. New Article.

K.A.R. 74-16-1. Cooperation with the board. (Previously K.A.R. 74-5-407); and includes applicants for certificates, permits, and firms.

K.A.R. 74-16-2. Notification of non-renewal; change of name or address. (Previously K.A.R. 74-5-408); requires notification of non-renewal of permit to practice and firm registration; expands notification to include employer address and business name.

Under the proposed amendments, there are no changes to the hours required to complete initial RMA training nor the hours required for recertification.

A summary of the proposed regulations and the economic impact statement of the regulations follows:

The 2023 Legislature established the Adult Learner Grant Program for certain students enrolled in eligible bachelor's degree programs at qualifying postsecondary educational institutions. The legislation requires, with certain exceptions, that each student receiving a grant agree to reside and work in Kansas for two years following completion of their grant-funded program.

These regulations: (1) provide definitions of key terms used in the regulations and statutes; (2) set forth the process to apply for a grant and appeal a denial or revocation of a grant; (3) set forth the terms to be included in a grant agreement and the requirements for successful completion of, postponement of, or release from the service obligation; and (4) establish the process for repayment of any grant when the service or other requirements are not met or forgiven.

There is no anticipated economic impact on specific businesses, sectors, public utility ratepayers, or local governments. Neither the act nor the regulations directly affect those entities.

Students who qualify for grants under this program and who successfully complete their grant-funded programs and two-year service requirements will benefit from the grant authorized by the Act. Students who are unable to complete or be excused from their service obligations will be required to repay grant funds. The higher education institutions that grant recipients attend will award the grants and be reimbursed by funds appropriated by the Legislature for this purpose. Individuals affected by the regulations will benefit financially from receiving grants, as will the institutions attended by the grant recipients. Kansas businesses will benefit to the extent additional trained individuals remain in Kansas communities to work after completion of their programs. The regulations themselves will have no direct economic effect, as they only stipulate how the Board of Regents and the participating institutions will implement the program.

There will be no direct economic impact on other public agencies or private businesses as a result of these regulations. The regulations will neither enhance nor restrict business activities and growth, other than as discussed above.

A summary of the proposed regulations and the economic impact statement of the regulations follows:

The Board of Regents has begun its first five-year review of its rules and regulations pursuant to K.S.A. 77-440. As part of that review, the agency has identified 23

unnecessary regulations: 14 regulations that are obsolete because they relate to obsolete programs, and 9 obsolete regulations that relate to ongoing programs.

These revocations would eliminate those obsolete regulations. The regulations related to obsolete programs are: (1) K.A.R. 88-14-1 through 88-14-4 (Community Resource Program); (2) K.A.R. 88-18-1 through 88-18-8 (Kansas Honors Scholarship Program); and (3) K.A.R. 88-27-1 and 88-27-2 (Washburn University Out-District Tuition). The underlying statutory programs no longer receive state funding and are no longer active.

The obsolete regulations related to ongoing programs are: K.A.R. 88-13-7, 88-13-8, 88-20-6, 88-20-2, 88-20-7, 88-21-5, 88-21-6, 88-21-7 and 88-22-5. These regulations relate to the Student Assistance programs, Nursing Service Scholarship Program, Kansas Ethnic Minority Scholarship Program, and Kansas Teachers Scholarship Program. The regulations are generally obsolete because they reference individual income tax returns, which are no longer used to determine scholarship eligibility, and because they set out confidentiality requirements that have been superseded by other laws. K.A.R. 88-20-2 establishes an out-of-date limit on nursing service scholarships, and K.A.R. 88-21-7 establishes an out-ofdate method for apportioning awards under the Ethnic Minority Scholarship Program in the event scholarship funds are over-subscribed.

There is not anticipated to be any economic impact on specific businesses, sectors, public utility ratepayers, or local governments. Revoking these regulations will not impose any implementation or compliance costs on those groups. Revoking the regulations is not anticipated to have any economic impact on the general public.

The licensee shall pay the biennial license renewal fee specified in K.A.R. 65-4-3 and any applicable additional fees.

(b)(1) Commencing with license renewals occurring in 2025, all licensees with an even numbered license that is *(continued)*

scheduled to be renewed by May 31, 2025, shall renew the license for a one year period ending on May 31, 2026. The licensee shall pay a license renewal fee equal to onehalf the amount of the biennial license renewal fee specified in K.A.R. 65-4-3 and any applicable additional fees.

(2) Each subsequent license renewal for any licensee specified in paragraph (b)(1) shall be for a two (2) year period ending on the second May 31 following the applicable renewal date. The licensee shall pay the biennial license renewal fee specified in K.A.R. 65-4-3 and any applicable additional fees.

(c)(1) For initial licenses issued on or after January 1, 2024, all licensees with an odd numbered license shall renew their license by May 31 of each odd numbered year. The licensee shall pay a license renewal fee prorated to the time period of licensure and based upon the amount of the biennial license renewal fee specified in K.A.R. 65-4-3 and any applicable additional fees.

(2) Each subsequent renewal for odd numbered licenses shall be for a two (2) year period ending on the second May 31 following the applicable renewal date. The licensee shall pay the biennial license renewal fee specified in K.A.R. 65-4-3 and any applicable additional fees.

(d)(1) For initial licenses issued on or after January 1, 2024, all licensees with an even numbered license shall renew their license by May 31 of each even numbered year. The licensee shall pay a license renewal fee prorated to the time period of licensure and based upon the amount of the biennial license renewal fee specified in K.A.R. 65-4-3 and any applicable additional fees.

(2) Each subsequent renewal for even numbered licenses shall be for a two (2) year period ending on the second May 31 following the applicable renewal date. The licensee shall pay the biennial license renewal fee specified in K.A.R. 65-4-3 and any applicable additional fees. (Authorized by K.S.A. 74-1504 and K.S.A. 65-1509; implementing K.S.A. 65-1509; effective Feb. 2, 2024.)
