### **Notice of Intent to Lease Real Property**

Public notice is hereby given that Wichita State University (WSU), directly or through its affiliate corporation Wichita State Innovation Alliance, Inc., intends to lease, subject to all required state approvals, real property located on the Wichita State University's campus designated as the "Innovation Campus" for the private development and operation of a partnership building or buildings. There are three separate building sites available for private development. Proposals may be submitted for one or more of the sites. Each site is approximately one to two and a half acres in area, and will be customized based on the proposal for the respective site. Site #1 is located east of Woolsey Hall. Site #2 is located on the northwest corner of 17th and Innovation Boulevard. Site #3 is located on the northwest corner of 17th and Oliver. The university intends to lease each site for a mutually agreeable period, not to exceed sixty years, but extended terms and renewal options would be considered. Interested tenants must be willing to be a good fit with the university's educational mission and identify anticipated benefits to the university, its students, and the WSU community (i.e. applied learning, joint research, faculty start-up, WSU curriculum or program support, etc.), and must agree to the essential ground lease terms and restrictive covenants. Interested tenants will be evaluated on: proposal terms, demonstrated benefit to WSU, design concepts, financial stability, and proposed use. Interested tenants will be required to construct adjacent and adequate surface parking that may not be included in the leased ground. Rental rate shall be based on fair market value and negotiable based on term of lease, purpose/ use of building improvement, and benefit to the university. The university is interested in proposals from any individual, organization or entity, for the development of a building or buildings to provide rental space available for occupants who are committed to advancing the university's mission and vision as an education, cultural, and economic driver for Kansas and the greater public good, and aligning with the university's research and applied learning goals. The university will consider serious offers and inquiries with detailed proposal terms from any financially qualified individual, group, organization. #### Notice of Requested Architectural Services

Notice is hereby given of the commencement of the selection process for architectural services for the Kansas Highway Patrol (KHP) Dispatch Center Relocation. The Patrol's Central Communications Center is based in Salina, Kansas, and provides dispatching services for troopers statewide. Central Communications via Communication Specialists support field personnel 24 hours a day, 7 days a week by broadcasting information on the Highway Patrol's radio communication system. Communication Specialists also coordinate emergency medical relays across the state using aircraft and ground units, and monitor alarms and warning systems, such as those issued by the National Weather Service and local emergency managers. The Central Dispatch operations are housed in the lower level of the KHP Troop C headquarters and have outgrown the usefulness of the current facility. The KHP engaged with a firm to provide a needs assessment of the Dispatch operations and has been granted authorization to proceed with the design, bid, and build of a new dispatch facility. The project construction budget is \$14,000,000.

### **Notice of Water Quality Certification**

The Kansas Department of Health and Environment (KDHE) has drafted a water quality certification per Section 401 of the Clean Water Act (CWA) requested by Brian Lang PE, for Doyle Creek Watershed Joint District #86 for a Section 404 of the CWA #NWK-2008-01774 see: <https://www.nwk.usace.army.mil/Media/Public-Notices/>. The project is a floodwater retarding structure to be built across an unnamed tributary to Doyle Creek. The embankment will be 27 feet tall and approximately 1360 feet long. It will be constructed of compacted earthfill materials from the required excavation of the auxiliary spillway and from excavation in the sediment pool upstream of the embankment. The principal spillway will consist of a 24-inch reinforced concrete pipe with a 42-inch concrete pipe riser and other appurtenances. The principal spillway will outlet into a riprap lined stilling basin before entering the natural channel approximately 150 feet downstream of the centerline of the embankment.
