Notice is hereby given for seeking the interest and qualifications for Construction Management At-Risk (CMAR) services for the new Kansas Veterinary Diagnostic Laboratory (KVDL) at Kansas State University.

Kansas State University is currently seeking the services of an architectural firm specializing in the design and construction of a new Veterinary Diagnostic Laboratory (VDL) to serve the State of Kansas and surrounding areas. The existing facilities are spread out over multiple buildings on the Kansas State University Manhattan campus resulting in inefficiency and poor biosecurity. The goal is to combine all the labs into one standalone VDL facility. This will help to provide safer and more efficient diagnostic facilities for individual and state entities and will improve internal and external testing, processing and reporting. The new facility, with a planned square footage of 142,000 GSF, will meet/maintain AAVLD and NAHLN Level 1 accreditation. Notice of Hearing on Proposed Administrative Regulations

A public hearing will be conducted at 8:30 a.m. Thursday, December 4, 2025, at the Board of Healing Arts Conference Room, Lower Level, SW Jackson, Topeka, Kansas, to review and consider the adoption of the proposed permanent regulations of the Kansas State Board of Pharmacy.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed regulations. All interested parties may submit written comments prior to the public hearing by mail to Alexandra Blasi, Executive Secretary, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1244, or by email to pharmacy@ks.gov. All interested parties will be given a reasonable opportunity to present their views orally regarding the adoption of the proposed regulations during the public hearing. In order to provide all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

Any individual with a disability may request an accommodation in order to participate in the public hearing and may request the regulations and economic impact statements in an accessible format. Requests for accommodation to participate in the public hearing should be made at least 10 business days in advance of the hearing by contacting Alexandra Blasi, Executive Secretary, 800 SW Jackson, Suite 1414, Topeka, KS 66612-1244 or by phone at 785-296-4056. Handicapped parking is located at the north entrance to the building. Curbs at the north entrance are accessible to individuals with disabilities.

K.A.R. 68-1-1a. Revoking. The Kansas Board of Pharmacy proposes revoking 68-1-1a and simultaneously adopting 68-7-26. Currently, 68-1-1a only applies to pharmacists; 68-7-26 will apply to both pharmacists and technicians. Regulation allows applicants to withdraw their application through inaction instead of incurring a disciplinary action on their record, which may prevent them from doing business in other states or incurring needless penalties.

The Board anticipates that the proposed revocation will have no identifiable economic impact.

K.A.R. 68-7-26. Application for licenses, registrations, or permits; withdrawal of application. The proposed new regulation was previously found in Article 1, 68-1-1a, which is set to be revoked. The proposed new regulation will now allow pharmacists and technicians to withdraw their application through inaction instead of incurring a disciplinary action on their record, which may prevent them from doing business in other states or incurring needless penalties.

The Board anticipates that the proposed regulation will have no identifiable economic impact, and any costs associated with complying with the regulation should be absorbed within the normal course of business for pharmacies and facilities.

K.A.R. 68-5-17. Pharmacy technicians; certification examination; request for extension. The proposed amendments clarify when a pharmacy technician must request an extension to pass the approved certification examination. The amendments clarify that a pharmacy technician must request an extension prior to their registration's expiration date. Previously, the regulation required pharmacy technicians to both submit the request 30 days prior to their registration's expiration and provide a reason for the request. The Board has determined that this language is not necessary and overly burdensome.

Article 1.—REGIONAL SYSTEMS OF COOPERATING LIBRARIES

54-1-23. Allocation of the grant-in-aid fund among the regional systems of cooperating libraries. (a) In any year that the annual authorization for state grant-in-aid exceeds one and a half million dollars, three-fourths of the authorization for systems is allocated to the base grant, which is divided equally among the systems.

- (b) In any year that the annual authorization for state grant-in-aid is less than or equal to one and a half million dollars, all of the authorization for systems except ten thousand dollars is allocated to the base grant, which is divided equally among the systems.
- (c) The remainder of the annual authorization for systems is distributed as follows:
- (1) one-tenth of the remainder is split between the systems based on the percentage of territory each system occupies compared to all systems; and
- (2) nine-tenths of the remainder is split between the systems based on the percentage of population a system has compared to all systems. (Authorized by K.S.A. 75-2560; implementing K.S.A. 75-2555; effective Jan. 25, 1993; amended Oct. 17, 2025.)

Article 24.—MORTGAGE BUSINESS

17-24-4. Record retention. (a) In any mortgage transaction in which the licensee does not close the mortgage loan in the licensee's name, the licensee shall retain the following documents, as applicable, for at least 36 months following the loan closing date, or if the loan is not closed, the loan application date:

- (1) The application;
- (2) all written agreements with the consumer that describe rates, fees, broker compensation, and any other similar fees;
- (3) an appraisal performed by a Kansas-licensed or Kansas-certified appraiser completed within 12 months before the loan closing date, the total appraised value of the real estate as reflected in the most recent records of the tax assessor of the county in which the real estate is located, or, for a nonpurchase money real estate transaction, the estimated market value as determined through an acceptable automated valuation model acceptable to the commissioner;
- (4) the notice as required by K.S.A. 2024 Supp. 9-2208(b), and amendments thereto, and K.A.R. 17-24-1;
- (5) all records and disclosures evidencing compliance with applicable federal lending laws and regulations;
- (6) records of all consumer correspondence, including all written communications, electronic mail, instant messages and phone logs, any notes detailing contact with each consumer, and any phone conversation recordings or transcripts;
- (7) any documentation that aided the licensee in making a credit decision, including a credit report, title work, verification of employment, verification of income, bank statements, payroll records, and tax returns;
- (8) evidence of all compensation paid to loan originators and the compensation agreement that governs those payments; and
- (9) all paid invoices for appraisal, title work, credit report, and any other closing costs.
- (b) In any mortgage transaction in which the licensee provides any money to fund the loan or closes the mortgage loan in the licensee's name, the licensee shall retain the documents required in subsection (a) and the following documents, as applicable, for at least 36 months from the mortgage loan closing date:
- (1) The high loan-to-value notice required by K.S.A. 2024 Supp. 9-2232, and amendments thereto;
- (2) any credit insurance requests and insurance certificates;
- (3) the note(s) and any applicable contract addendum or rider;
- (4) a copy of the filed mortgage(s) or deed(s);
- (5) a copy of the title policy or search; and
- (6) the assignment of the mortgage and note.
- (c) In any mortgage transaction in which the licensee engages in mortgage servicing or owns the mortgage

servicing rights, the licensee shall retain the following documents, as applicable, for at least 36 months from the final entry to each account:

- (1) All records and disclosures evidencing compliance with applicable federal lending laws and regulations;

- (3) a copy of the filed mortgage(s) or deed(s);
- (4) servicing history;
- (5) any statements, disclosures, invoices, or information for each account, including, but not limited to, the following:
- (A) Documentation supporting any amounts added to a consumer's account or evidence that a service was actually performed in connection with these amounts, or both, including costs of collection, attorney's fees, property inspections, property preservations, and broker price opinions;
- (B) loan modification agreements;
- (C) forbearance or any loan modification agreements;

- (E) foreclosure notices;
- (F) evidence of sale of foreclosed homes;
- (G) surplus or deficiency balance statements;
- (H) default-related correspondence or documents;
- (I) the notice of the consumer's right to cure;

- (L) notice and evidence of credit insurance premium refunds;
- (M) records of consumer correspondence, including all written communications, electronic mail, instant messages and phone logs, any notes detailing contact with each consumer, and any phone conversation recordings or transcripts; and

- (E) a schedule of servicing fees and charges imposed by the licensee or a third party.
- (d) In addition to meeting the requirements specified in subsections (a), (b), and (c), each licensee shall retain for at least the previous 36 months the documents related to the general business activities of the licensee, which shall include the following:
- (1) Advertising records, including copies of advertisements or solicitations made by print or electronic means, including through the internet;
- (2) the business account check ledger or register;
- (3) all financial statements, balance sheets, or statements of condition;
- (4) all escrow account ledgers and related deposit statements;
- (5) all lease agreements for Kansas principal place of business and branch offices; and

Article 6.—UNIFORM CONSUMER CREDIT CODE

75-6-35. Net worth requirements. (a) Each applicant for a supervised loan license and each licensee shall maintain a positive net worth. Positive net worth shall show that the aggregate assets, excluding all intangible assets and receivables from related entities, exceeds liabilities, as determined in accordance with United States generally accepted accounting principles. The administrator may issue an exception to this positive net worth requirement.

(b) As evidence that the applicant is in compliance with subsection (a), each applicant and licensee shall submit annually to the administrator, on or before January 1, a current and complete financial statement, accompanied by a written statement signed by an independent certified public accountant attesting that the statement has been reviewed and is in compliance with generally accepted accounting principles. For the purposes of this regulation, a current financial statement shall be one that was prepared within the preceding 12 months.
