Notice to Consulting Firms

The Kansas Department of Transportation (KDOT) is seeking to secure ready availability of construction inspection services on an as-needed basis by entering into up to 25 contracts with qualified consulting engineering firms who may perform services, from time to time and on short notice, when KDOT does not have the personnel to perform the services. The services may require engineers and technicians to perform sampling and testing of materials, inspection of construction work as well as administration and recordkeeping associated with such services.

Requirements: Interested consulting firms must: (a) be prequalified by KDOT in category 241 Construction Inspection and Testing; (b) have employees who are experienced in inspection, sampling, and testing as well as certified under the Certified Inspection and Testing Training Program described online at www.citksu.com and in the CIT Manual found at http://www.ksdot.org/descons. asp on KDOT's website; and (c) submit a Letter of Interest on or before February 23, 2017, to David Nagy, P.E., Assistant to the Director of Design/Contracts Engineer for KDOT by email to DavidN@ksdot.org with the subject line reading "LOI As-Needed Construction Inspection [Firm Name]". Letters of Interest in the form of a PDF document (maximum size 6 pages) should express interest in performing services on an As-Needed basis and describe particular qualifications for the construction inspection services sought by KDOT, including any special expertise, certifications, training, skill, experience or knowledge of the firm and its employees as well as the number and type of KDOT certified inspectors. KDOT shall not consider the skills or expertise of subconsultant personnel because consultants will be required to perform all services with their own employees. If a firm is not currently prequalified by KDOT but is interested in obtaining prequalification, then please

For licensure and other requirements applicable to the practice of technical professions within the State of Kansas, please consult the website of the Kansas Board of Technical Professions at http://www.ksbtp.ks.gov/. All firms doing business with KDOT must be registered and in good standing under the laws of the State of Kansas and comply with applicable state and federal laws, rules and regulations.

Qualifications-Based Selection Process. Based on the qualifications submitted in the Letter of Interest and other information available to KDOT, on or about March 16, 2017, KDOT will shortlist firms and notify all firms submitting Letters of Interest of the names of the shortlisted firms by return email. Thereafter, KDOT will issue a Request for Proposal (RFP) to the shortlisted firms soliciting a technical proposal. At KDOT's option, shortlisted firms may be interviewed by telephone conference call or asked to attend meetings or participate in other discussions with KDOT. Technical proposals will be evaluated on the basis of the factors listed below, evenly weighted, to rank the most qualified firms in order of preference. Evaluation factors: 1) the quality of the response to the RFP; 2) qualifications and experience of consultant employees proposed for services; 3) past performance history; and 4) ability and availability to perform services on short notice in one or more regional areas of the State of Kansas. Up to 25 of the highest ranked firms will be asked to enter into negotiations with KDOT for an As-Needed Agreement for services under which KDOT may request construction inspection services via Task or Work Orders over a period of 4 years, subject to a maximum cumulative aggregate amount payable under the As-Needed Agreement. In the event KDOT cannot reach agreement with any of the highest ranked firms, it will terminate negotiations with such firms and commence negotiations with the next highest ranked firm, and so on, until either agreement is reached for a satisfactory scope of services for a fair and reasonable price, or KDOT decides to pursue other alternatives. KDOT intends to conclude or terminate negotiations on or before **June 1, 2017**.

KanCare – Summary of Program and Extension Information

KanCare is the program through which the State of

Kansas administers Medicaid. After a long period of study, the state determined that contracting with multiple managed care organizations would result in the provision of more efficient and effective health care services to the populations covered by Medicaid and Children's Health Insurance Program (CHIP) in Kansas, and would ensure coordination of care and integration of physical and behavioral health services with each other and with home- and community-based services (HCBS).

On August 6, 2012, the State of Kansas submitted a Medicaid Section 1115 demonstration proposal, entitled KanCare, to the Centers for Medicare & Medicaid Services (CMS), a division of the U.S. Department of Health and Human Services. CMS approved that proposal on December 27, 2012, effective from January 1, 2013, through December 31, 2017. The state is now preparing to submit an application to extend the KanCare program for one year, effective from January 1, 2018 through December 31, 2018.

KanCare is operating concurrently with the state's section 1915(c) Home- and Community-Based Services (HCBS) waivers. Together, those seven waivers provide provide the authority necessary for the state to require enrollment of almost all Kansas Medicaid beneficiaries (including the aged, disabled, and some dual eligibles) into a managed care delivery system to receive state plan and waiver services. This represents an expansion of the state's previous managed care program, which provided services to children, pregnant women, and parents in the state's Medicaid program, as well as carved out managed care entities that separately covered mental health and substance use disorder services. KanCare also includes a safety net care pool to support certain hospitals that incur uncompensated care costs for Medicaid beneficiaries and the uninsured, and to provide incentives to hospitals for programs that result in delivery system reforms that enhance access to health care and improve the quality of care.

The KanCare demonstration program will:

- Maintain Medicaid state plan eligibility;
- Maintain Medicaid state plan benefits;
- Allow the state to require eligible individuals to enroll in managed care organizations (MCOs) to receive covered benefits through such MCOs, including individuals on HCBS waivers, except:
 - American Indian/Alaska Natives, who are presumptively enrolled in KanCare but will have the option of affirmatively opting out of managed care.
- Provide benefits, including long-term services and supports (LTSS) and HCBS, via managed care; and
- Create a Safety Net Care Pool to support hospitals that provide uncompensated care to Medicaid beneficiaries and the uninsured.

The KanCare demonstration will assist the state in its goals to:

- Provide integration and coordination of care across the whole spectrum of health to include physical health, behavioral health, and LTSS/HCBS;
- Improve the quality of care Kansas Medicaid beneficiaries receive through integrated care

- coordination and financial incentives paid for performance (quality and outcomes);
- Control Medicaid costs by emphasizing health, wellness, prevention and early detection as well as integration and coordination of care; and
- Establish long-lasting reforms that sustain the improvements in quality of health and wellness for Kansas Medicaid beneficiaries as well as provide a model for other states that are reforming their programs for Medicaid payment and delivery systems.

The one-year extension of KanCare is designed to continue the program as it is currently structured, including:

- Eligible members covered: No change is anticipated in any eligibility group; potential change in timing of assignment into KanCare program for Medically Needy eligibility group (prior to spenddown being met these members would be in fee-for-service status).
- Benefits covered and cost sharing requirements: No change is planned as part of the extension.
- Annual enrollment and re-enrollment of members: No change is planned as part of the extension.
- Annual aggregate expenditures: No change is planned as part of the extension.
- Waiver and expenditure authorities: No change is planned as part of the extension.
- Hypothesis and evaluation parameters for the program: No change is planned as part of the extension; will expect to see ongoing improvement within the more mature program, and related expectations will be reflected in contractual and program policy content.

Information about the KanCare extension process and related documents will be maintained and kept current throughout the public comment and review process, during which the Centers for Medicaid Services (CMS) is reviewing and acting upon the state's extension request. - **K.A.R. 9-18-10 General requirements for housing facilities.** This section defines the standard housekeeping, husbandry, and other requirements with which retail breeders, hobby breeders, animal shelters, rescue networks, boarding and training kennels, research facilities, and pet shops must comply.
- K.A.R. 9-18-11 Additional requirements for indoor housing facilities and sheltered housing facilities. This section defines the standard structural and other requirements for indoor and sheltered facilities for retail breeders, hobby breeders, animal shelters, rescue networks, boarding and training kennels, research facilities, and pet shops.
- K.A.R. 9-18-12 Additional requirements for outdoor housing facilities. This section defines the standard structural and other requirements for outdoor housing facilities for retail breeders, hobby breeders, animal shelters, rescue networks, boarding and training kennels, research facilities, and pet shops.
- **K.A.R. 9-18-13 Primary enclosures.** This section defines the requirements of a primary enclosure for retail breeders, hobby breeders, animal shelters, rescue networks, board-

- ing and training kennels, research facilities, and pet shops. It also defines additional requirements for cats.
- K.A.R. 9-18-14 Cleaning, sanitization, and pest control. This section defines the standard requirements for cleaning, sanitization, and pest control for retail breeders, hobby breeders, animal shelters, rescue networks, boarding and training kennels, research facilities, and pet shops.
- **K.A.R. 9-18-15 Compatible grouping.** This section states the licensee shall not house animals in groups that are not compatible.
- **K.A.R. 9-18-16 Separation of animals by gender.** This section states all intact adult animals must be housed separately from other sexually intact adult animals of the opposite sex within an animal shelter, rescue network, or pet animal foster home.
- **K.A.R. 9-18-17 Feeding and Watering.** This section defines adequate feeding and watering requirements for retail breeders, hobby breeders, animal shelters, rescue networks, boarding and training kennels, research facilities, and pet shops.
- **K.A.R. 9-18-18 Contingency Planning.** This section states each licensee must develop a written plan to provide proper handling, treatment, and care for animals in the event of an emergency.
- **K.A.R. 9-18-19 Employees and Volunteers.** This section states the licensee must employ enough individuals for the facility to remain in compliance. Employer must provide proper training of care and handling of animals to employees.
- **K.A.R. 9-18-20 Age of animal**. This section defines the age requirements in order to sell, exchange, and adopt animals.
- **K.A.R. 9-18-21 Adequate veterinary medical care.** This section states the requirement for retail breeders, hobby breeders, animal shelters, rescue networks, boarding and training kennels, research facilities, and pet shops to provide adequate veterinary care for their animals.
- **K.A.R.** 9-18-22 Exercise. This section states each licensee must provide a plan of exercise for dogs over 12 weeks of age, except females with litters. It also defines the means in which the licensee can provide exercise.
- K.A.R. 9-18-23 Adoption of feline immunodeficiency virus-positive cats. This section allows for the adoption of feline immunodeficiency virus-positive cats to be adopted or transferred by authorization by the attending veterinarian for a licensed animal shelter. This regulation states that a written statement from the veterinarian must be obtained and kept on file explaining the symptoms, risks, and recommendations of how the cat will be housed to minimize the spread of the virus.
- K.A.R. 9-18-24 Animal breeders and animal distributors. This section adopts by reference federal standards in 9 C.F.R. Sections 3.1 through 3.4 and 3.6 through 3.12.
- K.A.R. 9-18-25 Prohibiting the sale or gift of certain animals by pet shops. This section states the sale of reptiles shall not be conducted unless the business has posted signs regarding safe reptile-handling practices. It

also states pet shops shall not sell, offer for sale, or offer as a gift or promotional consideration any viable turtle eggs or live turtles with a carapace length of less than four inches.

K.A.R. 9-18-26 – Animal research facilities. Provides specific requirements for animal research facilities.

K.A.R. 9-18-27 – Rescue networks. This section states the requirements for rescue networks. This combines two previously-established categories: group home shelters and rescue home shelters, into the category of rescue network.

K.A.R. 9-18-28 – Pet animal foster homes. This section defines the requirements of pet animal foster homes utilized by rescue networks and shelters.

K.A.R. 9-18-29 - Mobile adoption facilities. This section states the ability of licensed shelters and rescue networks to conduct adoptions at locations other than their licensed premises.

K.A.R. 9-18-30 – Tethering of animals by boarding or training kennel operators. This section defines the purpose for and time periods during which licensees may use tethers.

K.A.R. 9-18-1 through 9-18-3. To be revoked.

K.A.R. 9-19-12. To be revoked.

K.A.R. 9-20-1 through 9-20-4. To be revoked.

K.A.R. 9-21-1 through 9-21-3. To be revoked.

K.A.R. 9-22-1 through 9-22-5. To be revoked.

K.A.R. 9-24-1 through 9-24-3. To be revoked.

K.A.R. 9-25-1 through 9-25-15. To be revoked.

Economic Impact Statement:

The proposed new regulations are adopted by the Kansas Animal Health Commissioner to implement the Kansas Pet Animal Act. Within these proposed regulations are requirements such as adequate veterinary care, feeding, watering, cleaning, and general requirements for housing facilities for small animals defined under the Kansas Pet Animal Act (KPAA).

The proposed new regulations are intended to streamline and consolidate six different subsets of existing regulations, and create uniform requirements for all licensees subject to the KPAA. These regulations will implement a more easily understandable, customer-friendly set of requirements not only for the licensees, but also for the Kansas Department of Agriculture Animal Facility Inspectors.

These proposed regulations are not mandated by Fed-

The proposed regulations should not have a negative fiscal impact upon the Kansas Department of Agriculture.

K.A.R. 9-18-6 Fees. This regulation will bring in an estimated additional revenue of approximately \$4,800 annually to the KDA Animal Facility Inspection program within the Division of Animal Health.

The additional revenue of \$4,800 will be derived from the increase in fees for the existing Group Home Shelters and Rescue Home Shelters, which will be combined in the proposed regulations as Rescue Networks with an annual fee of \$125. This fee was increased to cover the additional staff time and expenses of inspecting these types of shelters.

The current fees for licensure under the Kansas Pet Animal Act will not change, except for the addition of a new category (Rescue Network). This addition will combine two existing categories (Group Home Shelters and Rescue Home Shelters). This addition could pose a financial impact to these two existing categories.

These two existing categories currently pay \$50 annually for a license. These proposed regulations will increase the fees for these existing categories by \$75, with a new proposed fee of \$125.

A number of proposed requirements were discussed in multiple meetings of the Kansas Pet Animal Advisory Board. The fees and other requirements in the proposed regulations are the result of these discussions.

The proposed regulations are not expected to have an environmental impact.

The following is a summary of the proposed regulation and economic impact statement:

123-17-101. Community-based graduated responses for technical violations of probation, violations of conditional release, and violations of a condition of sentence. The regulation provides for an array of uniform responses by juvenile community supervision officers to technical violations of probation, violations of conditional release, and violations of a condition of sentence by juvenile offenders. The regulation further provides a uniform array of incentives for use by juvenile community supervision officers to respond to and encourage positive and prosocial behaviors of juvenile offenders on probation or conditional release. Lastly, the regulation provides for a standardized violations level report form to document graduated responses taken by juvenile community supervision officers.

Economic Impact: This proposed permanent regulation requires no additional resources for the Kansas Department of Corrections and will have no economic impact upon offenders, other governmental agencies, private businesses, or other private individuals.
