This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed rules and regulations. All interested parties will be given a reasonable opportunity to present their views orally on the adoption of the proposed regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes. These regulations are proposed for adoption on a permanent basis. A summary of the proposed regulations and their economic impact follows:

K.A.R. 5-14-10 – The proposed amendment sets forth a clear implementation of the civil penalties and suspensions applied for violations of the Kansas Water Appropriation Act. The amendment also deletes provisions related to overpumping violations, as these provisions have been moved into a separate regulation.

K.A.R. 5-14-12 – This new regulation sets forth a clear implementation of civil penalties and suspensions applied for exceeding the authorized quantity limitation on a permit or water right (i.e. overpumping violations). This regulation also defines how long a permit must be operated in compliance with its terms and permits before any civil penalty is expired from the permit or water right file. Among other implications, the expiration of a penalty from the water right file will affect the severity of any subsequent civil penalties levied for noncompliance with water right terms and conditions.

Economic Impact Statement:

The regulations will apply to existing and future water rights that are not in compliance with the Kansas Water Appropriation Act and applicable regulations. Kansas water rights are based on allowable appropriation and safe yield. Exceeding the authorized quantity, tampering with a meter, falsifying water use, and many other violations of statutes, regulations, and conditions of a water right, can adversely impact the water resource and could harm other Kansans' property rights. In addition, being out of compliance by using more than the authorized quantity of water or using water at a greater rate than a water user's permit allows, could result in a water user gaining an unfair economic advantage over his or her neighbors who faithfully operate in compliance. These regulations are intended to revise and clarify enforcement practices in order to prevent these problems.

This regulation is not mandated by federal law.

The proposed amendment and new regulations may result in a small positive fiscal impact to the department following implementation due to raised civil penalty amounts. It is anticipated that water users will adjust their practices appropriately such that the division will see no long-term fiscal impact, just greater levels of compliance.

The proposed amendments and new regulation will result in no fiscal impact to other government agencies. It may have a negative fiscal impact on private businesses and individuals if civil penalties are imposed for non-compliance. The expiration of civil penalties for staying in compliance could have a very positive fiscal impact to private business and individuals by allowing the water right to be back in good standing.

No other methods were considered by the state.

Some improvements to groundwater resource conditions, both quality and quantity, could be achieved through the adoption of this regulation change as water right holders achieve greater compliance with the terms and conditions of their water rights.

(c) For this game, a play/prize symbol shall appear in 80 play spots within the play area or areas.

(d) The ticket numbers in each book of tickets in this game shall start with 000 and end with 059.

(e) The price of instant tickets sold by a retailer for this game shall be \$5.00 each.

(f) In "Double Diamond" the player will scratch the play area to reveal 20 "SPINS." Each "SPIN" consists of three play symbols and one prize symbol. If the player reveals three identical play symbols in the same "SPIN" across, the player wins the prize amount shown for that "SPIN." If the player reveals two identical play symbols and a "\$\$" symbol in the same "SPIN" across, the player wins double the prize amount shown for that "SPIN." If the player reveals three "DOUBLE DIAMOND" symbols in the same "SPIN" across, the player wins all prizes on the ticket.

(g) Each ticket in this game may win up to 20 times.

(h) Approximately 300,000 tickets shall be ordered initially for this instant game. Additional ticket orders shall have the same prize structure, the same number of prizes per prize pool of 300,000 tickets, and the same odds as were contained in the initial ticket order.

(i) The expected number and value of instant prizes in this game shall be as follows:

(j) The odds of winning a prize in this game are approximately one in 3.51. (Authorized by K.S.A. 2016 Supp. 74-8710; implementing K.S.A. 2016 Supp. 74-8710, and K.S.A. 2016 Supp. 74-8720; effective, T-111-2-24-17, Jan. 11, 2017.)

Article 18.—GENERIC PLAYER LOYALTY CLUB RULES

111-18-1. Name of program. (a) On or after January 25, 2017, the Kansas lottery shall begin accepting registration for the Kansas lottery's player loyalty program which bears the licensed and trademarked name of PlayOn®. Registrations submitted between 12:01 a.m. on January 25, 2017, and the effective date of the regulation are deemed valid, provided the registration complies with all other statutory and regulatory requirements.

(b) The rules and regulations for the player loyalty program are contained in K.A.R. 111-18-1 through 111-18-7, and applicable specific rules are contained in K.A.R. 111-19-1 et seq. (Authorized by and implementing K.S.A. 2016 Supp. 74-8710; effective, T-111-2-24-17, Jan. 11, 2017.)

111-18-2. Definitions. Unless otherwise provided in these regulations, all definitions contained in the Kansas lottery act shall apply to all regulations in this section and K.A.R. 111-19-1 et seq.

(a) "Account," "PlayOn account," or "player loyalty account" refers to a record of a member's point activity.

(b) "APP" or "app" means a self-contained program

or piece of software designed to fulfill a particular purpose such as an application downloaded by a user to a mobile device.

(c) "Challenges" refers to activities set forth in the player loyalty program which gives players the opportunity to earn points.

(d) "Collecting Points" means the accumulation of points in a player's loyalty program account.

(e) "Download" means to copy data from one related computer system to another, typically over the Internet.

(f) "Drawing" or "online drawing" means the act of drawing or selecting winners by means of an electronic drawing or other method from among the entries that were entered for prizes.

(g) "Free Points Awards" means points collected by a player which are distributed from time to time from the player loyalty program as a bonus without requiring the player to earn the points.

(h) "Game ticket code(s)" refers to a draw game web-code or instant ticket code printed on Kansas lottery ticket products which can be entered by a member for the purpose of collecting points in the Kansas lottery's player loyalty program.

(i) "Instant Ticket Code" refers to the code printed on Kansas lottery instant game tickets which is used by the member as a game ticket code.

(j) "Member" or "members" refers to a Kansas lottery player(s) who has completed a member profile, agreed to the terms of service, and is registered to participate in PlayOn.

(k) "Member Profile" refers to the personal data and releases that are collected from the player who joins the players loyalty program and which may serve as verification that a player is at least 18 years of age.

(l) "Mobile device" means a portable computing device, including but not limited to a smartphone or tablet.

(m) "Online entry" or "online entries" means the method of entering a contest, game, drawing, promotion or other event sponsored by the Kansas lottery's player loyalty program by entering a ticket number or code electronically rather than via a physical ticket.

(n) "Non-winning ticket(s)" means any Kansas lottery ticket specifically designated by the Kansas lottery which is not a winner of any prize for the game in which it was originally eligible.

(o) "Player(s) Loyalty Program" refers to the Kansas lottery's online loyalty program where a player can seek information and participate in activities, promotions and services related to the program including, but not limited to the opportunity to collect points by submitting eligible Kansas lottery game ticket codes. The players loyalty program can be accessed through the Kansas lottery's website or any mobile version or mobile application (related apps) offered by the Kansas lottery.

(p) "PlayOn" refers to the name of the Kansas lottery's player loyalty program, and which is a registered trademark of Pollard Banknote Limited used under license.

(q) "Points" refers to a variable number value system as set forth in the guidelines of the player loyalty program which are distributed to a player loyalty account. Points are collected by a member and used to participate in drawings, and other promotional offers as provided by the player loyalty program.

(r) "Random number generator" or "RNG" means the online drawing machine or equipment used to randomly select the drawing winners.

(s) "Redemption of Points" means the act of a member releasing or using his or her points accumulated in the player's respective player loyalty account in exchange for the opportunity to enter a drawing or to obtain other prizes or other promotional opportunities as set forth in the guidelines of the players loyalty program.

(t) "Registration" means the act of creating an official record in PlayOn by completing a member profile including the required fields and agreeing to the terms and conditions of PlayOn.

(u) "Rewards" refers to the prize or entry given to a member in exchange for point redemption.

(v) "Rewards Catalog" refers to a listing of prizes available to be selected by a member upon the redemption of points.

(w) "Second-chance drawings" or "second-chance prizes" refers to prizes later awarded in drawings that are entered from winning or non-winning tickets that were sold for a specific promotion.

(x) "Terms and Conditions" means the arrangements and conditions set out by the Kansas lottery in PlayOn to which a member agrees upon registration.

(y) "URL" means a location or address identifying where documents can be found on the Internet.

(z) "Webcode" refers to the code printed on Kansas lottery draw game tickets which is used by the member as a game ticket code.

(aa) "Winning ticket" means any Kansas lottery ticket specifically designated by the Kansas lottery which is a winner of any prize for the game in which it was eligible.

(bb) "www.kslottery.com" refers to the Kansas lottery's website where a player can join the Kansas lottery's player loyalty club. (Authorized by K.S.A. 2016 Supp. 74-8710 and 74-8748; implementing K.S.A. 2016 Supp. 74-8710; effective, T-111-2-24-17, Jan. 11, 2017.)

111-18-3. PlayOn program overview; registration.

(a) The PlayOn program shall be powered by the Stellar Loyalty, Inc. loyalty solution platform and administered by Pollard Banknote Limited for the Kansas lottery. PlayOn can be accessed through the Kansas lottery's website at www.kslottery.com or any mobile version of PlayOn or mobile application which allows access to PlayOn. PlayOn offers Kansas lottery players various opportunities to earn and collect points which can be used to participate in drawings and other promotional opportunities.

(b) Any natural person, at least 18 years of age with a street mailing address in the United States or a United States territory, is eligible to join PlayOn through the registration process which requires a player to complete a member profile and provide personal information, including but not limited to age verification. Post office box addresses are not acceptable.

(c) The registration of all members in the Kansas lottery's players club immediately prior to implementation of PlayOn will automatically transfer to the Kansas PlayOn program. Said member will be required to activate his or her new account in PlayOn.

(d) Members can earn points by submitting eligible Kansas lottery ticket product code entries on the PlayOn

site and by participating in challenges and other activities or through free points awards offered by the Kansas lottery. A member is limited to entering a total of 40 tickets per calendar day, which includes game tickets for any second-chance drawing promotion(s).

(e) Members can use points to participate in drawings and other promotional offers provided by PlayOn.

(f) Points have no monetary or property value and shall not necessarily be associated with the face value of tickets.

(g) Point value will be revealed upon the successful submission of each eligible ticket or completion of a promotion or activity. Each eligible ticket has a point value based upon a range of values assigned by the Kansas lottery and is subject to change.

(h) Points are not transferable for any reason, including upon the death of a member or in a domestic dispute matter. Point balances from more than one account shall not be combined.

(i) Each member shall be responsible to ensure that his or her account points are properly credited. A member may submit a claim by email via the PlayOn "Contact & Support" link within five days of the date of claimed accrual of points; otherwise, such claims are null and void.

(j) Members are solely responsible for all activity on their accounts and for the security of their computer systems.

(k) Members shall be responsible for ensuring that the contact information provided for the account is current and valid. Failure to keep such information updated may result in forfeiture of prizes or disqualification from the PlayOn program.

(l) A member shall utilize no more than one single active PlayOn account. The Kansas lottery may, without warning, terminate membership(s) of any individual who establishes more than one single active account utilized in PlayOn program participation.

(m) An account shall be deemed inactive if there has not been any activity associated with such account during the previous 365 days. Such inactivity shall result in the deletion of said PlayOn account.

(n) Members enrolled in PlayOn are subject at all times to the terms and conditions, privacy policy, Kansas lottery rules, regulations, policies, directives, and procedures, the Kansas lottery act, and other applicable laws.

(o) Terms and conditions shall apply no matter how the programs described are accessed.

(p) The Kansas lottery PlayOn program shall be provided to individuals only. Corporations, associations, or groups may not participate in the program.

(q) Participation in PlayOn shall be voluntary and conditioned upon acceptance, without modification, of the terms and conditions and certification of eligibility requirements set forth in applicable regulations.

(r) Any activities associated with PlayOn shall be void where prohibited by law.

(s) All questions or disputes regarding eligibility for any PlayOn activities or member compliance shall be resolved by the Kansas lottery in its sole discretion.

(t) The Kansas lottery may send emails that include information that the Kansas lottery believes members may be interested in as a PlayOn member, including emails to reset passwords, account activity, and program updates.

(u) Members may discontinue receiving emails by opting out or cancelling their PlayOn membership. Upon cancellation of a PlayOn account, the cancelling member shall no longer have access to any PlayOn areas of the Kansas lottery website and related apps, and any points accrued to date of cancellation shall be forfeited.

(v) Members shall be responsible for the payment of any and all applicable taxes which may result from participation in any PlayOn activities and/or promotions.

(w) Any content available on the PlayOn website and related apps which is owned by the Kansas lottery or other third parties is protected by copy rights, trademarks, and other intellectual property rights.

(x) A player must be a member of PlayOn to be eligible to participate in drawings, activities, and events sponsored by the player loyalty club.

(y) All information posted by a member in the PlayOn program becomes the property of the Kansas lottery to use as it deems necessary. Any re-use of information does not entitle a member to any future compensation.

(z) Prizes will be issued in the winner's name only. The winner is the name that was entered during the PlayOn registration. (Authorized by K.S.A. 2016 Supp. 74-8710 and 74-8748; implementing K.S.A. 2016 Supp. 74-8710; effective, T-111-2-24-17, Jan. 11, 2017.)

111-18-4. Point redemption. (a) A member may redeem points for drawing and other promotional rewards offered by PlayOn.

(b) A member shall redeem points by clicking on the "redeem" link and following the links and instructions to browse through the available drawings and other offers. After the member has located the reward he or she desires, the player shall redeem the appropriate point total by clicking on the link for the desired reward. If the reward selected was an entry into a drawing, the member will receive an online confirmation that the entry into the drawing was submitted and received. If the reward selected was not an entry into a drawing, the member will be redirected to the offer page to utilize the reward.

(c) All points associated with a reward shall be deducted from the member's account upon redemption.

(d) The total number of points a member can use to obtain rewards is limited to the number of points the member has available in his or her account.

(e) All point redemptions for rewards from the rewards catalog are final and the points will be deducted from the member's account.

(f) Any points not used within one year after credit to an account shall expire and will be forfeited without compensation.

(g) The Kansas lottery may modify the drawings available for participation and their corresponding point values at any time for any reason. (Authorized by K.S.A. 2016 Supp. 74-8710 and 74-8748; implementing K.S.A. 2016 Supp. 74-8710; effective, T-111-2-24-17, Jan. 11, 2017.)

111-18-5. Drawings. (a) Following the close of drawing entries, a random number generator will be used to select winners of prizes.

(b) Drawing prizes may be cash or other prizes including second-chance prizes.

(c) All drawings shall be held under the supervision of Kansas lottery security staff members. Drawings may be conducted by Kansas lottery staff or vendor staff, at a location determined by the Kansas lottery. The drawings shall be conducted pursuant to written procedures developed by the Kansas lottery and approved by the executive director of the Kansas lottery.

(d) Persons interested in attending drawings are invited to receive detailed information by contacting the Kansas lottery director of security either by telephone, email, or by postal mail to: Security director, Kansas lottery, 128 North Kansas Avenue, Topeka, Kansas 66603. Requests to witness a drawing must be received by the Kansas lottery security director no less than 24 hours in advance of the drawing. Persons attending drawings must show valid photo identification and be supervised by a member of the Kansas lottery security division or a security designee during the drawing.

(e) A PlayOn member must be opted in for email to be eligible to be a drawing winner of the player loyalty club.

(f) Each person who enters a drawing agrees to release the Kansas lottery and its respective officers, directors, employees, agents, and sponsors from liability of any kind or nature for any loss, claims, damages, illness, or injuries of any kind associated with participation in the drawing or with acceptance and use of any prize.

(g) The Kansas lottery reserves the right to substitute prizes at its sole and total discretion of approximate equal value.

(h) A selected entry in a drawing will be reviewed by Kansas lottery security staff or designated vendor staff under Kansas lottery supervision to determine whether the entry meets qualifications for the drawing. If the entrant is declared to be an eligible entry, the entrant will be contacted via email address, telephone, and/or mailing address provided by the member's account and must present acceptable matching identification of his or her registration information including verification of age eligibility prior to being awarded a prize. The selected entrant must complete, sign, and submit a furnished prize claim form within the time set forth in the specific rules for the drawing.

(i) Unless otherwise provided in the regulation establishing the drawing, there shall be five additional entries selected in each drawing which shall serve as alternate winners in the order drawn in the event a winner fails to properly claim a prize.

(j) If selected entrant(s) do not qualify for the drawing, cannot provide acceptable matching identification, or fail to submit a completed claim form within the time frame specified for the drawing, that entrant will not be awarded a prize and a replacement winner may be selected in a like manner as the original entrant was selected from the entries for that drawing.

(k) Qualifying winning entrants will be determined by the Kansas lottery at its sole discretion.

(l) A winner or alternate winner of a prize shall be notified via email that he or she has won a prize. At that time, the winner or alternate winner shall be instructed how to verify his or her personal identification.

(m) A winner or alternate winner shall be sent a claim form via U.S. mail at the time the winner or alternate winner is notified he or she has won a prize.

(n) A player who is selected as a prize winner in a drawing must return his or her completed claim form, and must be received by the Kansas lottery within 10 days following the date of the online drawing unless otherwise provided in the regulation establishing the drawing. A player who is determined to be a winner as a result of being used as an alternate winner in a drawing must return his or her completed claim form and must be received by the Kansas lottery within 10 days following the date the alternate winner was sent a claim form unless otherwise provided in the regulation establishing the drawing.

(o) Completed claim forms can be mailed by the winner or alternate winner via U.S. Mail to: Kansas lottery, 128 North Kansas Avenue, Topeka, Kansas 66603, or the winner can deliver the completed claim form to the Kansas lottery claims center in Topeka, Kansas, during the hours the claim center is open for business.

(p) If a player fails to answer any email, respond to any request for information, or fill out any forms required by the Kansas lottery within the time allotted in the winner's notification of winning a prize, said win shall be forfeited and the prize awarded to an alternate winner.

(q) A drawing entry is eligible for only one drawing unless otherwise indicated in a specific drawing rule.

(r) A member may not win more than one prize in any drawing.

(s) All entries into a drawing are final.

(t) Drawing entries may not be cancelled or returned by a player, and any points used for an entry may not be returned or restored by the lottery. The Kansas lottery reserves the right to cancel or amend any entry at its sole discretion.

(u) Prizes will be issued in the winner's name only. The winner is the name that was entered during the PlayOn registration. (Authorized by K.S.A. 2016 Supp. 74-8710 and 74-8748; implementing K.S.A. 2016 Supp. 74-8710; effective, T-111-2-24-17, Jan. 11, 2017.)

111-18-6. Liability and exclusions. (a) The Kansas lottery is not responsible for and shall not be liable for: (i) Any damage to a player's computer systems that is directly or indirectly caused by accessing or downloading content from www.kslottery.com or any other website or mobile application designated by the Kansas lottery; or (ii) For any computer system, phone line, hardware, software or program malfunctions; or (iii) Other errors, failures, dropped or delayed computer transmissions or network connections of any kind; or (iv) For any printing, production, typographical, mechanical or other errors in the terms and conditions, tickets, or in the points summaries or accounts; or (v) For maintaining the confidentiality of member accounts and passwords, for restricting access to member computers, including all activities that occur under any member's accounts or passwords.

(b) Any liability incurred by the Kansas lottery as a result of any malfunction shall be limited to the purchase price of any eligible entering ticket.

(c) Without limiting the generality of the foregoing, the Kansas lottery is not responsible for incomplete, illegible, misdirected, late, lost, damaged or stolen entries; or for

(continued)

lost, interrupted, inaccessible or unavailable networks, satellites, Internet Service Providers (ISP), website or other connections; or for miscommunications; failed, jumbled, scrambled, delayed, or misdirected computer, telephone or cable transmission; or for any technical malfunctions, failures, or difficulties; printing errors; clerical, typographical or other error in the offering or announcement of any prize or in any prize notification documents, or other errors of any kind or nature; or for the incorrect or inaccurate capture of information or the failure to capture information.

(d) The Kansas lottery may discontinue any PlayOn promotion or event at any time without liability.

(e) Kansas lottery employees, commission members, and vendor employees and their immediate families living in the same household, and any other person or entity otherwise prohibited from participation by statute, rules and/or regulations are not eligible to win a prize offered by participating in PlayOn.

(f) Each person who registers as a member of PlayOn agrees to release the Kansas lottery and respective officers, directors, employees, agents, and sponsors from liability of any kind or nature for any loss, claims, damages, or injuries of any kind.

(g) All decisions with regard to ticket eligibility and drawing outcomes made by the Kansas lottery are final.

(h) The Kansas lottery may, in its sole discretion, invalidate points and/or entries into drawings if the Kansas lottery determines that such points were obtained fraudulently or improperly or from tickets deemed lost or stolen or not sold pursuant to statute or Kansas lottery rules and regulations.

(i) The Kansas lottery may suspend or terminate any PlayOn account if the Kansas lottery suspects that a member has engaged in any misrepresentation or fraudulent activities, or failed to comply with the terms and conditions or any rules associated with the PlayOn program.

(j) In the event a PlayOn member's account has been terminated, any points accrued to date shall be forfeited.

(k) The Kansas lottery may require proof of accrual of points and may delay the processing or redemption of any points without notice to a member in order to assure compliance with the terms and conditions. (Authorized by K.S.A. 2016 Supp. 74-8710 and 74-8748; implementing K.S.A. 2016 Supp. 74-8710; effective, T-111-2-24-17, Jan. 11, 2017.)

111-18-7. Prizes and odds of winning. (a) Prizes will be shipped by the Kansas lottery unless otherwise specified in the rules for a drawing or promotion.

(b) Odds of winning a prize in a drawing, unless otherwise provided for in a specific regulation, shall vary depending on the number of valid entries received.

(c) Except as provided in subsection (d) or any other law, prizes will not require payment by the winner of any delivery or other charges.

(d) Winning prizes are subject to income taxation at the player's expense unless otherwise specified by rule. (Authorized by K.S.A. 2016 Supp. 74-8710 and 74-8748; implementing K.S.A. 2016 Supp. 74-8710; effective, T-111-2-24-17, Jan. 11, 2017.)

Article 19—SPECIFIC PLAYER LOYALTY CLUB RULES

111-19-1. Monthly drawings. (a) The Kansas lottery may conduct monthly player loyalty club drawings.

(b) The Kansas lottery will begin accepting entries for monthly player loyalty club drawings at 12:01 a.m. on the first calendar day of the month, through noon on the last calendar day of the month. Drawings will be conducted within five days following the last day of the calendar month during which drawing entries were open. Drawing winners will be announced to the public within five calendar days after the drawing has been conducted.

(c) Only registered PlayOn members may enter the monthly player loyalty club drawing. PlayOn members must enter themselves into the drawings according to the terms and conditions of PlayOn. Entries shall not be accepted which are submitted by any method other than through PlayOn.

(d) There is no limit to the number of entries a member may make in any single drawing.

(e) The number of winners that will be selected in each monthly player loyalty club drawing will be announced prior to the beginning of said monthly drawing via the lottery's website.

(f) Each winner in the drawing will receive a Kansas lottery coupon of a pre-announced value which can be redeemed for any lottery ticket(s) designated by the Kansas lottery. A coupon must be redeemed by the date that appears on the coupon.

(g) Entries will not carry forward from one draw to the next.

(h) By entering the drawing(s), entrant agrees to PlayOn terms and conditions.

(i) Rules applicable to this drawing are contained in K.A.R. 111-19-1 and K.A.R. 111-18-1 *et seq.* (Authorized by K.S.A. 2016 Supp. 74-8710 and 74-8748; implementing K.S.A. 2016 Supp. 74-8710; effective, T-111-2-24-17, Jan. 11, 2017.)

111-19-2. Quarterly drawings. (a) The Kansas lottery may conduct quarterly player loyalty club drawings. The Kansas lottery will begin accepting entries into the first quarterly player loyalty club drawing beginning at 12:01 a.m. on January 25, 2017, through noon on March 31, 2017. Entries submitted between 12:01 a.m. on January 25, 2017, and the effective date of the regulation are deemed valid, provided the entry complies with all other statutory and regulatory requirements.

(b) Except as provided in subsection (a), the Kansas lottery will begin accepting entries for quarterly player loyalty club drawings beginning at 12:01 a.m. on the first calendar day of the quarter, through noon on the last calendar day of the quarter. After the first quarterly drawing as provided in subsection (a), the periods for all succeeding quarterly drawings shall include the following months:

Drawings will be conducted within five days following the last day of the quarter during which drawing entries were open. Drawing winners will be announced to the public within five calendar days after the drawing has been conducted.

(c) Only registered PlayOn members may enter the quarterly player loyalty club drawing. PlayOn members must enter themselves into the drawings according to the terms and conditions of PlayOn. Entries shall not be accepted which are submitted by any method other than through PlayOn.

(d) There is no limit to the number of entries a member may make in any single drawing.

(e) The number of winners will be selected in each quarterly player loyalty club drawing according to the pre-announced rules on the lottery's website.

(f) Each winner in each quarterly drawing will receive a pre-announced prize as shown on the lottery's website, which is subject to all taxes.

(g) Entries will not carry forward from one draw to the next.

(h) By entering the drawing(s), entrant agrees to PlayOn terms and conditions.

(i) Rules applicable to this online event drawing are contained in K.A.R. 111-19-2 and K.A.R. 111-18-1 *et seq.* (Authorized by K.S.A. 2016 Supp. 74-8710 and 74-8748; implementing K.S.A. 2016 Supp. 74-8710; effective, T-111-2-24-17, Jan. 11, 2017.)

111-19-3. PLP early adopter drawing. (a) The Kansas lottery shall conduct two drawings entitled "PLP Early Adopter Drawings." The first drawing will be conducted on February 8, 2017, and the second drawing will be conducted February 22, 2017. The entry period for the first drawing will be 12:01 a.m. on January 25, 2017, through noon on February 7, 2017. The winners of the first drawing will be announced on February 10, 2017. The entry period for the second drawing will be 12:01 p.m. on February 7, 2017, through noon on February 21, 2017. The winners of the second drawing will be announced on February 24, 2017. Entries submitted between 12:01 a.m. on January 25, 2017, and the effective date of the regulation are deemed valid, provided the entry complies with all other statutory and regulatory requirements.

The third drawing will close for entries at 11:59 p.m. on March 6, 2017. The drawing will be conducted on March 8, 2017, and winners will be announced on March 14, 2017. The fourth drawing will close for entries at 11:59 p.m. on March 13, 2017. The drawing will be conducted on March 15, 2017, and winners will be announced on March 21, 2017. The fifth drawing will close for entries at 11:59 p.m. on March 20, 2017. The drawing will be

conducted on March 22, 2017, and winners will be announced on March 28, 2017. The sixth drawing will close for entries at 11:59 p.m. on March 29, 2017. The drawing will be conducted on March 31, 2017, and winners will be announced on April 4, 2017.

(b) The specific ticket eligible for entry into the drawing shall be any winning or non-winning Kansas lottery Powerball ticket. Once the player collects all six different symbols on his or her electronic card, the player will be entered automatically into the drawing. If a symbol is generated that already appears on the player's electronic card, that symbol shall be moved automatically to another electronic card which shall be eligible to collect the remaining symbols. A player may have up to three game cards active at one time. If a symbol is in place in three active game cards, the symbol will be removed from the rotation of available symbols until a game card completes.

Article 501.—SOUTH CENTRAL GAMING ZONE

111-501-38. Round of play. (a) The ball must complete at least three (3) revolutions to constitute a valid spin. If the ball is spun in the same direction of the wheel, the dealer will announce the spin is void (a "no spin") and attempt to remove the ball before it comes to rest in a compartment.

(b) A "no spin" will be called by the dealer or table games supervisor or higher ranking casino official if any of the following occur:

(1) The ball fails to make at least three (3) revolutions around the wheel.

(2) The ball leaves the wheel completely.

(3) The dealer drops the ball before spinning.

(4) A foreign object enters the wheel.

(5) The ball is spun in the same direction as the wheel.

(c) If the ball hangs up and does not drop into a numbered slot, the table games supervisor or higher ranking casino official shall be asked for a decision.

(d) Once a no spin has been announced, it will be an invalid spin regardless of whether the ball enters a compartment or not.

(e) After the dealer has spun the ball and prior to it coming to rest, the dealer will announce there shall be no more bets. When the ball comes to rest in one of the compartments in the wheel the dealer will announce the winning number and place a dolly on that number on the layout.

(f) After the ball has dropped and the winning number has been marked on the layout, the dealer will pick up the outside losing bets, starting with the columns and 3rd dozen section of the layout, then moving towards the wheel head. The dealer will then clear all losing bets from around the winning number and then sweep losing bets in from the numbers, starting at the bottom of the roulette layout, working toward the wheel head. Once the layout is clear of all losing bets, the dealer shall pay all winning bets, starting with the columns, then working from the bottom of the layout, toward the wheel head, paying the outside winners, and finally paying the winning numbers bets on the layout. The wagers are paid from top to bottom by color. All bets of the same color are paid at the same time.

(g) No player is allowed to remove or make a bet until the dealer removes the marker or dolly from the most recent winning number.

(h) When a player bets less than the table minimum and the dealer and/or table games supervisor or higher

ranking casino official does not notice it before the dealer announces no more bets, the dealer shall pay that player based upon the amount actually bet and inform the player of the table minimum.

(i) If a bet appears to be over the table maximum, the dealer shall do the following:

(1) If the bet wins, the dealer shall segregate the maximum payoff in the work area of the layout and pay the player in normal procedure. All chips over the maximum will be returned to the player.

(2) If the bet loses, the dealer shall return all chips over the maximum bet to the player.

(j) All table minimums and maximum bets will be posted at or near the roulette table. (Authorized by K.S.A. 2016 Supp. 74-8710 and 74-8748; implementing K.S.A. 2016 Supp. 74-8710; effective, T-111-12-22-11, Oct. 12, 2011; amended, T-111-2-24-17, Jan. 11, 2017.)
