Notice Concerning Proposed Reopening of a Kansas Air Quality Class I Operating Permit

Notice is hereby given that the Kansas Department of Health and Environment (KDHE) and the Unified Government of Wyandotte County/Kansas City, Kansas' Department of Air Quality (DAQ) are soliciting comments regarding a proposed reopening of an air quality operating permit. A Class I Air Operating Permit was issued for the operation of Magellan Pipeline Company, L.P. – Kansas City Terminal, 401 E. Donovan Rd., Kansas City, KS 66115, owns and operates a liquid petroleum pipeline and terminal. The effective date of the permit was January 14, 2019. K.A.R. 28-19-513(e)(2) states that only those parts of the permit for which cause to reopen exists shall be affected by the reopening.

The Class I operating permit issued to Magellan Pipeline Company, L.P. – Kansas City Terminal is being reopened by KDHE and DAQ for the purpose of incorporating various modifications to the permit based on comments from the source inadvertently omitted from the permit. This reopening is due in accordance with K.A.R. 28-19-513(e)(1)(C).

The Kansas Oklahoma Railroad (KO) is seeking proposals to perform rehabilitation of existing and other ancillary railroad work for the proposed KO railroad project near Hutchinson, Kansas, between Greatbend and Wichita, Kansas. 1) Scope—Greatbend sub MP 218–268

K.A.R. 115-4-2. This permanent regulation sets general provisions for big game and wild turkey. The proposed amendments would allow for quartering of big game carcasses with proper evidence of sex attached.

Economic Impact Summary: No substantial negative economic impact to the department, other state agencies, small businesses, or individual members of the public is anticipated.

K.A.R. 115-4-4. This permanent regulation sets legal equipment and taking methods for big game animals. The proposed amendments would allow the use of locking draws during the archery season.

Economic Impact Summary: No substantial negative economic impact to the department, other state agencies, small businesses, or individual members of the public is anticipated.

K.A.R. 115-4-6. This permanent regulation sets deer management unit boundaries. The proposed amendments would amend the unit boundaries of DMU 19.

Economic Impact Summary: No substantial negative economic impact to the department, other state agencies, small businesses, or individual members of the public is anticipated.

K.A.R. 115-25-8. This exempt regulation sets the open season, bag limit and permits for elk. The proposed version of the regulation would adjust the season dates for the new year.

Economic Impact Summary: The proposed version of the regulation is expected to generate \$17,000 to the agency, all of which would accrue to the wildlife fee fund and generate a corresponding collateral economic impact to the State of Kansas estimated at \$156,752. Otherwise, no substantial negative economic impact to the department, other state agencies, small businesses, or individual members of the public is anticipated.

K.A.R. 115-25-9. This exempt regulation sets the spring season, bag limit, and permits for deer. The proposed version of the regulation would adjust the season dates for the new year and adjusts two wildlife area locations for additional white-tailed deer pressure.

Economic Impact Summary: The proposed version of the regulation is expected to generate \$12,950,000 to the agency, all of which would accrue to the wildlife fee fund and generate a corresponding collateral economic impact to the State of Kansas estimated at \$172,666,368. Otherwise, no substantial negative economic impact to the department, other state agencies, small businesses, or individual members of the public is anticipated.

The proposal establishes rules and regulations required to implement K.S.A. 2019 Supp. 74-32,267.

A summary of the proposed regulations and the economic impact statement of the regulation follows:

This is a proposal to establish rules and regulations required to implement K.S.A. 2019 Supp. 74-32,267. The statute established Accelerating Opportunity: Kansas (AO-K) to Work, a Kansas pathway to career program providing an alternative path to a high school equivalency credential for Kansas adults.

K.S.A. 2019 Supp. 74-32,267 requires that qualified students successfully complete an approved AO-K career pathway and receive an industry-recognized credential. It also requires that the Kansas Board of Regents (Board) approve the career pathways and industry-recognized credentials.

K.A.R. 88-25-1 – Program Title. This is a new regulation that establishes the AO-K to work program is also called the Kansas pathway to career.

K.A.R. 88-25-2 – AO-K career pathways; industry recognized credentials. This new regulation identifies which career pathways and industry-recognized credentials will qualify.

K.A.R. 88-25-3 – Career Readiness Certificate. K.S.A. 2019 Supp. 74-32,267 requires that students take a career readiness assessment and earn a career readiness certificate. This new regulation identifies two certificates that will satisfy this requirement.

K.A.R. 88-25-4 – High school equivalency requirements. K.S.A. 2019 Supp. 74-32,267 also permits the Board of Regents to establish additional criteria required to obtain the credential. K.A.R. 88-25-4 requires that each applicant also demonstrate high school equivalency in math, English Language Arts, and civics. The regulation identifies the tests or coursework that demonstrates that equivalency.

K.A.R. 88-25-5 – Fee. K.S.A. 2019 Supp. 74-32,267 permits the Board of Regents to charge a fee of no more than \$25 for issuance or duplication of a Kansas high school equivalency credential. K.A.R. 88-25-5 sets a \$25 fee.

Economic Impact: The regulation is not anticipated to have any direct economic impact on business, economic development, or local government within the State of Kansas. The regulation establishes a \$25 credentialing fee for all individuals that complete the requirements and can obtain a high school equivalency credential through the AO-K to Work program. Since this is a new program, the Board estimated the potential impact by taking a 5-year average of the number of students participating in a related program, AO-K. The average number of students participating in AO-K in the last 5 years was 509 students. If each of those students earned a credential the \$25 fee would cost \$12,730.
